Minutes of the

General Ministers' Conference of the Church of Christ 1937

FIRST DAY, TUESDAY, APRIL 6.

The first session of the Ministers' Conference met in the church on the Temple Lot at ten o'clock in the morning. The sacrament was served, after which the meeting was devoted to song, prayer and testimony. The service was in charge of Apostles A. M. Smith and James E. Yates, and occupied until noon.

Afternoon Session, 2 O'clock.

H. E. Moler in the chair, J. E. Bozarth assisting.

No. 56 in the Hymnal was sung.

Prayer by J. E. Bozarth.

No. 168 was sung.

C. A. Gurwell moved that the Twelve preside over the conference. The motion prevailed.

Moved and seconded that Sr. Sheldon act as secretary of the conference. Prevailed.

Sr. Anderson was chosen to act as chorister of the Conference, with power to choose her assistant and a pianist.

B. C. Flint and A. M. Smith were selected as Press Committee.

The chair suggested that following a time honored custom, the ministry be heard from. No one objecting, Bro. Moler led out with a few remarks, then called upon Apostles C. L. Wheaton, A. M. Smith, B. C. Flint, James E. Yates, Wm. F. Anderson and J. E. Bozarth, in the order of the length of time they had served in the quorum. Following these, Bishops J. R. McClain and A. O. Frisbey were called upon, then Elders R. M. Maloney and J. T. Overcast.

The meeting adjourned at 4 o'clock by singing No. 216 in the Hymnal, and prayer by Bro. Bozarth.

7:45. Preaching by James E. Yates, assisted by J. T. Overcast.

SECOND DAY, WEDNESDAY, APRIL 7. Morning.

9:30. Prayer meeting in charge of J. R. McClain and Wm. F. Anderson. An interesting meeting.

11:00. The speaker of the hour was R. M. Maloney. Thos. E. Barton was in charge of the meeting.

Afternoon Business Session, 2 O'clock.

J. E. Bozarth in the chair, assisted by Wm. F. Anderson. No. 351 in the Hymnal was sung.

Prayer by Bro. Anderson.

No. 354 was sung.

Minutes read and approved.

By permission of the chair Bro. James E. Yates read from the minutes pertaining to rules governing ministers' conferences.

Reports were read from Elders Lewis E. Welch, John A. Daer and F. J. Parkinson.

Tentative program submitted by the Twelve was read and adopted.

A statement from R. M. Maloney was read in which he said that after a year's deliberation, he was ready to accept his call "and submit to ordination."

Bro. Wheaton moved that the statement be spread on the minutes and that provision be made for the brother's ordination in the prayer meeting Thursday morning. After some discussion as to whether it would be proper to submit the matter further to referendum it was decided to have been covered by the last referendum, and by a vote of 8 to 1 it was ordered to proceed with ordination at the time specified in the motion.

The report of the committee on working harmony was read. Bro. Flint moved that action on the document be postponed until the 8th to give T. J. Jordan time to get here. Bro. James Yates seconded the motion.

Bro. Wheaton moved as a substitute that the motion be made special order of business for tomorrow, or Thursday afternoon. Bro. Anderson moved to amend the substitute by striking out "tomorrow afternoon, and make it read, Friday afternoon."

Considerable discussion followed, when the previous question was called.

The substitute carried by a vote of 8 for and 5 against.

The substitute as amended received 12 votes, none voting against.

A bill was read, submitted by the Twelve, to "control promiscuous ordination of irresponsible persons to the priest-hood."

Bro. Moler moved to adopt the bill.

Bro. C. A. Gurwell moved that to be more specific article 2 be amended by inserting the words, "the council of twelve apostles, the seventies or general bishopric." The document as amended was adopted by a vote of 13, none voting against. The document follows:

- 1. Whereas, there has come to our attention evidences of promiscuous ordination of men to the priesthood in this Church of Christ through ill-advised persons who have been motivated by a spirit of enthusiasm and zeal not according to godliness,
- 2. Therefore, be it resolved that we adopt as a rule to govern such cases the following course of procedure:

Where persons are called to occupy in the council of twelve apostles; the seventies, or the general bishopric, the call must be approved by the church at its conferences and Bro. Barton.

A number spoke, when Sister C. L. Wheaton offered a subsidiary motion recommending that the report and the recommendations offered by the committee be considered separately. This was seconded.

Bro. Maloney spoke and then Bro. Wheaton moved the previous question on the subsidiary motion. The motion lost by a vote of 6 for and 10 against, and the discussion continued.

Bro. Wheaton rose to speak. Bro. Moler objected on the ground that he had been heard from through the document he had read. The chair took that view of the matter and so ruled. Bro. Wheaton appealed from the decision of the chair. The ruling of the chair was submitted to vote. 7 voted for sustaining the chair and 9 against.

Bro. Wheaton was given the floor, speaking to the subsidiary motion.

Bro. Maloney presented the following preamble and resolution:

"By reason of the nature of this committee's report and the other documents we have heard express evidence of sharp and unyielding opinion in the body, therefore to save the church from unpleasant and unfruitful conflict, I move that this whole matter be laid on the table."

This was seconded by Bro. Wheaton.

By a vote of 14 for doing so, and only 3 against, the whole matter was laid upon the table.

Because the time was needed for quorum meetings, the Twelve recommended that the prayer meeting Saturday morning be moved from 9:30 to 11 o'clock.

Closing song was 216 in Hymnal.

Benediction by Bro. Jordan.

Evening Session.

7:45. Bro. T. J. Jordan was the speaker. Bro. Wm. F. Anderson was in charge of the meeting.

FIFTH DAY, SATURDAY, APRIL 10. Morning Session.

11:00 A. M. The prayer meeting was in charge of Bro. T. J. Jordan and R. M. Maloney. It was a spiritual meeting. The good Spirit spoke through Bro. Yates, comforting and encouraging the saints and commending those who had made an effort to come to the conference.

Afternoon Business Session, 2:00 O'clock.

Bro. Leon A. Gould in the chair, Bro. Jordan assisting. 132 in Hymnal was sung.

Prayer by Bro. Jordan.

191 in Hymnal.

Minutes of last session read and preamble was added to Bro. Maloney's resolution as he wished.

General Recorder's report was read.

Bro. Wheaton moved that the Recorders' Report be approved, and that Bro. Nicholas Denham be continued in office. This was seconded and carried.

Joint report from the Twelve and Bishopric upon the cooperative enterprise was read. The adoption of this report was moved and seconded, carrying by a vote of 14 for and none against.

Ministerial reports were read from Elders James Evans, David Jenkins, John G. Jenkins and Silas Madden.

Report of General Bishopric was read. Moved to approve the report. A. M. Smith moved as a substitute that the report be considered, paragraph at a time. Carried.

Bro. Anderson moved to approve the first recommendation of the report. Carried.

Bro. Anderson moved to approve the second recommendation.

Bro. Gurwell moved to defer action until Bro. Ford could

communicate with Bro. Johnson. 10 voted for this, 2 against.

The Committee on Working Harmony submitted a revised report, which was read.

There was some question as to the proper course of procedure to reconsider the report of the Committee, and Bro. Wheaton moved that the committee be permitted to withdraw their original report from the table and submit their revised report. By vote this was granted.

Bro. Wheaton further moved that the Recommendations accompanying the report be considered paragraph by paragraph.

Consideration of this motion was interrupted by a request from A. M. Smith, seconded by B. C. Flint, asking that a letter read by Bro. Wheaton in the Quorum of the Twelve be read here. Bro. Wheaton said the letter was a personal matter. Bro. Anderson moved to lay this motion on the table. By vote this was done.

Vote was called on the previous question to take up the recommendations of the Committee on Working Harmony paragraph by paragraph. By vote this was ordered.

Paragraph 1 was read. Its adoption was moved and seconded and carried by a vote of 9 for and five against.

Paragraph 2 was read. It was moved and seconded to adopt. After the discussion had proceeded some ways Bro. A. M. Smith offered the following:

"Whereas, it is still quite apparent that the spirit of this matter is still sharply dividing the body of this conference, I therefore move that this whole matter be layed on the table."

This motion was seconded and carried by a vote of 14 for and one against.

Moved to adjourn business until Monday afternoon at 2:00 o'clock.

SIXTH DAY, SUNDAY, APRIL 11. Morning Session.

The twelve called a prayer meeting at 8 o'clock, to which all were invited to attend. The meeting was in charge of T. J. Jordan and A. M. Smith. A splendid meeting was reported.

The local church held Sunday school at the regular time, 9:45 to 10.

At the 11 o'clock hour in the morning H. E. Moler was the speaker, J. R. McClain in charge.

In the afternoon at 2:30, J. E. Bozarth preached, Bro Ray Bryan of Hamilton, Mo., in charge.

In the evening at 7:45, Wm. F. Anderson was the speaker, J. E. Bozarth in charge.

SEVENTH DAY, MONDAY, APRIL 12. Morning Session.

9:30 Prayer meeting in charge of Bro. Gibbons and Ford. 11:00 Preaching by R. M. Maloney, Bro. T. J. Ford in charge.

Afternoon Business Session, 2:00 O'clock.

T. J. Jordan in the chair; A. M. Smith assisting.

143 in Hymnal opening song.

Prayer by A. M. Smith.

Moved that all matters of business be placed in the hands of the presiding officer. Carried.

Minutes read and approved.

Recommendations from the Twelve advised that business be taken up at 10 o'clock Tuesday morning, and at 2:00 o'clock Tuesday afternoon. No new business would be received after 2:00 o'clock P. M. April 13th. The morning prayer meeting would meet at 9:00 o'clock under this arrangement. The recommendations were approved by the body.

C. L. Wheaton moved that Thos. E. Barton succeed himself on the Committee for Working Harmony.

J. E. Bozarth moved as a substitute that we defer action.

H. E. Moler moved to amend the substitute by striking out all after that and state instead that "we abolish the Committee on Working Harmony." B. C. Flint seconded.

Several spoke to the question when the Chair asked Bro. Wheaton to yield the floor for the reading of the following resolutions:

"Whereas there has been so much contention over the Working Harmony movement and the committee;

"And whereas we have now spent two days on this matter and are just where we were when we started;

Therefore, be it resolved that this body in conference assembled, by their vote ask this committee to resign, and that contact with the other groups of the Restoration be made through the ministry of the Church of Christ (Temple Lot), which is a continuation of the church restored April 6, 1830.'

These resolutions were signed by sixteen names. (See Ref. Bill No. 10.)

B. C. Flint moved the adoption of the document; J. E. Bozarth seconded.

The chair ruled that this document would be entertained as a substitute for all before it relating to the subject.

Bro. Jordan gave the chair to A. M. Smith that he might speak. Others spoke to the question when R. M. Maloney moved the previous question. It was called by a vote of 9 for and 5 against.

Vote on the substitute carried by 16 for it and 3 against it. Bro. Ford reported that Bro. Henry Johnson was not prepared to say whether he would serve as one of the seven bishops. Bro. Gurwell moved to defer action on his name until Tuesday morning. Bro. Ford seconded.

Bro. Yates moved as a substitute that this conference authorize the placing of Bro. Johnson in the Bishopric and make provision for his ordination. This lost by 6 for and 7 against.

The original motion carried by 11 for and only 1 against. Supplying vacancies occuring this year on Boards and Committees was taken up.

It was moved that A. O. Frisbey succeed himself on the Board of Trustees.

C. L. Wheaton speaks, moving as a substitute that we recommend to the whole church the abolishing of the Board of Trustees and that custody and trusteeship of the Temple Lot property as well as all other real estate property coming into the hands of the general church shall be vested in the general bishopric.

Thos. E. Barton moves as a subsidiary motion to defer action on substitute until next year.

Bro. C. L. Wheaton offers his resignation from the Board of Trustees.

The previous question was called but lost by a vote of 5 for and 7 against.

Three spoke, and the subsidiary motion was put to vote. Two were for it and 11 against it.

It was moved to refer the substitute to a committee. This carried.

A. O. Frisbey, C. L. Wheaton and J. R. McClain were nominated for that committee. It was moved that these three constitute the committee.

C. L. Wheaton was given the floor; he spoke, again offering his resignation as a member on the Board of trustees,

to become effective at once, giving as his reason, "I believe that such trusteeship should be vested in the general bishopric of the church."

It was moved to accept Bro. Wheaton's resignation and the body approved.

Bro. Jas. E. Yates obtained the floor and read the following:

"We, the Committee on Working Harmony," appointed to promote as great a harmony with other divisions of the Restoration as might be consistent with the fact that this Church of Christ is the true church, and is now the official organization by Divine appointment, wish upon our part to promote as great harmony with those other organizations as possible and right:

However, since a number of our brethren and ministers of the Quorum of Twelve are so determined against doing these things by committee, and since we feel that harmony within the church is of first importance,

Therefore we, of the committee, hereby resign, in the hope that we may thereby accomplish the greatest good for the church.

We do this, subject to the approval of Referendum.

A. M. Smith moved that we accept the resignation of the ommittee on Working Harmony. The motion was seconded.

Committee on Working Harmony. The motion was seconded. Considerable discussion followed, when the matter was placed to vote, and 13 voted to accept the resignation of the committee, and 2 voted against doing so. (Bill No. 11.)

The session adjourned by singing 221 in the Hynmal and prayer by Bro. A. M. Smith.

The body voted to approve.

To the Ministers' Conference of the Church of Christ, with Headquarters on the Temple Lot, Greeting:

As the committee appointed to draft suitable resolutions to be sent out to the referendum of the whole church relative to the trusteeship of property belonging to the general Church of Christ, such as the Temple Lots, etc., we wish to present the following for your consideration and approval:

Whereas title has been vested in a board of trustees that have continued in custody of the Temple Lot property owned by the Church of Christ under the following terms of conveyance, i. e.,

"As trustees in trust for the aforesaid Church of Christ, and to their official successors as trustees in trust for the said Church of Christ, according to the laws and covenants

of said church . . . and the right of conveyance pertains to no other church of the same name or similarity of name than that which has been specified in this deed of which said Grandville Hedrick is now this day and date the President of said Church of Christ, as being composed of associated members according to the laws and covenants of said Church, wherefore the said Church of Christ is the real party of the second part to this deed of conveyance as represented by the term, 'Trustees in trust' for said Church of Christ."

Therefore be it resolved that this same title under the same conditions shall hereinafter be vested in the General Bishopric of the Church of Christ, as well as the title to all other real estate property of the general church as trustees in trust for said Church of Christ."

2nd. Having a chance to dispose of the church truck which is now in Minnesota at what we consider a fair price, and on reasonable terms, we deem it wise to sell it, and it was so ordered.

3rd, In view of the fact that the lumber on the Temple Lot is deteriorating very fast, the one inch stuff especially, that it be sold for cash, and placed in the temple fund, with which other material may be purchased when needed, if not otherwise provided for by the conference: that the office manager, Brother McClain, and A. S. Wheaton be authorized to sell the lumber. This was concurred in by four bishops present. This to also include the cement that was left on hand by the Building committee.

"In regard to the Office Manager, Bro. Ford moved, 'In matters of a difficult nature, to relieve him of too great a responsibility, that he counsel with the bishop or bishops most convenient, and if need be, all the bishops, that a consensus of opinion may be had. Approved.

2nd. Having a chance to dispose of the church truck which is now in Minnesota at what we consider a fair price, and on reasonable terms, we deem it wise to sell it, and it was so ordered.

3rd, In view of the fact that the lumber on the Temple Lot is deteriorating very fast, the one inch stuff especially, that it be sold for cash, and placed in the temple fund, with which other material may be purchased when needed, if not otherwise provided for by the conference: that the office manager, Brother McClain, and A. S. Wheaton be authorized to sell the lumber. This was concurred in by four bishops present. This to also include the cement that was left on hand by the Building committee.

Moved as a substitute to the whole matter that the Twelve be authorized to appoint R. B. Trowbridge, if he would accept; if he would not, then Riley Wheaton. The Auditor was to have authority to install an adequate system of bookkeeping. This was seconded and put to vote. 5 voted for, and 4 against.

Bro. A. M. Smith, general superintendent of the Sunday school association, gave an oral report. He recommended the publication and use by our schools of a system of reporting submitted by Bro. Wayne Richardson.

The body approved of the Superintendent's recommendation.

The Secretary of the Sunday school association made a report. The body approved.

The body approved the continuation of A. M. Smith as general Sunday school superintendent.

Sr. Sheldon declined reelection as general secretary because she did not have time for the work, and Bro. Wayne Richardson was elected.

Thomas Maley and Rolland Sprague were nominated for the office of assistant superintendent. Bro Sprague was chosen. He lives in Independence.

By permission of the chair, Bro. Smith spoke on the Quarterly situation. We have over twenty schools. A number use the Cook Quarterlies. Some use other quarterlies, and some use none at all. It would be desirable to have quarterlies of our own, but he saw no way of financing such

a move at the present time.

Bro. B. C. Flint spoke in high terms of the quarterlies published by the Scripture Press, 800 Dearborn Street, Chicago, Ill.

It was moved and seconded that Sr. Sheldon continue as general secretary of the church. She expressed her regret that she was compelled to decline because her affairs did not give her time for the work.

C. L. Wheaton, Leon A. Gould and Dorothy Denham were nominated. Bro. Gould received the highest number of votes, so he becomes the general secretary of the Church.

Report from the Dining Committee showed \$10.75 due them for furnishing meals to the ministry who are under conference appointment. It was moved and seconded that this amount be paid from the general funds. The body approved.

Bro. C. L. Wheaton expressed the belief that the church should have a secretary of transportation. The suggestion met with favor, and Bro. Wheaton was nominated for that office; also Bro. R.B. Trowbridge and J. R. McClain. Bro. McClain declined. Bro. Wheaton was chosen by vote of the body. It was moved that Bro. Trowbridge be associated with him, and this was approved.

A. M. Smith moved that the Board of Publication be authorized to appoint the Business Manager of the Advocate. The move was seconded and carried.

Wm. F. Anderson moved that the next general conference of the ministry meet April 6 of 1938 at Independence, Mo. Carried.

Adjourned with the singing of "God Be With You Till We Meet Again," and prayer by Bro. R. M. Maloney.

Brief Review of the Ministers' Conference

The 1937 Ministers' Conference is now history. The fruits of its sowing will develop in their time, and we are encouraged with the promise that they will be good and wholesome and life-giving in their nature.

The attendance was somewhat smaller than the year previous, but the spirit of loyalty and sincerity manifested by those in attendance was outstanding. All members of the Council of Twelve were in attendance, there being at the present time but one vacancy. Four of the General Bishops were in attendance, and taking an active interest in their work.

The prayer meetings were of a spiritual character, restful to the soul, and pregnant with the assurance of God's loving watchcare. The voice of the Spirit was heard through Bro. Yates, assuring us that the Master of life was with his people.

"Though you behold not my face, I am known to you in the deepest recesses of your souls; I am in your midst to bless you and to lead you, to comfort those that need comfort, and to strengthen those who need my strength. Verily, ye are the instruments of my rescue when you will love each other and serve me with full purpose of heart; yea, ye are the instruments of my rescue for the spiritual well-being of souls among men." "I am well pleased with those who have come to this conference from a distance, and I have blessed them, and I will continue to bless them. I am well pleased with you my people, therefore, thus saith the Spirit, Be ye comforted in me, and go forth courageously to perform my work, and ye shall be made to know that I am with you all the way."

On another occasion words of comfort were given to Apostle T. J. Jordan as follows:

"Thus saith the Lord to Bro. Jordan: By the power of my Spirit I speak this message to you. You have been able to give to the hearts of others much encouragement. Your work is acceptable to your Lord. Verily, thus saith the Spirit to you, my son, go forward in the work according to the resolves you have in your heart, with courage from me; for I am with you to bless and to sustain you in your ministrations to my people. Thus saith the Spirit unto you, my servant, this morning. Amen."

Many encouraging testimonies were given, and many earnest prayers offered. Sr. Wm. Anderson as chorister for the conference, with her assistants, rendered efficient service, a delight to those who love this part of the service.

The business sessions were marked by friction to some extent, especially in the early part of the conference. These differences of opinion, while not enjoyed on the whole by the personnel of the conference are no doubt to some extent, at least, a logical outcome of the past year's experiences.

Separated from each other, meeting varying conditions, minds wrestling with contrary-like problems, it seems to be inevitable that we come together with a clashing of ideas. We have not yet learned to apply in full measure the admonition of the Master, "Be ye wise servants, harmless as doves." The miraculous thing about it is, that these same men, the conference over, will go to their fields in a spirit of utmost self-sacrifice and devotion, willing to give their lives if necessary for the gospel's sake.

There were perhaps three outstanding measures before the assembly.

I may mention first, the changing of the trusteeship of the Temple Lots and other properties belonging to the General Church. Having been held heretofore by a board of three as trustees in trust, the conference ordered that title be now transferred to the seven General Bishops as trustees in trust, thus wiping out by enactment, as well as by sentiment, the line of distinction that has been drawn in the past between the so-called original stock of the Church of Christ, and those later received into membership.

The second one I may speak of was in relation to the Committee on Working Harmony. This occupied the center of the stage for the most of three days, and called forth many pointed observations on both sides of the question, and some heated argument at times. However the consensus of opinion of the ministry present fianlly seemed to crystalize in the thought that better contact with other divisions of the Restoration might be made by the members and the ministry of the Church rather than by a committee, and steps were taken looking toward a discontinuance of the committee.

On the other hand, those favoring the work of the Committee were eloquent in their pleas that the Committee be continued, believing that through this means a better contact could be made than by the individual method. What the reaction of the People's Conference may be to this matter we would hesitate even to conjecture.

The third matter of paramount importance was the report on "Temporal Plans" from the committee appointed by a joint council of the Council of Twelve and the Bishopric. This brought out a unanimity of expression upon the floor of the conference that was unique in the history of conferences, and seems to indicate that without doubt the hearts of the Saints are looking forward with hope tothe establishment of those Zionic conditions outlined in our standard books. Provision was made for immediate steps to be taken toward forming articles of association in harmony with these plans, as soon as the Peoples' Conferences shall approve, if they do. A memorable conference, seasoned with heartache it is true, but pointing with hope to the realization of our objective, Zion redeemed, the pure in heart.

Dear Sister Sheldon and Advocate:

I love each one that writes, though I have never met but few of them, I love their names and see them in my imagination. I receive great help from the pieces written by our Elders and wish there were more.

A Bit of News from Hollywood, California By the Village Blacksmith

The Lord promised Abraham that he would not destroy the city if only ten righteous ones could be found therein.

If the angel of the Lord came to the twin cities of Los Angeles and Hollywood, how many righteous would he find? I wonder.

For the last fourteen years my wife, Carrie, and I have tried in our weak way to do our part towards warning these cities with the message of the Restoration, given through the choice seer, Joseph Smith. Thus far, in all those years, we have succeeded in converting and baptizing only seven adults who were not members of some other church.

Nothing gives Carrie and me more happiness than to visit our neighbors, sit by their home fireside, and talk the gospel. About three months ago Carrie visited a friend of hers who is on her death bed with that dreadful disease, cancer. Carrie asked me to go with her and explain about the thief on the cross, and salvation in the eleventh hour. This gave me an opening. After an hour's talk this woman, like the eunch of old, asked for baptism. How could this be done, was the question, when she was so far gone. The best medical aid had told her she could not possibly live. She was unable to sit up in bed. Carrie and I asked the Lord for wisdom. Here is what we did.

I erected a baptismal font in her back yard, 8 feet long, 4 feet wide and 3 feet deep, filled it with clear, running water, went home, waited and prayed for a week to see if the Lord would give her temporary strength to walk to and from the water. We had done our part, done all we could, and felt that "man's extremity is God's opportunity." The power of God prevailed. On the evening of March 31st she sent us a message, "Come and baptize me." We went. She arose from her bed, walked to and from the water. It was a nice baptism. The Spirit of the Lord was with her, and with Carrie, bringing tears of joy to her eyes.

Are we happy? Today, April 11th, we had sacrament and laying on of hands, confirming the sister. Her husband listened and questioned, and is very much impressed with our story, and I look for further results. Whether this sister lives or dies, her name is recorded in the Lamb's Book of Life. When a person is baptized by water and the Holy Spirit by one having authority from God to officiate, his name goes on the Book of Life as a son of God's, a joint heir to His kingdom, and as long as his life lasts, if he is faithful and true, there is no need for rebaptism.

Why I Go to Church

This thought was given to me by our Editor one Sunday evening at the close of service. Since that time I find a multitude of reasons moving through my mind, and find it very hard to put one above another.

To begin with, I truly find no other place that gives me as much pleasure as being in the house of the Lord and helping serve whenever called upon. Then I recall very plainly the promise I made in the waters of baptism, when I buried the old man and took up the newness of life given me by the Saviour. (And by the way, each and every one of us who have embraced this gospel have received the same thing.)

Another very compelling reason is that I know were I to stay away from Church and the duty that is mine I would soon lose the influence of the Holy Spirit, and more than likely go back to the old ways again. That thought reminds me of the scripture that tells us if we once receive the Gospel

of Jesus Christ and then go back to the old ways that our condition is much worse than before. I am sure I don't want to resurrect the old man again.

Here in the center place the struggle that is as old as time itself goes on: Right and Wrong striving for the mastery, and I have joined myself with the force of right, hoping and believing that in the finish, Right will be the victor. There are those faithful Brothers and Sisters that carry on the manful warfare that I am proud to be with, and all of whom I have learned to love and cherish as my own. I have often pictured the joy and peace that would be ours were each member here to remember their promise made in the waters of baptism and come and help this struggling little band on the Temple Lot to carry the burden than sometimes is so very hard. There are none of us but what have our peculiarities, but for the works' sake we must overlook these things and get into the harness. The time is fast drawing near, and signs preceding the end are fast coming upon us on every hand, which is another very good reason why I should go to Church and be found at work for the Master. The time has come and is fast passing when we in charge of the sacred plot of ground and the trust the Lord has given into our hands should be forgetting those petty feelings that cause us to shirk our duty and, instead, be about the building of our souls that we might be one and be able to build that great city Zion to which Christ is to come, to set in order all things.

It seems I have heard a thought expressed something like this, "Those who do not work will never know the joy of achievement." I want to be in that joyous throng with the Master. Last year at Conference time I hitch-hiked down here from Rockford, Ill. Footsore and very weary I sat on the porch of Bro. Anderson's place to rest, and in looking around I saw the great stone church across the street and then a little south of that and across the street I saw the little white church. Compared as to architectural beauty with the church across the way, it had not a chance, but to me it seemed I had never seen a place as sweet and lovely. I don't believe that anyone can know the joy that swelled up within me; that is, unless they have had the same experience themselves. Since then I have come to regard it as partly mine. I love to think of the privilege I have of taking part in the work of the Master and being in His house.

Most everyone who reads the Advocate will recall the article by Bro. Caviness on Work. In this article he gives us this to think of. "We have only so much time; how are we using it? Unless we work for what we hope for, we will never realize our anticipations." I would like to fit into the parable of the sower who went forth to sow, that I might be like the good ground that the seed fell on; another reason why I go to Church.

In closing I would like to say there are faces absent from our gatherings that we miss, and wish it were not so. Please give heed to this little wish, come meet with us again. Let us pray for one another.

When calls are given that would induct men into the Melchisedec Priesthood, the ordination shall not be conferred until the call has been approved by the member of the Council of twelve in charge of the field in which such call originates, as well as by the voice of the local congregation to whom such persons shall minister. A general referendum vote on the call and ordination of an elder is not required.
- 4. Where the call comes providing for persons to be ordained to offices in the lesser priesthood, such ordinations shall not be conferred except it is approved by the voice of the local church to whom they may minister; such approval shall be given in a regular business meeting of that local congregation, of which due notice has been given, where such things should, by their nature, be considered.
