THE MINISTERS' CONFERENCE

The 1947 conference has passed into history, history of a pleasing kind. We seem to have learned from the events of the past, lessons that we hope will be of lasting value. For by this time we should have learned that no one is necessarily an enemy because he may entertain an adverse opinion—and neither is he hopelessly lost; but the unfolding of the future may prove that he is on the right track, and well in advance of us.

While, viewing the great importance of tasks yet to be accomplished, the progress made in the late conference may seem small in comparison, yet we feel that distinct progress has been made, and the horizon of the future is visibly brightened.

With the addition of two consecrated young men to the General Bishopric, that body has been placed in a position to take progressive measures, for the good of the work in general, that heretofore have been unduly hampered. We can confidently given them our full and hearty support.

The so-called constitutional document came in for a careful and extended examination by the whole body of the ministry in attendance at three morning sessions, with some constructive criticism that bore fruit.

The ministry recommended to the conference that and no longer represents the Church of Christ. Sections 2, 3, 4, 5, 6 and 7 be adopted in their amended. form, and that the balance of the document be referred can no longer continue as a minister for the church, back to the committee of five for further study and action. These Articles in their amended form, will be published later in convenient form for reference as a handbook for those interested.

Having now "turned the corner," and by maintaining the course now indicated, under the spiritual influences governing in the late conference, healthy progress for the Church of Christ is assured.

THE CHILDREN'S CORNER

PAUL, A SERVANT OF GOD

In our story about Stephen last month, we learned that the witnesses who stoned Stephen laid their coats at the feet of a young man named Saul, who was consenting to Stephen's death.

At this time there was a terrible persecution against those of the Church who were at Jerusalem, many of whom were forced to scatter throughout Judea and Samaria; only the apostles being left in Jerusalem.

Saul bitterly opposed the early church, and persecuted it, causing great fear and destruction wherever he appeared. He entered every home and caused those who believed in Jesus to be thrown into prison, and the believers scattered far to escape the wrath and persecutions of Saul; and wherever they went they preached the gospel of Christ.

Saul, who probably saw that his efforts to destroy the church in Jerusalem seemed only to spread the gospel story, secured letters from the high priest, empowering him to bring any Christian found in the synagogues in Damascus to Jerusalem for trial.

As he was traveling to Damascus, on one occasion, a bright light appeared in the heavens and shone round about him. Saul fell to the earth, and he heard a voice saying, "Saul, Saul, why persecutest thou me?"

Saul asked, "Who art thou Lord," and the voice answered: "I am Jesus whom thou persecutest."

Jesus also told Saul it was hard for him to struggle against Him as he had been doing. Saul who had been trembling with fear and astonishment, asked Jesus what he wanted him to do. Jesus told him to go on to Damascus, where he would be told what else to do.

Those who were with Saul saw the light and were afraid, but "they heard not the voice that spake to Saul." When Saul arose from the ground and opened his eyes he found that he could see nothing; and those who were with him took him by the hand and led him into Damascus, where he lay in darkness for three days, neither eating nor drinking.

There lived in Damascus a man named Ananias who was a disciple of Jesus. After Saul was stricken blind, the Lord appeared to this man, calling him by name, and said, "Arise, and go into the street which is called Straight, and inquire in the house of one called Judas for one called Saul, of Tarsus; for, behold, he prayeth, and hath seen in a vision a man named Ananias coming in, and putting his hand on him, that he might receive his sight."

Ananias was astonished at the Lord's words, and said, "Lord, I have heard by many of this man, how much evil he hath done to thy saints in Jerusalem: and here he hath authority from the chief priests to bind all that call on thy name."

Jesus told Ananias that He had chosen Saul to bear His name before both the Gentiles and the Israelites, and that He would show Saul the things he must suffer in his mission.

Ananias obeyed the Lord's command, and when he entered the house of Judas he laid his hands on Saul's head, and said: Brother Saul, the Lord, even Jesus, that appeared unto thee in the way as thou camest, has sent me, that thou mightest receive thy sight, and be filled with the Holy Ghost." And even as Ananias spoke Saul's sight was restored, and he arose and was baptized in the name of Jesus.

Saul spent several days with the disciples in Damascus, and preached the gospel of Jesus in all the synagogues there. Those who heard Saul could not understand the change in him, because they knew he had come to Damascus to imprison the believers in Christ; and now he, too, professed to be a believer.

Saul's speech was so convincing that the Jews were unable to argue against him; and, being angry because of this, they plotted to kill him. Saul and his friends heard that the Jews were waiting at the gate of the city to kill him as he tried to leave, so when night came the disciples hid Saul in a large basket and let him down safely over the city walls.

After this narrow escape from Damascus, Saul journeyed to Jerusalem where he tried to join the disciples, and met with another cold welcome because the people were all afraid of him, and didn't believe that he was truly a disciple of Jesus. One of the congregation named Barnabas took Saul to the apostles and told them how Jesus had spoken to him on the road to Damascus, and how Saul had preached with great boldness in the synagogues of Damascus; so Saul was received by the disciples and preached about Jesus in Jerusalem as he had done in Damascus.

At this time, certain Greeks who heard Saul were angered by his words, and once again he fled for his life, journeying to his home in Tarsus.

With Saul, the persecutor, transformed into "Paul," the disciple, the followers of Jesus had a season of peace, and were able to study and to walk in God's ways, and many more were added to their number.

Apostle A. M. Smith in charge, assisted by Apostle R. R. Robertson.

Opening Song: No. 178—Hail to the brightness of Zion's glad morning."

Opening Prayer by Brother R. R. Robertson.

Scripture was read by Brother A. M. Smith from the first chapter of the first epistle of Peter.

Second Song: No. 190—Redeemer of Israel our only delight."

After some preliminary remarks about the solemn importance of the hours immediately before us, the chair opened the business with the question of "who shall preside?"

Brother J. A. Sweem moved that the Council of Twelve preside over this conference and they to choose the ones to take charge. Seconded by Brother LeRoy Wheaton. Motion carried—19 for, none against.

Brother C. L. Wheaton moved that Brother F. Maley act as secretary and choose his assistants. Seconded by Brother Bert Cooper. Carried.

Chorister—Sister Betty Morgan being the General Church Chorister among whose duties is the preparation and directing of General Conference music.

Sister Metta Anderson nominated Brother Bert Cooper pianist for the Conference. The body unanimously selected Brother Cooper as pianist.

Brother C. L. Wheaton moved that Brother Ernie

Premo be the chief usher and choose his assistants. Seconded by Brother B. C. Flint. Carried.

Question was raised about maintenance of the building during the conference.

Brother W. F. Anderson moved that Brother Derry (Chas.) be authorized to choose his assistants in this work. Seconded by Brother B. C. Flint. Motion carried.

Brother C. L. Wheaton moved that the General Bishopric be authorized to remunerate such assistants for that work. Seconded by Brother Bert Cooper. Motion carried.

Brother W. F. Anderson moved that Brother A. M. Smith and Brother B. C. Flint act as Press Committee. Seconded and carried.

Minutes of the April Conference of 1946, sessions of April 11, 2:30 p. m.; April 12, 10:00 a. m.; April 12, 2:00 p. m., and April 12, 8:00 p. m. were read, corrected and approved.

Minutes of the "Constitutional Convention" of October 6, 1946 were read and approved.

Scripture was read by Brother R. R. Robertson from the second chapter of the first epistle of Peter.

The minutes of the $10:00~\alpha$. m. session of April 7, 1947 were read. There were no corrections and the chair ruled that they would stand approved as read.

Three papers in the hands of the secretary were given their first reading.

- (1) Ministerial report of Elder Amos Surbrook.
- (2) A document with recommendations from the Council of Twelve.
- (3) A report from the Auditing Committee relative to the delay in their department.

Brother Joseph Yates called up for second reading

and consideration the document from the Council of Twelve. The document follows:

To the Conference of the Church of Christ Greetings:

The Council of Twelve hereby offers the following recommendations to the Conference as the outline of services other than the regular business session:

- ,1) The morning hours from 10:00 a.m. to 12:00 be devoted to devotional service, and priest-hood meetings; and suggest that the hour from 10:00 to 11:00 a.m. be devoted to prayer meeting; and from 11:00 to 12:00 to preaching. Further that during this time, the members of the Priesthood may meet in quorum capacity to care for such matters as may come before them during this conference.
- (2) That the hour from 4:00 p. m. to 5:00 be devoted to the School of the Ministry.
- (3) That the time from $7:30~\rm p.~m.$ to $8:00~\rm p.~m.$ be devoted to song service and preaching to follow at $8:00~\rm p.~m.$

Brother Joseph Yates moved that we accept the report with recommendations of the Council of Twelve and approve of it in its entirety. Seconded by Brother Wm. Sheldon.

This matter was examined and discussed at length. Brother James E. Yates moved as a substitute for the whole matter before the body that:

Concerning this issue now before the conference, namely, the transaction of legislative business and in order that common consent (for or against) may be obtained in an orderly way, I move that this whole question shall be referred first to the whole body of the ministry now in attendance at this conference. They to study, analize, act upon, and report back to this General Conference their recommendations in the matter for common consent of the conference in approval or disproval.

Also, in order that the body of the Ministry may take this matter up in an orderly way that the Conference approve of this method of Ministers' consideration of our major business first.

Seconded by Brother L. L. Boyce.

With the consent of the seconder (after further discussion) Brother James E. Yates withdrew his motion.

Brother LeRoy Wheaton called up for second reading and consideration the report of the Auditing Committee. It follows:

Independence, Mo. April 7, 1947.

To the Church of Christ In Conference Assembled Greetings:

On March 19, 1947, the books not as yet being in our hands, we, your Auditing Committee, requested of Brother Davis that he turn them over to us not later than March 22 in order that we might be able to procure a "competent certified auditor" to audit the books.

Brother Davis delivered three ledgers to us on

Sunday, March 30. On March 31 we took them to a certified accountant who told us that without the bank statements, cancelled checks, receipts, paid bills, etc., it was not possible to make an audit at all. On April 1, the committee requested Brother Davis to supply them with the needed material; and on April 2, he delivered to the committee certain material covering the period only from December, 1946, to March, 1947. It is the committee's understanding that their duty was to have the books audited for the period from March 15, 1946, to March 15, 1947.

On April 3, the committee took what material had come into their hands to an accountant (certified) who makes a special concession to charitable institutions. Upon condition we could procure the rest of the material needed, he assured us he could make a full and complete audit for an amount not exceeding \$50, but that it would be impossible to have it done in less than ten days. This would be too late for the Conference, in our opinion.

Therefore, finding ourselves unable to procure a full, complete, and dependable audit because of insufficient time and lack of material needed, we returned the books, etc. to Brother Davis at his request on the evening of April 3, 1947.

As your auditing committee, we recommend that you instruct the quorum of bishops hereafter to see to it that the books of the manager of the Business Office are closed on March 15 of each year, and submitted immediately for auditing.

After long deliberations we, the joint meeting of all the ministers attending this conference beg leave to report that we have considered the matter of the constitutional document referred to us and have the following recommendations to offer, and suggest you take such action:

(1) Be it resolved that:

Whereas the articles and paragraphs selected from the revised report presented by the conference-appointed "Constitutional Committee," hereafter named in this resolution, are in harmony with our present practices and procedures and do systematically and plainly set forth much of the doctrine of Christ and some of the practices of the Church of Christ that would make for unity, and help the priesthood in their ministry,

We therefore recommend to the Conference that the following be approved and printed as a handbook for the purpose set forth in the revised preamble in Article Two: All of Articles Two, Three, Four, Five, All of Article Six except the last two paragraphs, and all of Article Seven.

(2) Be it further resolved that:

This Conference refer the rest of the "Constitutional Committee's" report back to that same committee for them to consider and to report back to the Conference this next year.

Relative to a change to a delegate type conference as outlined in the document sponsored by Brethren Flint and Anderson, which was referred to us, we recommend that the Conference continue its present rules of Conference procedure as adopted in 1939, and also continue them in this Conference and until those rules shall have been revised according to our regular procedure.

Article Two (as revised)

PREAMBLE

Pursuant to the action of the Minister's Conference of April 13, 1943, and approved by the Referendum Vote of that year, and later affirmed by the Ministers' Conference of April 8, 1946, we your committee appointed "to draft a document in the nature of a Constitution, embracing the laws and doctrines of the Church, its Quorums, their duties, and all matters pertaining to the spiritual and temporal affairs of the church," hereby set forth the results of our labors to be published in printed form as a Hand Book of conference resolutions and enactment relating to the duties of quorums, committees, and conference procedure, etc., to become a guide or rule, as "helps and governments," (see I Corinthians 12:28) to govern such proceedings upon the part of ministry and membership of the Church of Christ, with Headquarters on the Temple Lot, Independence, Missouri.

Further revisions (Compare with report published in Zion's Advocate for March, 1947.

Article Four:

Paragraph 1, 6th line should read, "our Lord and Savior Jesus Christ to whom be all glory, Article Five:

Paragraph (a) last line should read, "in Article Fifteen of this Hand Book."

Articles of Faith, paragraph 2, second line should read: "SON OF GOD, the manifestation of God in the flesh who lived,"

Articles of Faith, paragraph 19, 3rd and 4th lines should read: "Bishopric under the direction of the general conferences of the Church and under the supervision of the Council of Twelve. The temporal affairs—"

Article Six:

Paragraph (a) quotation marks removed; lines 9 and 10 should read: "Then shall they be received unto baptism for the remission of their sins, into the Church of Christ.

New paragraph (b) reads:

"Laying on of Hands to Receive the Holy Ghost.

(b) After persons are baptized in water by one having the proper authority then shall an Elder or Elders of the Church of Christ lay hands on their heads and pray over them that they may receive the cleansing power and Gift of the Holy Ghost.

After they have been received unto baptism and are cleansed by the power of the Holy Ghost, they are to be numbered among the people of the Church of Christ and their names are to be taken and kept on a record that they might be remembered and nourished by the good word of God.

Former paragraph (b) is changed to para-

graph (c).

Last two paragraphs as published in Advocate omitted.

Article Seven:

Paragraph (3) last line should read: "the direction of the General Conferences, and under the supervision of the Council of Twelve."

Paragraph (b) lines 3 and 4 should read: "three members are chosen, one for one year, one for two years, and one for three years, and thereafter as—"

New Paragraph (c-2) preceding paragraph (d) reads:

Young People's Christian League:

(1) General Chairman.

(2) Vice General Chairman.

(3) General Secretary.

And such other officers as the rules of the League provide. The general organization of the Young People's League shall be under the direction of the Conference and the supervision of the Council of Twelve.

Paragraph (2) of Associate Editors, first line should read: "These form the editorial

staff which shall—"

Paragraph (5) line three should read: "attending General Conferences and Conventions.

Paragraph on local organizations should be labeled (f); line three should read: "is an elder. (Citation: "Alma...or")

Paragraph (1) under local organizations line 1 should read: "A PASTOR, or presiding elder who shall have "

Paragraph (2) under local organizations concerning priests. After words "but in all cases is to assist the elder." Add new paragraph: "In the absence of an elder, or due to the incapacitation of an elder, a priest may act as pastor."

Paragraph (e) after Auxiliary Organizations, should be titled, "Cooperative Associations." The next to last paragraph of this division, the last line should read "interfere in any way as long as they operate in harmony

with the teachings of the General Church."

Vote was taken on the motion to concur in the recommendation to have these articles published. Motion carired 13 to 8.

Brother Nicholas Denham moved to adopt the recommendation of the Joint Meeting of the Priesthod as to the referring this document back to this committee. Seconded by Brother Wm. Sheldon. Motion carried 13 to 0.

Brother LeRoy Wheaton moved to concur in the recommendation of continuing our present conference procedure. Seconded by Brother B. A. Winegar. Carried 21 to 2.

Brother Joseph Yates rose and tendered his resignation as one of the Associate Editors of Zion's Advocate.

Brother Clarence L. Wheaton moved that we ask the Brother to reconsider his resignation and further that we give Brother Joseph Yates a vote of confidence. Seconded by Brother Maynard Case. Carried.

Brother W. F. Anderson brought to the floor the matter of our needy membership in Wales and Germany.

There was considerable discussion.

Brother Clarence L. Wheaton moved that we recommend that the Sisters of the UNITED WORKERS make a drive throughout the Church for clothing and food to send to our members in Wales and Germany. Seconded by Brother LeRoy Wheaton. Motion carried.

Brother W. F. Anderson brought to the floor the matter of the death of our late Brother R. M. Maloney for-

merly of the Council of Twelve.

Brother W. F. Anderson moved that a committee of three be appointed to draft a letter of condolence to our Sister Maloney, widow of the late Brother Maloney. Seconded by Brother Clarence L. Wheaton.

Brother Nicholas Denham moved that nominations cease and that these three constitute the committee. Seconded by Brother Wm. Sheldon. Motion carried.
