### EDITORIAL

This conference year is now in its beginning. The conference has closed and many have returned to their homes. There are, no doubt, various opinions as to what has been accomplished. Our accomplishments are not usually realized at such an assembly. We must wait on time to prove the wisdom of the beginning or the continuation of a proposition. Our duty is to lend our efforts to the progress of those things we believe to be Divine.

This conference had a significance to some. This year, for instance, was the first time in many years that all twelve Apostles met together at one time. This signified to some that we are on the threshold of a new era or time. Many are looking forward, some with anticipation, to the opening up of new fields. Some of the fields are of labor; some of the fields are of thought.

Concerning the fields of labor: There is much work to be done among those of the Gentile nations, many of whom have not heard of the restored gospel and multitudes have not heard it. We must bear witness to them of it.

The work is getting underway among the seed of Lehi. They have been, as Isaiah prophesied, "Scattered and peeled", "Meted out and trodden down." But the promise was made to Nephi that they should, some day, come to a knowledge of their forefathers and to a knowledge of the covenants made with them as a remnant of the house of Jacob. They are to be found throughout all the land of North and South America. Will our task be finished when this has been accomplished? The answer is: Verily no!

We have sung songs, quoted scripture and preached sermons about how in the latter days the Jews would return to their covenant land and build up Jerusalem again. We say that we believe there will be a holy people there once more. Let us ask our individual selves if we truly believe this. If we do, what are we doing about it? We declare that the Gospel was to be restored, first to the Gentile then the Jew. In this way, fulfilling the words of Christ, "The first shall be last and the last shall be first". When the gospel of Christ was first preached, it was to the Jew. Then the disciples of Christ took it to the Gentile. Now the order is reversed. After being preached to the Gentile for over one hundred years it must soon go to the Jew. But, we cannot stop there.

When Christ was here among His people on this land, He told them that He had another people which were not on this land, neither of the land of Jerusalem, neither in any part of that land round about. Nephi writes of the Lord's people being "in the east, and in the west, and in the north, and in the south, and in the islands of the sea."

These passages of scripture have been known among the members of the Church of Christ for over one hundred years. Many times we hear the thought expressed, "I wish these other people with their records would be discovered." The American Indian was discovered in the seventeenth century and nothing was known of his record (The Book of Mormon), until three hundred years later. This was a people discovered by those of the world. If Ephraim and Manasseh are to push the people of the earth together then it is reas-

## REFERENDUM NOTICE TO ALL BRANCHES AND MEMBERS

#### READ THESE INSTRUCTIONS BEFORE VOTING

Each organized local church is to hold a business meeting during the third week of June to consider and vote upon this referendum bill.

The secretary or clerk of the meeting shall record the number voting in favor of the bill and the number voting against the bill in the proper box at the end of the bill. Both the presiding minister and the secretary or clerk of the meeting shall sign this ballot before mailing. The secretary or clerk shall submit with this ballot a complete list of the members who attended the meeting when this bill was considered and voted upon.

All scattered members and members of a local church who did not attend the business meeting when this bill was considered and voted upon may send in their votes on a ballot by signing their names in the lower left hand box and placing the number of votes in favor of or opposed to the bill in the proper box immediately under the bill.

This ballot when properly marked shall be mailed and postmarked not later than July 31, 1954 to the following address:

#### BILL NO. 1

In accordance with the instructions of the conference to the secretaries, there will appear in the following "Affirmative Report" only those actions and measures on which an affirmative vote carried. The complete minutes of the Conference are held on file by the General Church Secretary. Copies are also held by the General Church Recorder, James M. Case; The Secretary of the Council of Twelve, Arthur M. Smith; Secretary of the Council of Bishops, C. LeRoy Wheaton, Jr.; and also the Board of General Church Historians.

The following principles will be followed in making the Report of the Affirmative Action of the 1954 Minister's Conference:

- 1. Organization of the conference is condensed.
- 2. Opening and closing exercises of the meetings are omitted.
- 3. Approval of minutes from session to session are omitted.
- 4. Ministerial reports are not shown; other reports not acted upon will be mentioned in brief, if at all. Reports of auxiliaries, etc. which are being spread in full on other pages of the Advocate will carry only a note showing that they are to be found in other pages of the Advocate.
- 5. Matters referred to committees or other bodies are not shown in full.
- 6. Elections of officers and committees will show only the final results.
- 7. Motions and resolutions are shown in the form finally adopted. Movers and seconders of the original motions will be shown where possible. Counted votes will show only on matters of α referendum nature.
- 8. Motions lost, tabled, or otherwise unnecessary to the understanding of the report are omitted.

Of the Ministers' Conference of the Church of Christ (Temple Lot)

In Session April 6, 1954 to April 12, 1954 on the Temple Lot, at Independence, Missouri

#### April 6, 1954 — 10:00 A. M. Session

Apostle Thomas E. Barton in charge assisted by Apostle Don W. Housknecht.

The body organized the conference as follows:

Chairmanship: The Council of Twelve.

Secretary: Bro. Forest Maley.

Press Committee: Brethren Arthur M. Smith, J. Maynard Case and C. LeRoy Wheaton

Ushers: Deacons present at the conference.

Program for the Conference:

9:30 A. M. to 10:45 Prayer and devotional service. 11:00 A. M. to 12:00 A. M. Preaching except when

other provisions have been made.

2:00 P. M. to 4:00 P. M. Business session.

4:30 P. M. to 5:30 P. M. School of the Ministry.

7:30 P. M. to 8:00 P. M. Song Service.

8:00 P. M. Preaching service, unless otherwise directed by the body.

Meetings of the Ministry in quorum capacity, committees, etc. shall be held during the early morning hours as much as possible, that all may be at liberty to attend the prayer service, and the business sessions of the Conference. When emergencies arise, these rules may be changed by a motion from the conference floor, and a majority vote of the body.

The General Sunday School Association was given

from 9:30 A. M. to 12:00 noon on Saturday, April 10th for their convention.

The United Workers (Women's Auxiliary) was given from 2:00 P. M. to 4:00 P. M. Thursday, April 8, for their convention.

The Young People's Christian League (Independence Local) were given the evening and night of April 10, Saturday, for their activities in entertaining the visiting young people of the Church.

#### April 6, 1954 - 2:00 P. M. Session

Apostle Don W. Housknecht in charge assisted by Apostle Wm. A. Sheldon.

The secretaries were about to read a communication from Bro. Clarence Wheaton containing a purportedly divine message.

Bro. Wm. F. Anderson moved that this document from Bro. Clarence L. Wheaton be referred to the Ministry. Seconded by Bro. Wm. A. Sheldon. Carried.

#### April 7, 1954 - 2:00 P. M. Session

Apostle Wm. A. Sheldon in charge assisted by Apostle Wm. F. Anderson.

Bro. LeRoy Wheaton moved that we set aside the next few minutes to sing "Blessed Be the Tie That Binds" in memory of our Brother, Apostles James E. Yates who has departed this life, and authorize the Chairman to send suitable condolences and flowers to the family in Phoenix. Seconded by Bro. Richard Wheaton. Carried. The singing of the song was immediately carried out.

The remainder of the session was spent in considering the report of the Jurisprudence Committee, which was referred back to them in a later meeting, return report was received, and their work finally laid on the table where it remained at the end of the closing session. Therefore, this report will not be shown in this presentation of the conference actions.

### April 8, 1954 - 11:00 A. M. Session

Apostle Wm. A. Sheldon in charge assisted by Apostle Wm. F. Anderson.

Consideration was given to the recommendation of the Council of Twelve and Bishops relative to incorporating the Church. It follows:

April 7, 1954 Independence, Mo.

To the Ministers' Conference Church of Christ Greetings:

At the recent special called Joint Council of the Council of Twelve Apostles and General Bishopric on April 1, 1954 the following resolution was adopted to recommend to the Ministers' Conference. We present it for your consideration:

"We recommend to the Conference that we take such steps necessary to incorporate the Church of Christ."

Bro. T. J. Jordan moved to appoint a committee of three to take this matter under advisement and report back at the earliest possible date; and that they be

authorized to seek legal counsel in connection with their investigation. Seconded by Bro. Don W. Housknecht. Carried.

**Committee on Incorporation:** Brethren Vance H. Harris, Nicholas F. Denham, and LeRoy Wheaton.

#### April 9, 1954 - 2:00 P. M. Session

Apostle Wm. F. Anderson in charge assisted by Apostle Leon A. Gould.

Bro. Clarence L. Wheaton arose on personal privilege to request the return to himself without further action of the body a document from himself to the conference which had been referred to the body of the Ministry.

Bro. Rolland D. Sprague moved that the document be returned to Bro. Wheaton. Seconded by Bro. LeRoy Wheaton. Carried.

Consideration was given to a recommendation from the Council of Twelve on two ordinations. The document follows:

April 9, 1954

To the Conference

Of the Church of Christ

The Council of Twelve met at 8:00 A. M. April 9 in special prayer that if it be pleasing to our Heavenly Father, that He might make known to us His pleasure as touching some of the problems that have come up before them, that unity and understanding might be theirs in carrying out the obligations and responsibilities that have been placed upon them.

After a season of prayer in which they all responded, Apostle B. C. Flint arose, and stated that during this season of prayer, he had received spiritual direction that Brother Archie F. Bell is called to the office of an Apostle in the Church of Christ.

After further consideration of this matter in which the Council was united in their testimony of this call, of which the Spirit bore witness to all, the Council by unanimous vote agreed to send to the Conference the following recommendation:

"We the Council of Twelve do recommend to the Conference, that inasmuch as it has been made known to us by the Spirit, that Archie F. Bell of Ava, Missouri, and Leon Yates of Phoenix, Arizona, have been called to serve in the office work of an Apostle, that they be set apart and ordained to this office at the earliest date possible."

We therefore recommend that provision be made for their ordination by this Conference.

Bro. Richard Wheaton moved that we approve the recommendation of the Twelve concerning these two brethren and provide for their ordination. Seconded by Bro. Nicholas F. Denham. Carried 41 to 12.

Bro. Clarence L. Wheaton moved that the ordination of these two brethren be provided for at the prayer service Sunday afternoon. Seconded by Bro. B. C. Flint. Carried.

During the discussion of the above business the Chair asked for statements from the two brethren with regard to their call to be Apostles.

Statement of Bro. Archie F. Bell. "It was asked if I have a statement to offer. I know it is true that I should be placed in the Council of Twelve and I have known it for years. I came to conference in 1930 expecting to be (placed in the Twelve). It was not told

me by anyone. God told me. I hope this answers your question. The only thing to decide here is which of the two spirits manifest here is of God. The question is, is this of God or of man?"

Statement of Bro. Leon Yates. "Somehow I'm not very excited. There have been occasions when I spoke to people when I was upset. But I have never been more calm than now. I believe God called me as was Aaron. I never realized, before, that after they were called as was Aaron that there should be such a discussion. I have known since the age of accountability that the Gospel had a work and I had a work in the Gospel. I have been taught the value of truth. I have had to school myself. I have made mistakes. I tried to correct them as fully as possible. And I fully expect to make some mistakes in the future. As far as my beliefs are concerned, I believe the Gospel of Jesus Christ and try to teach.'

Upon the request of Bro. Don Housknecht Bro. Archie F. Bell made a further statement. "I have nothing to cover up. When a person is 'called' it isn't a matter of belief. If you will notice in Paul's writings, it says they were not called because of their works but because of God's purpose. When they moved the Ark of the Covenant from one place to another and it looked like it would upset, a man put up his hand to steady it. You know the result. I want you all to take warning of it. Most of you know my past and my work. I don't believe I have done anything to upset the Ark of God restored in these last days. Never will I at any time do anything to disrupt it or upset it. I think too much of this work of Christ's to do anything to hinder it. My belief is that I have not. My personal beliefs will be kept to myself unless I am asked for them. Any man of God should not be ashamed nor afraid to state and give reasons for his personal beliefs if he is asked to do so.'

#### April 10, 1954 - 2:00 P. M. Session

Apostle Leon A. Gould in charge assisted by Apostle T. J. Jordan.

The return report of the Jurisprudence Committee was considered and tabled.

Bro. LeRoy Wheaton moved we express our appreciation for the effort of this committee and discharge them. Seconded and carried.

Consideration was given to the Report of the Auditing Committee and the report of the Auditor. The report of the Auditor appears in other pages of the Advocate.

April 8, 1954

To the Ministers' Conference Assembled.

We, the Auditing Committee, report once more we have accomplished our work for another year, having obtained the auditor, and he having finished his work, the report coming to the conference.

Bro. R. R. Robertson moved to accept the report of the United Workers. Seconded by Bro. Charles Reed. Carried.

Consideration was given to the Recommendation of the Joint Council relative to missionary help and the handling of spiritual manifestations. The document follows:

> April 1, 1954 Independence, Mo.

To the Ministers' Conference

Church of Christ Greetings:

At the recent special called council of the Council of Twelve Apostles, General Bishopric and Seventy on April 2 and 3, 1954 the following resolutions were adopted to recommend to the Ministers' Conference. We present them for your consideration:

1. "We recommend to the conference of the Church that when the missionary in charge of a field shall see a need of increased missionary activity in that field he shall by the inspiration from God select a Seventy, preferably, or an Elder who is willing to go into that field, he shall so recommend to the Council of Twelve and after their approval and upon consultation with the General Bishopric find the funds for his family's needs are available, he shall be sent out." "Nothing in the foregoing shall deny the right of the Conference to appoint a Seventy to a field of labor."

2. "Be it resolved that when a purported revelation comes and is substantiated by two or more witnesses that it shall be presented to the people (if given to  $\alpha$ local, be presented to a local; if given to the General Church, then it be presented to the General Church; if given to a quorum or individual, then it be presented to that quorum or individual, etc.,) and they shall be counselled to compare it with the Bible and the Book of Mormon and if it is found to be in harmony therewith, they may if they desire, take action concerning it and such action by a majority of the body considering it shall be the rule of that body, be it a local, quorum, or the General Church, etc., until it has been amended or rescinded. It shall then be that the arbitrament of time shall prove if the revelation and that action were of God." "Be it further resolved that any action of the past conflicting therewith be hereby rescinded."

Consideration was given the recommendation of the Joint Council of Twelve and Bishops on the budget, Business Manager, etc. The document follows:

"We recommend to the Bishopric that the expense of providing this home shall not exceed \$600.00."

"We recommend to the conference that Elder J. M. Case be the representative of the Twelve in the office and the caretaker of the property."

Bro. Rolland D. Sprague moved as a substitute that we approve the report of the Joint Council on the Budget, etc., and concur in the recommendations. Seconded by Bro. LeRoy Wheaton. Carried.

Consideration was given to the Opinion of the Twelve on the Gathering and Temporal law. The document, being a part of a report of the Joint Council of Apostles, Bishopric and Seventy, follows:

#### OPINION OF THE COUNCIL OF TWELVE APOSTLES RELATIVE TO THE GATHERING AND THE TEMPORAL LAW

To the Church of Christ (Temple Lot)

In Conference Assembled:

"We your servants of the Council of Twelve, wish to recommend the following course of action relative to the gathering to Independence, Missouri, and the regions round about, and action to be taken relative to the Temporal Law related thereto:

Whereas, the Church of Christ, through its Articles of Faith and Practice has expressed its belief in the 'literal gathering of Israel,' (Article 22), which incorporates the gathering of the Jews to Jerusalem, as well as the gathering of the seed of Joseph, descendants of Ephraim and Manasseh, upon this land, to-wit:

'That a New Jerusalem should be built up upon this land, unto the seed of Joseph,' etc., (Ether 6:6).

And, whereas we have further affirmed that this New Jerusalem shall be built 'beginning at the Temple Lot' (Article 24),

Which Temple Lot is at Independence, Missouri, the center place of Zion,

Therefore be it resolved, as a guide in our present need, that we as a people should look forward with hope and faith, making all necessary preparation against the day of a greater return and gathering to this land, which return and gathering had its beginning in the year 1867, at which time it was revealed that we should 'begin to gather,' (Truth Teller, page 4).

And whereas we have further been commanded that we should not gather in haste, but in order, be it further resolved:

That we advise the members of the Church abroad, desiring to gather here at the center place, that they consult with the (General) Bishopric who reside in this locality, and they gather not in haste but only after proper preparations have been made."

The above document was presented to the Joint Council of Twelve Apostles and General Bishopric on April 1, 1954 and was concurred in by all five Bishops present.

The following appendage was then adopted by the Joint Council:

"That in giving counsel and advice to those abroad who desire to gather, that such advice and counsel be given in harmony with the law of the church; and that a failure to do so shall subject them to a reprimand."

The above document and appendage was presented to the Council of Twelve Apostles, General Bishopric and Seventy in Joint Session at the evening session of April 2, 1954 and the following was adopted:

"Resolved that we send this document and the appendage as our Joint Action to the Conference."

Bro. LeRoy Wheaton moved that the first part of the document as to the opinion of the Twelve, all except the section about the reprimand, be approved. Seconded by Bro. Archie F. Bell. Carried.

Bro. Wm. F. Anderson moved that the appendage of the foregoing document be laid on the table. Seconded by Bro. Vance H. Harris. Carried.

Consideration was given to the report of the General Bishopric. It follows:

Independence, Mo.

To the Conference of Church of Christ (Temple Lot) Greetings:

The General Bishopric have prepared a budget and several recommendations in line with our temporal responsibilities which come to you as the joint action of the Council of Twelve and General Bishopric. However, we wish to call your attention to the fact that during the past seven years our receipts have increased from \$6,158.37 in 1946-47 to \$20,219.76 or nearly three and a half times the 1946-47 figure. It is of striking significance that the income increased in 1950-51 nearly 70% over the previous year. It was at that time that the missionary effort was begun in Mexico, we had also increased all our missionary effort, and about the time that the Church approved a clearer definition of Tithing.

Last year we felt that the budget we had proposed was high for so small a people. May we of the Bishopric express our deep appreciation for your response, for as you review the Auditor's Report you will see that we not only met the budget but in exceeding it we were able to put a small amount into a reserve fund.

In our budget this year we have taken into account the desire not only of the people of the Church but the ministry for an increase in our missionary effort. We have proposed to provide for this increase in enlarging the item for family allowances, as well as the item for Elders' Expense.

We have also provided for a fund of \$2,000.00 for offerings as a start for the home for the aged, needy and orphan children. We realize that this is only a beginning but feel that if you will come forward and support this over and above your regular tithes and offerings we shall soon see such a home in operation here at the center place.

In considering the living conditions in Yucatan, which we can hardly imagine, we have proposed to provide in our work this year the establishing of a missionary home near Dzan, Yucatan.

We wish to express to this conference and to the Church abroad our appreciation for the tireless effort of Brother Nicholas F. Denham over the last seven years that he has served the Church as Business Manager, and although we have recommended that he be given a much needed rest and that Bother Vance H. Harris be the Business Manager, it is impossible to tell you of the long hours of detailed work required to discharge this responsibility. The Council of Twelve and the General Bishopric in joint action have endeavored to show our appreciation of the tireless effort of Brother Denham.

In the year ahead much more is required of us than many may realize. May God give us sufficient of His Spirit and strength to accomplish the work which He has set before each of us.

The Council of Twelve recommend to the Conference for their consideration of the following list of appointments as the fields of missionary labor for the Council of Twelve.

William F. Anderson—Michigan, Ohio and Indiana. T. J. Jordan and Leon A. Gould—In joint charge together in Western Canada, Washington, Oregon, Idaho, Montana, North Dakota, South Dakota, Minnesota, and Iowa.

Leon Yates—Arizona, Utah, Nevada, and California. Thomas E. Barton—Colorado, Kansas, Nebraska

and Wyoming.

Clarence L. Wheaton—New Mexico, Oklahoma, Texas and Mexico.

William A. Sheldon and Don W. Housknecht—In joint charge together in Eastern Canada and Northeastern States including Maine, New Hampshire, Vermont, Rhode Island, Connecticut, New Jersey, Virginia, West Virginia, Pennsylvania and Maryland.

Archie F. Bell-Missouri, Arkansas, and Louisiana.

#### CHURCH OF CHRIST REPORT ON EXAMINATION MARCH 15, 1954

The General Bishopric

The Ministers' Conference, Church of Christ, Temple Lot,

#### Independence, Missouri

At the request of your Auditing Committee, consisting of Mr. R. D. Sprague, Mrs. Dorothy Denham and Mr. J. M. Case, I have made an examination of the books of account of the Church of Christ, maintained by Mr. Nicholas F. Denham, Business Manager, for the twelve months from March 16, 1953 to March 15, 1954 and present herewith my report including the following statements: Exhibit A: Statement of Cash Receipts and Expenditures for year ended March 15, 1954.

Exhibit B: Funds Balance Sheel at March 15, 1954. Scehdule 1: Family Allowances for year ended March 15, 1954.

These statements are subject to the following comments.

#### Cash Receipts and Expenditures—Exhibit A

The verification of cash receipts was confined to comparing the data on the stubs of receipts issued by the Business Manager during the period under review, with the corresponding entries in the cash book and tracing deposits of equivalent totals to the bank statements.

All disbursements were by checks which contained information regarding the nature of the disbursements. Thus each check, when properly endorsed by payee, constituted a receipt for the purposes indicated thereon. The checks were signed jointly by the Business Manager and the Secretary of the Bishopric. Verification consisted of examining the checks paid by the bank and comparing them with the cash book entries. Invoices were also examined and covered most of the expenditures except those of such nature as obviously would not be supported by invoices.

The cash receipts from all sources other than Temple Fund contributions, were deposited in a single account with the First National Bank of Independence, Missouri. The receipts indicated for "History Fund" are classified in this report with General Fund receipts for the reason that the excess of the History printing costs over receipts of the current and previous years was paid from the General Fund.

Expenditures for the Advocate and the Dining Hall activities were in excess of the receipts for these purposes by \$1,457.81 and \$83.95 respectively. Purchases of Books and Tracts were \$134.97 in excess of receipts from sales, etc., but it should be kept in mind that inventories of unsold books were not taken at the beginning and end of the year. The Cost of printing the History was \$1,829.45 in excess of total receipts from sales, etc. It was estimated that approximately threefourths of the total number printed were still on hand unsold at March 15, 1954. The results of annual operations would be more accurately disclosed if inventories of the saleable items were taken at the beginning and end of each year.

General Fund expenditures for the year exceeded the receipts by \$89.89. Contributions for the Mexican Mission were \$310.80 more than expenditures for Aid. Included in this amount is \$30.00 representing offerings for the Yucatan Building Fund. Temple Fund contributions were \$30.88. There were no disbursements from this fund, the present balance being \$2,289.86.

### Funds Balance Sheet—Exhibit B

Cash in bank and on hand is self-explanatory by reference to Exhibit A.

The several equipment figures are nominal amounts of \$1.00 each for the three groups indicated. In previous reports I referred to the incompleteness of the equipment accounts as carried on the books of account. This year, the Business Manager authorized the reduction to nominal values of \$1.00 for each category. I suggest that a memorandum inventory of all equipment items now owned be compiled and that subsequent additions and disposals be entered thereon even if such changes are not shown in the asset section of

the books.

The two real estate items are nominal amounts of \$1.00 each recorded at March 16, 1940.

The books are kept on the cash basis and there were no recorded liabilities at March 15, 1954. We were informed by the Business Manager that he knows of no unpaid bills.

#### General

Fire and extended coverage insurance is carried in the amount of \$2,500.00 on the building and \$500.00 on the contents. A fidelity bond of \$5,000.00 is carried on the Business Manager.

Full co-operation was accorded me by the Business Manager and the Auditing Committee.

I shall be glad to furnish any additional information that may be required.
