# EDITORIAL

The God of Heaven is still our God. We are fully convinced of that fact. If this were not so, the power of evil would not be trying so hard to overcome us. The evil one is the cause of all our persecutions, trials and tribulations.

It is quite evident that a new era is opening up, not only for the Lord's people but for the world as well. All indications are for the world to be faced with increased perplexities that will overtax its ability to solve. The task falls to the Lord's people to prepare the people to do the work designated by the Lord for Joseph, the son of Jacob, to do in the last days.

In the writings of Moses we find this statement: "Let the blessing come upon the head of Joseph, and upon the top of the head of him that was separated from his brethren. His glory is like the firstling of his bullock, and his horns are like the horns of unicoms; with them he shall push the people together to the ends of the earth: and they are the ten thousands of Ephraim, and they are the thousands of Manassah."

It must be remembered that Israel, in blessing the two sons of Joseph said: "Let my name be named on them". This caused them to be included in the family of Israel and become two of the Tribes. These two were the only sons of Joseph, therefore the tribe of Joseph would have to be extracts from these two sons.

The Lord indicated in the days of Nephi, that when the gospel was restored it would be to the Gentile. We also learn, from the prophecy of Zenos, that the Lord said He would graft tender twigs into the wild olive tree from the tame olive tree. Paul, in his writings, indicated that the Gentiles were the wild olive tree. We learn that Ephraim lost his identity among the Gentiles. This being the case, then, there is plenty of reason to believe there is an extract among the Gentiles here in America.

The Book of Mormon plainly states that the American Indian is a descendant of Manasseh. This, in the Book of Mormon, is called a planting. It will be necessary for an extract from this planting to be united with an extract from Ephraim among the Gentiles and they together will be the beginning of the tribe of Joseph.

The gospel was restored to the Gentile back in 1830 and has been carried forth among them in this land to this day, and will continue to be. Now we have entered the era when it must be established among the Indian or Lamanite. In the words of Christ we find that the Gentile is to assist the Lamanite. One meaning of assist is: Cause to stand.

We must be instrumental in placing the tools of the gospel in their hands and help them to learn how to use these tools. We are building the house of the Lord, having received authority to do so, and should be working on the second story at the present. The tools for building the Kingdom of God have been in the hands of the Gentiles only, up until lately, but now the Lamanites must begin to share this work.

The Lord's ways are always orderly. We understand that His plans were prepared from the foundation of the world, not only for the redemption of His people but also for appointed times and people to be used in His great plan.

Israel had some knowledge of this when He blessed the two sons of Joseph. Moses expressed a broader knowledge than Israel did, when he pronounced the blessing upon Joseph. Part of the blessing is quoted above. We must be careful not to run before the Lord, that is: not to start an all out effort which is not in harmony with His plans.

It should be plain to us that our primary work, today, is to prepare the descendants of the two sons of Joseph, on this land, for the work which the Lord decreed that they should do together.

The prophet Zenos wrote concerning this last work for the Lord: "And it came to pass that the Lord of the vineyard sent His servant; and the servant went and did as the Lord had commanded him, and brought other servants; and they were few.

"And the Lord of the vineyard said unto them, go to, and labor in the vineyard, with your mights . . . and the Lord of the vineyard labored also with them; and they did obey the commandments of the Lord of the vineyard, in all things."

In the above we can see that there are more than one doing the work for the Lord. Jacob makes the statement that this is the "last time, that the servants of the Lord shall go forth in His power, to nourish and prune His vineyard."

When Christ was here on earth, He made a statement that fits in well with the prophecy of Zenos in the part we have referred to. It is: "And then shall the power of heaven come down among them; and I also will be in the midst, and then shall the work of the Father commence, at that day when this gospel shall be preached among the remnant of this people.

Verily, I say unto you, at that day shall the work of the Father commence among all the dispersed of my people; yea, even the tribes which have been lost."

It stands to reason that if this work is to be done by the descendants of Joseph through his two sons; then they must be together when the Lord endues His servants with the power of Heaven. When they receive this enduement is the time when they will be positively identified as Ephraim and Manasseh in Joseph. Then, are they to push the people of the earth together. Then, will be fulfilled the statement of Christ wherein He says: "And this gospel of the kingdom shall be preached in all the world for a witness unto all nations." Then is the time when the stone, cut out of the mountain without hands, will start to break the image to pieces with the word of God. And fragments of the population of these various nations will be gathered home to the land of their inheritance.

There is no time to be lost in idle disputes, contentions or discouragements. We must remember the words of Christ: "He that endureth unto the end, the same shall be saved."

Satan knows that his time is short and for that reason he will put forth his every effort to destroy as much of the Lord's work as he can. We must be careful that we do not let ourselves be used by him in this effort of destruction.

Satan will pit person against person, personality against personality and group against group. He will try to get us to see so much fault in our fellowman that we see nothing but fault in everything, knowing that if we do this thing, we may turn against everything that is good and thus destroy ourselves.

The thoughts which try to induce us to give up, come from evil. The thoughts which invite and entice us to do good and endure trials and tribulations, come from God.

"Choose you this day whom ye shall serve".

Mount up the heights of wisdom And crush each error low Hold back no word of knowledge That human heart should know. Be faithful to your mission And the service of your Lord And then a home in glory Will be your great reward.

Motions and resolutions are to be shown in the form finally adopted. Movers and seconders of the original motions will be shown where possible.

Counted votes will show only on matters of a referendum nature. Motions lost, tabled, or otherwise unnecessary to the understanding of the report will be omitted.

Preamble: Whereas, there is a growing interest in the study of archeology in the Americas, as supporting evidence of the Book of Mormon, in the Church of Christ,

Therefore be it resolved, that this 1955 conference of the Church of Christ, (Temple Lot), looks with favor upon such a department in the Church, to be designated as the Archeological and Visual Aid Committee of the Church of Christ.

And it is further resolved, that to further such study, we do hereby appoint a permanent committee of six members to serve, two for three years, two for two years and two for one year; two to be elected or reelected each year.

And it is further provided that such committee shall be empowered to receive funds which shall be held by the General Bishopric under separate account for this purpose, and receive slides, books, and other archeological materials for the use of such committee, and be the custodian of the same, and shall classify, index, and prepare the same for use by our missionaries, as evidence of the divine authenticity of the Book of Mormon.

Archeological and Visual Aid Committee:—Fernando Ojeda (3), L. V. Aldridge (3), Clarence L. Wheaton (2), Archie F. Bell (2), E. J. McIndoo (1), Forest E. Maley (1). The numbers indicate the number of conference years to serve.

The Regulations for the General Church Representative follows:

> Independence, Missouri April 12, 1955

To the Conference of the Church of Christ Assembled Greetings:

At the meeting of the Joint Council meeting of the Council of Twelve Apostles and General Bishopric we voted to recommend to the conference for their approval the following:

# Duties of the General Church Representative in the General Church Office.

Whereas the Church by conference resolution adopted, April 12, 1946, (see Advocate for May, 1946, page 77) provisions for a "Church Representative in the General Church Office" and,

Whereas, there is no record of a rule or regulation governing the activities of said Representative, therefore be it recommended that the following regulations should be adopted.

l. It shall be his duty to meet all visitors during office hours, who come to the General Church Office on the Temple Lot seeking information, as follows:

(a) On our doctrine, and explain the same in accord with the Bible and Book of Mormon, the Articles of Faith and General Conference enactments; personal opinions should be stated as such.

(b) On our history, and be so informed as to be able to correctly represent it in accord with the accepted views of the Church of Christ and in harmony with the "Outline History of the Church of Christ."

(c) Concerning literature, tracts, etc., issued to the General Office by the Board of Publications and distribute same to the public as circumstances may warrant.

2. Handling of the mail received by him.

(a) All mail, except such as pertains to the temporal affairs shall be turned over to him by the Business Manager, for distribution to the departments or individuals to whom it should be assigned, without him taking the liberty to carry on a correspondence touching the same, except it be personally addressed to him in relation to a board, office or committee on which he serves. This shall in no wise conflict with the provisions for the Business Manager, as provided in the Bill No. 4 of the 1942 referendum enacted at the Special Conference of November 16, 1942, as found in the Supplement to Zion's Advocate, for December 1942.

(b) In his official correspondence, the representative of the Church shall request that mail be sent to the Church post office box.

(c) All official correspondence pertaining to the Administrative Missionary activities shall be referred to the Missionary in charge of the field which is affected.

A copy of all correspondence, if designated as official from "General Representative" shall be filed with the Missionary in charge of the field affected or with the Secretary of the Council of Twelve, if it be of general interest.

(d) In all correspondence dealing with doctrinal questions, he shall answer in accord with section 1 (a).

(e) All funds received in the mail shall be turned over to the Business Manager of the General Bishopric for the necessary correspondence related thereto. He shall issue a Bishop's agent receipt for all funds received from visitors to the office. He shall discourage the practice of members sending funds to him but shall instruct them to send them to the Business Manager in harmony with conference action.

(f) All correspondence pertaining to the Administration of Temporal Affairs in the Church shall be referred to the Secretary of the General Bishopric.

3. He shall be the custodian of the General Office, but the management of the office shall be under the Business Manager, in harmony with conference action. (Manager as used above is one who controls or directs the movements or workings of the office).

(a) The Business Manager, General Church Secretary, Recorder, Secretary of the Council of Twelve, and the Secretary of the General Bishopric shall be granted access to the office with keys.

4. He is to maintain at all times a missionary atmosphere in the General Office as his primary objective.

The recomendation of the Joint Council on missionary expenses follows as finally amended and adopted:

> Independence, Missouri April 13, 1955

To the Conference Of the Church of Christ Greetings:

Whereas; there have been injustices, hardships,

and inequalities in the manner in which missionaries have hitherto been provided their personal subsistence and travel expenses, due to circumstances over which they have no control;

Therefore; be it resolved that the Joint Council of the Twelve Apostles and the General Bishopric recommend to the General Conference for hteir approval as a rule or regulation governing this situation:

1. That the General Bishopric may issue to each missionary under General Conference appointment, and who receives an allowance for his family, an official receipt book, for the purpose of receipting every person who shall place in his hands, funds for tithes, offerings or special donations.

2. That all such funds, other than funds for personal use, shall, upon being received be turned over to the General Bishopric with a duplicate copy of such a receipt to be credited on their books to the donor. If donor desires to remain anonymous, it shall be so stated to the Bishopric and so entered upon their books.

3. That Missionaries shall be provided an Expense Drawing Account by the Bishopric, whereby their just wants and needs for subsistence and travel expenses shall be provided for. The drawing account shall be issued by the General Bishopric as requested from time to time as needed by the missionary.

4. That missionaries thus appointed shall make a regular monthly report of their missionary expenditures to the General Bishopric.

5. That in cases of emergency arising from sickness, accident, or other causes, they shall make their needs known to the General Bishopric, who in turn may provide them relief so far as it may be possible.

6. All solicitation for funds in the church, regardless for what purpose, and the funds so collected, shall be reported to the General Bishopric, and that we recommend to all our people to come forward with their tithes, offerings and consecrations to assist to further our General Missionary activities and to take care of the poor, needy, sick and that the work may arise as time passes.

These statements are subject to the following comments.

#### Cash Receipts, Expenditures and Fund Equities-Exhibit A

The verification of cash receipts was confined to comparing the data on the stubs of receipts issued by the Business Manager during the period under review, with the corresponding entries in the cash book and tracing deposits of equivalent totals to the bank statements.

All disbursements were by checks which contained information regarding the nature of the disbursements. Thus each check, when endorsed by the payee, constituted a receipt for the purposes indicated thereon.

The checks were signed jointly by the Business Manager and the Secretary of the Bishopric. Verification consisted of examining the checks paid by the bank and comparing them with the cash book entries. Invoices were also examined and covered most of the expenditures except those of such nature as obviously would not be supported by invoices.

The cash receipts from all sources other than Temple Fund contributions, were deposited in a single account with the First National Bank of Independence, Missouri.

Expenditures for the Advocate and the Dining Hall activities were in excess of the receipts for these purposes by \$1,265.22 and \$129.31 respectively. Purchases of Books and Tracts were \$99.68 in excess of receipts from sales, etc. I am informed that an inventory of unsold books was taken at the close of the year. If this practice is continued it will be possible to determine more accurately the net results of operating the book and tract department.

General Fund contributions for the year exceeded the expenditures by \$2,320.50. Expenditures for the Mexican Mission exceeded the contributions by \$350.78 of which amount \$310.80 was from Mexican Mission Funds on hand at the beginning of the year, the remainder of \$39.98 being considered a disbursement of the General Fund. Storehouse Fund contributions of \$3.50 were received and there were no disbursements for this fund. Vault Fund contributions of \$373.50 were received and \$60.00 was expended for a vault door and frame, leaving a balance of \$313.50 remaining in the Fund.

Temple Fund contributions were \$150.00. There were no disbursements from this fund, the present balance being \$2,439.86.

In addition to the cash balances shown, the only other assets recorded on the books are real estate and equipment at nominal values.

The books are kept on the cash basis and there were no recorded liabilities at March 15, 1955. We were informed by the Business Manager that he knows of no unpaid bills.

The Fund Equities at March 15, 1955 are shown on the last line of Exhibit A.

#### General

Fire and extended coverage insurance is carried in the amount of \$2,500.00 on the building and \$500.00 on the contents. A fidelity bond of \$5,000.00 is carried on the Business Manager.

The books were well kept and full co-operation was accorded me by the Business Manager and the Auditing Committee.

I shall be glad to furnish any additional information that may be required.

#### OUT OF THE MAIL SACK

Newaygo, Michigan, R2

Brothers and Sisters, Greetings:

I wish to tell you something about how I was taught the tenth chapter of St. John when I belonged to another church many years ago.

I will tell of only a few verses that we were studying one night a week at a time. We discussed the sheepfold as found in the first verse. Each one had a different idea as to what it was and how it was built, but mostly how it was built. Some said it was a barn, others said it was an inclosure made of wire, or poles, or stones such as corrals are built. They had it built of material things, not spiritual.

They did know who the shepherd was but not the sheep. They thought that the sheep were those that are kept in corrals or barns. That is in the second verse.

Now the third verse. The porter was just some hired man, servant or slave who looked after the sheep at night while the shepherd rested. Notice, I said shepherds instead of shepherd. They said that this porter was taking care of three or four flocks of sheep for as many shepherds.

Now the next two verses, and that is as far as I will write on what they believed. They said that each shepherd had a certain call and by the tone of his voice each flock would follow its own shepherd and would naturally be afraid of strangers. Oh, how far can the blind lead the blind and how deep is the ditch they both will fall into.

When I went to this old school house on these week-day nights and twice on Sundays, I had to go past a log cabin on the corner at the crossroads. One of the Church of Christ ministers lived there and also had meetings there once on Sunday afternoon and once in the week, sometimes more, that is if we gathered there to feed on the true gospel which he had brought to those of us who were willing to learn. He was sent here in answer to my prayers that God would give knowledge to those other ministers who were teaching us what they believed instead of what it really teaches in the Bible. God sent him instead.

This one Sunday morning I had gone to Sunday School at the school house as usual, but I was not satisfied with what I was being taught at all. So on the way home I stopped in at the cabin and this Church of Christ minister was standing by the front door talking to some other people. I walked up to him and asked him who the porter was and I didn't even tell him where we were studying, he knew.

He made me answer my own question by asking me another. He asked me who came out of the wilderness eating locusts and honey and I answered John the Baptist. And then I knew who the porter was instead of a servant, hired man or slave.

I also told him what they had said about the sheepfold and the sheep. He asked me who I thought the shepherd was and I told him that Jesus Christ was. He said, "If John the Baptist was the porter and Christ the shepherd, who were the sheep?" I said they must be the followers of Christ and he said that I was right. He then asked me what the sheepfold was. If it was a gathering place for the sheep, just what place was it? I had to think, there, but came up with the right answer; and he said I was right. It is the Church of Christ.

Those people that were there had come to an allday meeting. There were quite a few there from different parts of the state of Michigan. When I started asking the minister these questions they stopped talking and one could have heard a pin drop. They wanted to hear what one spiritual hungry soul was seeking after. I went on home one happy woman, and you have guessed it that I didn't miss the afternoon meeting either.

I left the other church right after that when they voted down my question and said, "It didn't amount to much."

My question was , "Does the Bible speak of the American Indian? If so, where is it found?"

No one could find it so it was voted down. It was my turn but my question was never answered. But we won't go into that.

Just one year later I was baptized into the Church of Christ and I don't regret one moment of it either. That was nearly sixteen years ago. There have been trials for me too but I am happy to be your sister in the only true gospel of our Lord and Savior, Jesus Christ.
