Our present bank balances are as follows: This is a gain of \$2,059.92 over the previous year.

We have, since the books were closed, contracted for the building of a six foot side walk and curb along the entire south side of the Temple Lot along Walnut Street, and for a new concrete landing and side walk at the River Boulevard entrance to the church. This has been completed and paid for just prior to the convening of conference.

The Stark Acres Lot was sold and the money received on contract given by the Business Manager but the deed has not been completed and delivered to the buyer. This will be attended to promptly.

We have no outstanding bills as all obligations have been taken care of promptly by the Business

Manager

We have tried to serve you and our Heavenly Father to the best of our ability and wish to thank each of you for your support of the many activities of the work.

Case, I have made an examination of the books of account of the Church of Christ (Temple Lot), maintained by Mr. Vance H. Harris, Business Manager, for the twelve months from March 16, 1955 to March 15, 1956 and present herewith my report including the following statements:

Exhibit A. Statement of Cash Receipts, Expenditures and Fund Equities for year ended March 15, 1956.

Schedule 1. Family Allowances for year ended March 15, 1956.

These statements are subject to the following comments.

Cash Receipts, Expenditures and Fund Equities Exhibit A

The verification of cash receipts was confined to comparing the data on the stubs of receipts issued by the Business Manager during the period under review, with the corresponding entries in the cash book and tracing deposits of equivalent totals to the bank statements.

All disbursements were by checks which contained information regarding the nature of the disbursements. Thus each check, when endorsed by the payee, constituted a receipt for the purposes indicated thereon. The checks were signed jointly by the Business Manager and the Secretary of the Bishopric. Verification consisted of examining the checks paid by the bank and comparing them with the cash book entries. Invoices were also examined and covered most of the expenditures except those of such nature as obviously would not be supported by invoices.

The cash receipts from all sources other than Temple Fund contributions, were deposited in a single account with the First National Bank of Independence, Missouri.

Expenditures for the Advocate were in excess of the subscription receipts by \$1,251.23. Dining Hall receipts were \$78.68 in excess of expenditures. Purchases of Books and Tracts were \$78.36 in excess of receipts from sales, etc.

General Fund contributions for the year exceeded

the expenditures by \$1,528.92.

Building Fund receipts of \$340.00 consisted of offerings of \$40.00, and \$300.00 from the sale of the Stark Acres Lot. There were no disbursements from these receipts.

Temple Fund contributions were \$191.00. There were no disbursements from this fund, the present balance being \$2,630.86.

In addition to the cash balances shown, the only other assets recorded on the books are real estate and equipment at nominal values.

The books are kept on a cash basis. We were informed by the Business Manager that the only unpaid bills are for the cost of new sidewalks on the south of the Temple Lot and in front of the Church, the

amounts being \$1,785.00 and \$365.00 respectively, the total being \$2,150.00.

The Fund Equities at March 15, 1956 are shown on the last line of Exhibit A.

General

Fire and extended coverage insurance is carried in the amount of \$2,500.00 on the building and \$500.00 on the contents. A fidelity bond of \$5,000 is carried on the Business Manager.

The books were well kept and full cooperation was accorded me by the Business Manager and Auditing Committee.

COME LET US REASON TOGETHER

"We have also a more sure word of prophecy; whereunto ye do well that ye take heed, as unto a light that shineth in a dark place, until the day dawn, and the day star arise in your hearts; Knowing this first, that no prophecy of the Scripture is of any private interpretation. For the prophecy came not in old time by the will of man; but holy men of God spake as they were moved by the Holy Ghost." II Peter 1:19-21.

The neglect of such a rule has thrown mankind into the utmost confusion and uncertainty in all their Biblical researches. While man is left at liberty to transform, spiritualize or give any uncertain or private interpretation to the word of God, all is uncertainty.

"Whatsoever things were written aforetime were written for our learning, that we through patience and comfort of the Scriptures, might have hope." Romans 15:4. Far better would it have been for mankind if the great Author of our existence had revealed nothing to His fallen creatures, than to have revealed a book which would leave them in doubt and uncertainty, to contend with one another, from age to age, respecting the meaning of its contents. That such uncertainty and contention have existed for ages, none will deny. The wise and learned have differed, and still do differ, from each other in the understanding of prophecy. Why the difference? Either revelation itself is deficient or else the fault is in mankind. But to say revelation is deficient would be to charge God foolishly; God forbid; the fault must be in man. There are two great causes for this blindness.

First, mankind has suposed that direct inspiration by the Holy Ghost was not intended for all ages of the church, but confined to primitive times; the "canon of Scripture being full," and all things necessary being revealed, the Spirit which guides into all truth was no longer for the people; therefore they sought to understand by their wisdom and by their own learning what could never be clearly understood except by the Spirit of truth, for the things of God knoweth no man except by the Spirit of God.

Second, having lost the Spirit of Inspiration, they began to institute their own opinions, traditions, and commandments, giving constructions and private interpretations to the written word instead of believing the things written. The moment they departed from its literal meaning, one man's opinion or interpretation was just as good as another's; all were clothed with equal authority, and from that arose all the darkness and misunderstanding on these points which have agitated the world for the last eighteen hundred years or more.

Let a book be published, entitled "A Knowledge of the Future", and let mankind be really convinced

that it did give a certain, definite knowledge of the future events so that its pages unfold the future history of the nations and great events. Such a large Edition would immediately sell at a great sum per copy. Now the books of the Prophets and the spirit of prophecy were intended for this very purpose. Well did the Apostles say:

'Covet earnestly the best gifts" I Cor. 12:31. ... Covet to prophecy ... "I Corinthians 14:39. And "Knowing this first, that no prophecy of the Scripture is of any private interpretation." II Peter 1:20. There is a division to be kept in mind, the distinction between the past and the future. If we find prophecy which has been literally fulfilled in the past, then it follows of necessity that every prophecy which is yet future will not fail of a literal fulfillment. It was well for Noah that he was not well versed in the spiritualizing systems of modern divinity; for, under their benighted influence, he would never have believed that so marvelous a prophecy would have had a literal meaning and accomplishment. No, he would have been told that the flood meant a spiritual flood and the ark α spiritual ark. But he was simple enough to believe the prophecy litrerally; and the world, who did not believe it, perished by the flood.

Another striking example of the power of foreknowledge is the vision of Nebuchadnezzar and the interpretation of the vision. Read Daniel 2:36-47. In view of this vision it presents to us the great kingdoms of the past; first, Babylon, under Nebuchadnezzar, second, Medes and Persians who took Babylon from Belshazzar and reigned over all the earth; third, the Greeks under Alexander who conquered the world the reigned in the midst of Babylon; fourth, the Roman Empire which subdued all things; fifth, its division into eastern and western empires and its final breaking up or subdivision into the various kingdoms of modern Europe, represented by the feet and toes, part of iron and part of clay; and lastly, an entirely new kingdom organized by the God of Heaven in the last days, or during the reign of these kingdoms, represented by the feet and toes. This last kingdom was never to change masters like all the kingdoms before it. It was to break in pieces all these kingdoms and stand forever. Many say that God organized this last kingdom in the days of Christ, but the kingdom of God, set up in the days of Christ, never did break in pieces any of the kingdoms of the world. It was itself warred against and overcome, in fulfillment of the words of Daniel 7:21, and John records in Revelation 13:7, "And it was given unto him to make war with the saints, and to overcome them; And power was given him over all kindreds, and tongues, and nations." In fulfillment of this, power was given to authorities of the earth to kill the Apostles and inspired men, until, if any remained, they were banished from among men, or forced to retire to desolate islands, or dens, caves or mountains. At the same time many false prophets and teachers were introduced in their place whom men heaped to themselves, because they would not endure sound doctrine. In this way the kingdom of God became disorganized and lost from among men, and the doctrine and churches of men instituted in its place.

Suffice it to say, that the kingdom spoken of by Daniel is something to be organized in the last days by the God of heaven Himself. And when once organized it will never cease to roll. All the powers of earth and hell will not impede its progress, until at length the Ancient of Days shall sit and the Lord Jesus will come in the clouds of heaven with power and great glory, as King of kings and Lord of lords, and destroy all these kingdoms, and give the kingdom of greatness, under the whole heaven to the Saints. Then there will be but our Lord, and His name one, and He shall be king over all the earth.

"Lord, wilt thou at this time restore again the kingdoms to Israel?" Acts 1:6. The Savior made answer that it was not for them to know the times and seasons which the Father had put in his own power; but they were to receive power and bear witness of them to the uttermost part of the earth, as much as to say, that work is not for you Apostles to accomplish, but shall be done in the Lord's own time, by whom He will, but go ye and do the work I have commanded you.

There are many other predictions such as Genesis 19:12-13. If it had entered Lot's heart that he must come out of Sodom spiritually, instead of literally, it would have cost him his life. How easy it is to believe what is in the past. Yes, we believe now, but would we have believed had we lived in that age? Let us ask ourselves this question, do we believe the prophecies being fulfilled in our day? It takes faith, and without faith it is impossible to please God.

"And I saw another angel fly in the midst of heaven, having the everlasting Gospel to preach unto them that dwell on the earth, and to every nation, and kindred, and tongue, and people saying with a loud voice, Fear God, and give glory to him; for the hour of his judgment is come: and worship him that made heaven and earth, and the sea, and the fountains of waters." Revelation 14:6-7.

"Therefore, behold, I will proceed to do a marvelous work among this people, even a marvelous work and a wonder: for the wisdom of their wise men shall perish, and the understanding of their prudent men shall be hid Is it not yet a very little while, and Lebanon shall be turned into a fruitful field, and the fruitful field shall be esteemed as a forest?" Isaiah 29: 14-17.

"But thou, O Daniel, shut up the words, and seal the book, even to the time of the end: many shall run to and fro, and knowledge shall be increased." Daniel 12:4.

If it were possible to go back a hundred years or less to the limited educational facilities, slavish conditions, we would feel as though we were transported to another world, to say nothing about the inventions and discoveries of modern times; and the "running to and fro" is evidenced by the crowded trains, congested

streetcars, buses, and overloaded boats which tell the tale that "the world do move."

"It shall come to pass in the last days, saith God, I will pour out my Spirit upon all flesh: and your sons and your daughters shall prophesy, and your young men shall see visions, and your old men shall dream dreams." Acts 2:17. Some may say, "Oh, a prophet is a preacher." The literal meaning of the Greek word is a forth-teller; one who speeds forth the message which has been communicated to him through Divine inspiration, whether of practical duties or future events.

Now do we believe that God will do this or do we believe the modern teaching that in these last days the Lord will not pour out His Spirit so as to cause our sons and our daughters to prophesy and old men to dream dreams and our young men to see visions for such things are no longer needed and it is all delusion, and none but the ignorant and narrow-minded believe such things?

We find in Acts 21:10-11, where a prophet named Agabus took Paul's girdle and bound his own hands and feet and said, "Thus saith the Holy Ghost, so shall the Jews at Jerusalem bind the man that owneth this girdle, and shall deliver him into the hands of the Gentiles." The fulfillment of this prediction is too well known to need any description. But we notice a prophecy of Paul's recorded in II Timothy 4:3-4, "For the time will come when they will not endure sound doctrine; but after their own lusts shall they heap to themselves teachers, having itching ears; and they shall turn away their ears from the truth, and shall be turned into fables." This prophesy has been fulfilled to the very letter, for it applies to every religious teacher who has arisen from that day unto the present, except those commissioned by direct revelation and inspired by the Holy Ghost. To convince the reader of its full accomplishments, we need only to point to the numberless presbyters of the day who preach for hire, and divine for money, and who receive their authority from their fellow man; and as to the fables to which they are turned, we need only to mention the spiritualizing and private interpretations which salute our ears from almost ever religious press and pulpit.

Another prophecy of Paul's is found in the first five verses of II Timothy 3, "This know also, that in the last days perilous times shall come. For men shall be lovers of their ownselves, covetous, boasters, proud, blasphemers, disobedient to parents, unthankful, unholy, without natural affection, truce-breakers, false accusers, incontinent, fierce, despisers of those that are good, traitors, heady, high-minded, lovers of pleasures more than lovers of God; Having a form of godliness, but denying the power thereof: from such turn away.' From the last verse of this quotation we learn to our astonishment that this sum of awful wickedness applies to professors of religion only; that is, this would be the character of the (so-called) Christian part of the community in the last days. Some may say this applies to those who profess no Christianity. Does it? Non-professors have no form of godliness, but those ungodly characters spoken of were to have a form of godliness, denying the power thereof. "From such turn away." A command, a warning. Are we heeding that warning? Do we turn away or do we gather with them in their ungodly worship, "denying the power thereof."

How it must pain the heart of our Heavenly Father when He sees all of these things. He knows how the peoples of the earth were groping in darkness seeking for His light. Then when the light did come, instead of receiving the light, they began to fight against it

Do we think that God would open this light to the world, showing them the untruths and the works of abomination that had taken hold of the hearts of men as well as showing them the way and the truth in this light, then because the world did not accept His way but rebelled against it, withdraw Himself from all mankind? Verily no! His truths will continue forever. His people will continue forever. No power on earth nor in the earth can stop His Eternal purposes.

The world does not believe that the Holy Ghost, as it was in the days of old, has been restored to mankind, but it has. It is resident among those of God's people as it has always been when the Church of Christ has been on earth. It has brought revelation, inspiration and the supernatural Gifts of the Spirit as well as authority from God. It has opened the eyes and the understanding of events in the latter days showing the fulfillment of many things spoken of by the Holy Prophets of old, and the understanding of things to come.

We cannot stop here. There is so much for God's people to do before the Second Coming of Christ and we know that He will not delay His coming.

Let us all be true to that light that God has given us and work faithfully while there is light for each one of us. If we do so we know that God has promised to give us additional light. We also know that the time will come for each one of us when we must lay down this tabernacle of clay; therefore let us work while it is yet day, laying aside all selfishness and discouragement because of the sneers and scoffs of the world.

Yes, come let us all work together in this glorious gospel work which God has entrusted to us.

After the meeting our pastor spoke to us on the evaluation of our place (as individuals) in the plan of righteousness. Included in his talk was the fact of the spiritual presence being the hinge for our entire work, for without it we would be just do-gooders.

On January 15 we had very good attendance. After the opening songs Brother Maley asked for silent prays and attention for Brother Gill's sake.

Glenn took us to the prophecies of Haggai and Zechariah which tell much about the desolation and waste of Jerusalem and its return to fertility. These prophesies also foretell (by mode of accompanying events) when Jerusalem shall become fruitful and habitable again.

Along with the prophesies Glenn read to us an article published in the Milwaukee Sentinel entitled, "Inside Israel in 1956." With the factual information in this article we can see how those prophesies are coming true. Just one of the many comparisons Glenn used between prophecy and fulfillment was in Zechariah chapter 8, verse 12, and in accord with this prophecy the article reads, "Everywhere you look little groves of trees are sprouting up to yield fruitful topsoil for future crops." The article goes on to explain the fertility of the farms in the Valley of Sharon. Among fertile field crops they also have fruit tree groves of orange, tangerine and other citrus fruits.

By the use of the article Glenn went on to estab-

lish the fulfillment of the prophesy of Jerusalem being built out beyond the walls; also Glenn mentioned by several other articles the tension possibilities which would bring the world to war on Jerusalem.

Glenn closed by stating that the time is close at hand when the nations of the world shall war on Jerusalem and Christ shall come, for even now Lebanon has become a fruitful field and the Jews are returning to their home land. As surely as the Lord punished them before He will bless them now.

The morning of January 22 began with a very good class. Brother Maley was introduced by Brother John Gill. He then presented material to us in the form of a round table discussion. The subject matter Brother Maley led us in was "necessity of spiritual and physical baptism and relationships between them." The scriptural material exposed by the discussion that was beneficial to the subject is as follows:

Saint John 1:1-6, "(5) . . . Except a man be born again of water and the Spirit he cannot enter the kingdom of heaven."

March 1:1-8, "(8) I indeed have baptized you with water; but he shall baptize you with the Holy Ghost."

The Sunday service of January 29, Brother John Gill introduced Brother Glenn Gill to be our speaker.

Glenn took us to some church history to show us that we must not look for the end before the means; that is, the establishment of Zion before we have accepted the Gospel and divine leadership. He then explained what constitutes a mistake. "Mistakes are things which we do now, but look back on later and learn why we did them." Glenn explained there are two general mistakes, the mistake of not doing and that of doing wrong. Glenn showed in readings from the Book of Commandments that we find no support for communal living except at Kirtland, Ohio, and that was a special case. Also, we find no support that the New Jerusalem or Zion shall exist before the time of divine leadership; but that the restoration of authority was established and ministers are ordained to preach; repent ye for the kingdom of heaven is at hand; just as John taught in preparation to Christ's first coming. Glenn concluded thus: the Bible and Book of Mormon are things to live by, let the spirit lead you. The spirit is our only contact with God so live pure before Him that we might have His spirit to be with us...

During the second week of February, Brother and Sister Jordan visited among the homes of the members in our Local. They made their residence at the farm home of Sister Gill and family. We very much appreciated their activity with us.

On the Sunday of February 12, Brother Maley introduced Brother Jordan as the speaker for the hour. As we were singing the opening song we noticed Bro. Jordan pick up his Bible and look for something. Brother Jordan began by saying that he felt a divine inspiration or guidance in his heart. His beginning text, which was inspired while we were singing was St. John 14:21-22, "He that hath my commandments, and keepeth them, he it is that loveth me: and he that loveth

me shall be loved of my Father, and I will love him, and will manifest myself to Him."

Going on, Brother Jordan, mentioned there were 1,037 different denominations representing Christ. Belief is vastly more than simply believing that Christ is my personal Saviour, for as it is in Matthew 7:20-23, "Wherefore by their fruits ye shall know them. Not everyone that saith unto me, Lord, Lord, shall enter into the kingdom of heaven; but he that doeth the will of my Father which is in heaven. Many will say to me in that day, Lord, Lord, have we not prophesied in thy name? and in thy name have cast out devils? and in thy name done many wonderful works? and then will I profess unto them, I never knew you: depart from me, ye that work iniquity."

Matthew 16:15-18; "But whom say ye that I am? And Simon Peter answered and said, Thou art the Christ, the son of the living God. Flesh and blood hath not revealed it unto thee but my Father which is in heaven. And I say also unto thee, that thou art Peter; and upon this rock I will build my church; and the gates of hell shall not prevail against it."

Brother Jordan then went on to explain how Christ set up His church. I Cor. 12:28, "And God hath set some in the church; first, apostles; secondarily, prophets;" etc. Ephesians 2:20, "and are built upon the foundation of the apostles and prophets, Jesus Christ himself being the chief cornerstone." Hebrews 6:1 (I.T.) "Therefore not leaving the principles of the doctrine of Christ, let us go on unto perfection; not laying again the foundation of repentance from dead works . . . "

Then Brother Jordan asked, "What are we going to do?" He then took for a text, Acts 2:37-38, where Peter preaches to them on the Day of Pentecost and tells them that he whom they crucified was Christ, and their reply was, "men and brethren what shall we do?" Then Peter said unto them repent and be baptized every one of you in the name of Jesus Christ for the remission of sins, and ye shall receive the gift of the Holy Ghost.

Now Brother Jordan explained that grace is not salvation unto eternal life, but that the remission of our sins after we have repented is that gift of grace that Christ offered unto us. Baptism in the name of Christ for the remission of sins and the abiding force of the Holy Ghost is unto salvation if we continue faithful observing His commandments unto the end.

Brother Jordan concluded Christ did come and establish His church which offered remission of sins and the Holy Ghost by baptism and laying on of hands. They also enjoyed blessings in that day. (Mark 16.)

Brother Jordan explained that this church after falling away was restored in these latter days identically as it was then. He ended with Romans 1:16, "I am not ashamed of the Gospel of Christ for it is the power of God unto salvation."

Our service of February 26 was opened by Brother Knapp who introduced our pastor, Brother Maley. Brother Maley mentioned that he would talk again on repentance. He presented a slight review of last week's material in Alma, chapter 19, in the Book of Mormon. If we sin we shall die in our sins. Now Alma

also mentions repentance as a turning about, or turning away from our sins. Brother Maley asked how salvation is gained. The scriptures say that salvation is through Jesus Christ. But how? The sectarian world says that salvation is through Jesus Christ by accepting Him as our personal Savior and He will save us. Then they say that after we are saved we will change and naturally do that which is right. Brother Maley then explained that this type of salvation would be instigated while sinners are still in their sins. Alma said that man shall die in his sins; therefore salvation is impossible unless a man turns from his sins. The Gospel teaches us that man is worthless without repentance and righteousness, for God wants honest intention of the soul. Therefore salvation through Jesus Christ, as Brother Maley explained, can only come to a person after he has turned away from the lusts of the flesh and is seeking the fruits of the Spirit.

Brother Maley then explained that after we have obtained the Spirit through baptism definite responsibilities are ours in order to obtain salvation. His text in this connection was Hebrews 6:1, (I.T.). "Therefore not leaving the principles of the doctrine of Christ, let us go on to perfection, not laying again the foundation of repentance from dead works, and of faith toward God.

Brother Maley presented a new thought on Revelation 14:6, "And I saw another angel fly in the midst of heaven, having the everlasting Gospel to preach unto them that dwell on the earth, and to every nation, kindred and tongue, and people." He explained that angels have never preached to anyone. They reveal, council, advise, and inform, but never do they preach. Therefore it is our responsibility to preach both with our mouths and with our example to every nation, kindred, tongue and people. But Brother Maley warned that we must preach and exemplify with the Holy Ghost, and in order to maintain the Spirit we must continue in repentance of dead works.

In summing up, we can say repentance is necessary to receive the Holy Ghost and also necessary to maintain it.

The Holy Ghost is necessary in our lives for it guides us through our tasks and choices, which are portraying a good example for others to follow, remaining faithful unto the end and preaching the Gospel.
