Chairmanship of the Conference

Brother L. V. Aldridge moved that the Council of Twelve preside over the conference.

Seconded by Bro. K. J. Smith.

Bro. Robert L. Maley moved as a substitute the following:

Whereas: In the past it has been our practice to place the chairmanship of the business meetings in the hands of the members of the Quorum of Twelve, and Whereas: This has been the source of some criticism to the members of that body when they have had to render a decision of the Chair, or to cast the Chair's vote in case of a tied vote,

Therefore: In an effort to remove these men from such focus of different opinions and a source of personal embarrassment to them in the past, I move: that by election of the conference assembled we elect a Board of Chairmen to conduct the Chairmanship of Business Meetings throughout the conference. This Board should be (1) chosen from the Eldership of the church who are present, (2) composed of three members known to be skillful in handling affairs of parliamentary meetings, (3) appointed to occupy the Chair acting as a Board of Chairmen, and in cases of a tie vote or a split decision on the floor, they shall render the decision of the chair from the majority vote within said Board. Seconded by Bro. Forest Maley. Lost 14 to 31.

Seconded by Bro. Frank Elliott. Bro. K. J. Smith moved the previous question. Seconded and carried.

Vote was called on the motion on procedure. Lost. First reading was given the following documents:

Bro. Richard A. Wheaton moved to further amend by striking out the sentence containing the words "The historian and associates shall be under the supervision of the Council of Twelve." Seconded by Bro. Frank Elliott. Lost 12 to 21.

Vote was called on the recommendation of the Twelve relative to a Historian as amended. Carried. The recommendation as adopted follows:

April 6, 1959

To the General Conference of the Church of Christ Greetings:

The Council of Twelve presents the following resolution for consideration and adoption:

Whereas there is an apparent need for a more complete history of the Restoration of the Church of Christ,

Whereas it is necessary to keep abreast of current historical events, and

Whereas the present system of a Board of Historians has proven unsatisfactory, due in part to the following reasons:

- (a) It is difficult for more than one individual to write the history.
- (b) Alternating membership of the board is not conducive to continuity of effort.

Therefore, be it Resolved:

That we recommend to the conference that the Board of Historians be discontinued, and that we further recommend the election of a historian and two advisory associates, whose terms of office shall continue jointly for a period of four years.

The compilation of historical matter, both current and past, with the view of producing a more complete history of the church, shall be the primary responsibil-

ity of the historian.

His associates shall be permitted to examine matter, advise, and edit such matter as may be determined suitable for publication.

The majority decision of the historian and his associates, as to manuscript content, shall prevail.

The historian and associates shall be under the supervision of the Council of Twelve.

Any historical material of value whatsoever shall be kept in the custody of the Library Board, to be at call of any Historian or Historical Board that may arise in the future, so that this material is not lost.

This organ has been used extensively throughout the conference thus far and we hope you have enjoyed the use of it as we have in our meetings. It has been set in the auditorium on trial.

Having been authorized to collect funds, take pledges, etc., the local committee petitions the General Church to give us the long idle Solovox to use to trade in on an electric or electronic organ when and if we succeed in raising such other funds necessary to make the purchase we have in mind. That way the Solovox need only be given us when a purchase is arranged. A dealer has said the instrument would be worth about \$125.00.

Considering the use the conference would have from year to year of such musical instrument as the local church might buy, we petition your favorable consideration of our request.

Minutes of the Conference, April 9, 1959 2:00 P. M. Session

The minutes of April 9, 1959—10:00 A. M. session were read and ruled to stand approved as read.

Discussion was resumed from the previous session on the matter of appointing a committee to learn the will of God concerning financial law.

Vote was called and the resolution carried 25 to 4. Following is the resolution on financial law adopted above:

RESOLUTION IN RESPECT TO THE ESTABLISHMENT OF A COMMITTEE WHICH IS DESIGNED THROUGH PRAYER AND FASTING AND RESEARCH, TO LEARN THE WILL OF GOD CONCERNING THE FINANCIAL LAW UNDER WHICH THE CHURCH OF CHRIST SHOULD FUNCTION

Whereas, there is, and ever has been much confusion in the world in general and in the Church of Christ in particular, concerning the financial law under God by which the incorporate body of God's people should function; and,

Whereas, it is readily agreed that no organization can operate properly without the use of money; and

Whereas, faith alone is not sufficient for the building up of Zion, and since the blessings of God are poured out only on those who step out on the promises of God and keep the will and commandments of Christ, even as Peter could not walk upon the water until he had stepped down out of the boat; and

Whereas, numerous attempts have been made at cooperative enterprises based upon the Scriptures or upon the wisdom of men, both within and outside of the Restoration, all of which have, in the main, resulted in the failure of these respective ventures to the embarrassment of their adherents; and,

Whereas, the Scriptures admonish us to use the brains that the Lord has given us in that we are told

to be "wise as serpents"; and

Whereas, the Church of Christ through the years has failed in the eyes of God and before the world to provide adequate churches for its people, as exemplified by the failure to build a church in Ticul, Yucatan, at only seventy-five cents a member; and

Whereas, the Church of Christ has failed in caring for the temporal needs of its poor, not even approaching the efforts of the Church of Jesus Christ of Latter Day Saints, who are honored before the world in this worthy enterprise; and

Whereas, the Church of Christ has failed to fulfill the great commission which is the very reason for its existence; to "Go ye into all the world and preach the gospel to every nation, kindred, tongue and people; baptizing them in the name of the Father, the Son and the Holy Ghost;" and

Whereas, the building up of Zion and the preparation for eternity are more important than this present life and the temporal needs thereof (which God has promised to provide if we keep His commandments and walk in His ways); and

Whereas, there are some in the Church who believe that all Church income should be through the medium of free-will offerings; while others teach that today, tithing plus offerings are sufficient; and still others who look for the time when we will live under the law known among us as the Consecration Law; all of which results in a wide gulf of misunderstanding prevailing throughout the whole Church of Christ; and

Whereas, there is great confusion and disagreement

concerning the operation of the law of tithes, or offerings, or consecration; and

Whereas, we are to study to show ourselves approved, a workman unto God who needeth not to be ashamed, rightly dividing the word of truth, therefore be it resolved;

First, that a committee of five members be elected, one of which is to be a Bishop, and two to be Apostles, to learn the will of God concerning the financial law of the Church of Christ;

Second, that this committee is to search diligently through the Bible, the Book of Mormon, Book of Commandments, Doctrine and Covenants, all applicable revelations of the Restoration, Restoration History, writings of the Church fathers of the early Christian Church; all applicable secular and church histories (in particular other efforts in cooperative enterprises) all other advantageous sources; and especially, through much fasting and prayer, to seek the guidance of the Holy Spirit that the will of the Lord may be manifest concerning the matter,

Third, that the five members must be industrious, sober, of seemly walk before the Church, men of wisdom, filled with the Spirit of God, capable in their own right of evaluating all data and sources of knowledge in this field, willing to spend long hours in research wherever the Spirit of God leads, and withal of a humble and contrite spirit and given to spending much time in the quiet place before their God in order to pour out their souls for His guidance and that they may become perfect before their Creator that their prayers may reach up to the throne of grace.

Fourth, that their findings, conclusions and recommendations be presented to the Conference in their fullness in the form of a complete monograph including suggested chapters on similar ventures in cooperative enterprises, how other church organizations meet their financial obligations, Scriptural studies (Bible, Book of Commandments, Doctrine and Covenants, Revelations, etc.), on tithing, offerings and Consecration, an exhaustive investigation on exactly what was contained in the law of Moses, and any other pertinent material that will be of aid in evaluating the many facets of this problem,

Fifth, that this committee continue to function for one conference year or until such a reasonable time that this work may be adequately and completely brought to a completion,

Sixth, that a minimum of the following meetings of the committee be had if at all possible in order to promote the progress of this work; two before leaving Independence, that the ground work and plans be laid to most effectively carry on this investigation, one during the summer to further expedite the work, and one before Conference (perhaps arriving early) in order to make any last minute adjustments or arrangements in the presentation of the final report.

Our total receipts from all sources was \$22,355.98 of which \$19,634.78 was tithes. This was a \$1,329.98 increase over last year showing that the people are responding favorably to the teaching of tithing.

Our total expenditure for all items was \$20,639.13 of which \$11,720.00 was family allowances and \$3,880.00 was Elder's expenses, these two items being approximately 80 per cent of our total expenditures.

Due to the slow rate of income during the first part of the year we thought we would have to pro-rate the allowances but due to the fine response of the tithepayers we were able to meet these obligations which the Bishops appreciate very much.

Our March 1st General Fund Balance was \$3,-265.05, Temple Fund Account \$2,689.86 and the General Building Fund Savings Account \$4,141.89.

I heartily recommend that we proceed to remodel and redecorate the council office, business office, rear hall, and rest rooms, depending upon the receipt of funds to cover such expenditures.

The appearance of the Temple Lot is not the best and this will require spraying and reseeding and the lot should be leveled at the same time. This item alone will amount to about \$500.00.

The report of the commission appointed by the Council of Twelve on a matter relative to Brethren L. V. Aldridge and Rolland D. Sprague was read: It follows:

To E. L. Yates, Chairman of the Appointing Committee in the Council of Twelve Greetings:

We, the undersigned, being a duly appointed commission under the provision of the rules of jurisprudence adopted by the Church of Christ to investigate the validity of the compliant made by Elder Rolland Sprague against Elder L. V. Aldridge, report and recommend the following:

We have earnestly and prayerfully entered into our responsibility in this matter. To the best of our ability we have endeavored to be guided by the laws of honesty and righteousness.

The affirmative statements concerning the behavior of the accused made by both the complainant and the accused are very largely in agreement. Both men, Bro. Sprague and Bro. Aldridge, report the same story to us concerning holding the sacrament service in St. Louis local without the knowledge of the pastor. The complainant honestly felt that this constituted a violation of Paragraph 15 of the Articles of Faith and Practice. The accused felt that this was not a real violation of this paragraph but was willing to make amends for offense caused by his actions in the form of a public apology.

The complainant also saw his error in publicly bringing this charge against his brother and is willing to make public apology for any hurt that he has caused him.

We therefore believe that a reconciliation has been affected and recommend that no Elder's Court be appointed. Accordingly we respectfully request that we be discharged.

Bro. Rolland D. Sprague made the following state-

ment:

"I have a statement now to give. I very much commend the attitude of the commission that worked with us. I wish to state that through the efforts of the committee appointed by three members of the Council of Twelve, Bro. L. V. Aldridge has agreed to correct the error of calling a meeting and serving the sacrament to members of the St. Louis Local Church without the knowledge and consent of the pastor (which in my opinion was a violation of Article 15 of the Articles of Faith and Practice).

"Bro. Aldridge has expressed himself as having been wounded by the unwise method of bringing the charge against him here on the conference floor. I apologize to him and to this conference for this offense, and ask forgiveness of my brother and this conference.

The following statement from Bro. L. V. Aldridge was read:

To the Church of Christ Assembled, Greetings:

In holding the sacrament service in the home of Brother Shankle I did so with only one purpose in mind; to minister to those who, because of friction in the local in St. Louis, were absenting themselves from the local services.

It is my opinion that I did not violate Par. 15 of Articles of Faith and Practice of the Church of Christ as charged by Elder Rolland Sprague.

I had no intention to override the pastor since he had previously invited me to come to St. Louis to see if I could get this family back to attend services. I felt directed by the Holy Spirit to administer the sacrament to them. If my motives were misunderstood by the pastor and members of the St. Louis Local I am very sorry for any hurt they may have received because of this incident.

After the statement by Bro. Sprague, Bro. LeRoy Wheaton moved that in view of the statement by Bro. Sprague, we acept the apology. Seconded by Bro. E. Leon Yates. Carried.

Bro. LeRoy Wheaton moved that we accept the statement and apology of Brother Aldridge. Seconded

by Bro. E. Leon Yates. Carried.

Bro. Wm. F. Anderson called for second reading and consideration of the recommendation of the Twelve on private publications. It was given second reading and follows:

April 6, 1959

To the General Conference of the Church of Christ Greetings:

The Council of Twelve Apostles recommends the following preamble and resolution for adoption:

Inasmuch as there is in existence in the church a number of privately sponsored and distributed publications, some of which are damaging to the progress of the church, in that some of their utterances are designed to destroy rather than to build, and

Whereas the Church has an official publication known as the ZION'S ADVOCATE, to which all may submit matter of general interest to the church, and

Whereas the ZION'S ADVOCATE does not receive much matter because of its submission to privately distributed publications, and

Whereas we wish to solicit and encourage the submission of more material of constructive nature to the General Church paper, therefore

Be it resolved,

That the General Church looks with utmost disapproval upon the publication of matter, antagonistic or destructive in nature, either in the ZION'S ADVO-CATE or privately sponsored publications of the church membership.

Such matter is that which is in flagrant opposition to the church's stand on its councils, beliefs and practices.

If there be legitimate objection to the church's stand on various matters, these objections may be considered through the proper council or conference of the church. (signed) Wm. A. Sheldon, Sec'y.

Collins, Mo.—Bro. Joseph Yates—We are rather proud of our Sunday School. Our average attendance is 18 to 43. We have 3 classes. They are studying prophesy in regard to the restoration of the church and another class is studying the book of Isaiah.

Minneapolis, Minn.—John Gill—We have two types of classes. The adult class is round table type and they are studying the Book of Mormon. The little children's class has little drawings and papers to draw and color with a lesson connection.

Grand Junction, Colo.—Marvin Ely—We have an average attendance of 35 to 40 divided into 5 classes. Cradle roll, primary class, intermediate class, young people's class, and adult class.
