EDITORIAL

The 1960 Conference will be remembered as one of quiet, tolerant consideration of differences of opinion during earnest deliberations. It is true that some members may have been disappointed in the defeat of their measures which they felt convinced would have been beneficial to the church. It is also true that some members may be convinced that some actions taken by the Conference will not prove to be beneficial to the church. Conference actions are not proven by the opinions of men but by their own fruits which time will reveal.

We, as members of the church, are bound by the voice of the church. The scriptures teach that it is rare that the voice of the church is wrong, but if the time comes that the voice of the majority of the church is wrong, then is the church in a woeful condition.

Sometimes men are tempted to turn against the decision of the majority and go their own ways regardless of the stand of the majority. In the history of Christendom there are instances when men were justified in taking a firm stand in opposition to the majority, but these instances were justified only when the majority was definitely wrong. Men should be very careful to make sure that the majority is wrong before turning in opposition to the majority. Many men, unjustifiably thinking they themselves were right, have turned against the decision of the majority and have defeated their own purposes.

There are a number of measures going out to the People's Conference from the Ministers' Conference for final decision by the people this spring. Those who vote on these measures will do well to consider them carefully and prayerfully that the resulting decisions of the church may be righteous decisions.

May we each labor diligently to bring ourselves into complete subjection to the will of God, serving Him and each other in love and humility that we may bring glory and honor to His name.

Report of the Financial Committee adopted for publication as follows:

Report of the Financial Committee

One year ago, by Conference action, the Financial Committee was created with the express function of pursuing an exhaustive study of all available religious and secular literature relative to certain economic systems such as tithing, all things common and consecration. The specific purpose of this research is to learn the will of God concerning the financial law of the Church of Christ and to avoid the many pitfalls of those who have had a zeal but not according to knowledge. The scriptures tell us that the time will come when men will kill us thinking that thereby they are doing God's service. Likewise, many times in the past men have turned all they had into various communal schemes boasting to the world that it was of God and have made a fetish of their peculiar mode of living; but these peculiar systems were not born of the wisdom of God but of the foolishness of man, and many of these bear even the earmarks of the madness of Satan. Lest we, as a people, fall into a similar madness through the insidious deceptions of Satan, it was deemed expedient to seek, through prayer and fasting and much study to learn the will and counsel of God in this matter.

It was further stated in the above Conference action that their "findings, conclusions and recommendations be presented to the Conference in their fullness in the form of a complete monograph." In order to bring to a successful conclusion the project delineated in these Conference instructions, the Committee has completed the study of about fifteen books including the Bible, the Book of Mormon and the Book of Commandments. Correspondence is also being carried on with contemporary groups interested in communal living. Pertinent data to the extent of one hundred and sixty-five pages of single-spaced typewritten pages have been collected. At the present time the monograph has not been prepared. The Committee estimates that a least another year will be required for the completion of this task. However, this schedule is well within the time alloted by the 1959 Conference which states "that this Committee continue to function for one Conference year or until such a reasonable time that this work may be adequately and completely brought to a completion."

In lieu of the fact that the general church organization must continue to function, it is the consensus of the Committee that it is absolutely essential that the Saints of the Church of Christ willfully and wholeheartedly support the present system of tithing as recommended by former Conference action, regardless of whatever economic system under which they may choose to live, whether it be all things common, or the old garden variety of capitalism indigenous to the country as a whole. Note the following Conference resolution relative to this point: "Any local, or group of people in a local, desirous of doing so, may organize into cooperative associations for the advancement of their spiritual and economic welfare and the furthering of social equality and the principles of all things common among themselves, may do so, in harmony with scriptures found in the Bible, Book of Mormon, and the Laws and Commandments given to the Church of Christ in these last days; and in harmony with the actions of the General Conferences of the Church of Christ, as follows Resolved, that it is the sense of this body, that it be recommended for the acceptance of the church as a whole, that there be an observance of the principle of consecration of all our properties to the church, to be followed by tithing one-tenth of one's income."-Adopted October 19, 1925.

The work of the Board of Publications was done in a series of three meetings held at different dates during the year of 1959 in which the following work was done:

(1) It was decided by the Board that the price of the "OUTLINE HISTORY OF THE CHURCH OF CHRIST" be reduced to \$2.00 ea. (below cost) and advertised in Zion's Advocate. This price is intended to include the cost of Postage and Insurance or handling.

(2) The Board of Publications authorized the reprinting of the BOOK OF COMMANDMENTS in the following amounts:

(a) 750 Paperbacks

(b) 250 Cloth or plastic bindings

AUDITOR'S REPORT

The General Bishopric and The Ministers' Conference Church of Christ (Temple Lot) Independence, Missouri

At the request of your Auditing Committee, consistof Mr. J. M. Case, Mr. Denver G. Chapman, and Mr. Leslie P. Case, I have made an examination of the books of account of the Church of Christ (Temple Lot), maintained by Mr. Vance H. Harris, Business Manager for the twelve months ended February 29, 1960, and present herewith my report including the following statements:

Exhibit A—Summary of Receipts and Expenditures for the year ended February 29, 1960.

Exhibit B-Statement of General Fund Expenditures for the year ended February 29, 1960.

Schedule B1-Statement of Family Allowances and Aid for the year ended February 29, 1960.

These statements are subject to the following comments:

Cash Receipts and Expenditures — Exhibits A and B

The verification of cash receipts was confined to comparing data on the carbon copies of the receipts issued by the Business Manager with the corresponding entries in the cash book and determining that the deposits made to the bank accounts and the undeposited cash on hand were equal to the total receipts.

All disbursements were by checks which contain information regarding the nature of the disbursements. Thus each check, when endorsed by the payee, constituted a receipt for the purposes indicated thereon. The checks were signed jointly by the Business Manager and the Secretary of the Bishopric. Verification consisted of examining the checks paid by the bank and comparing them with the cash book entries. The balances in bank at the close of the period were confirmed by certificates received directly from the despositaries. The undeposited cash on hand was confirmed by a signed statement from the Business Manager.

There were two groups of receipts and offsetting expeditures not included in the statements presented because they did not repesent church income and expenses. These items are as follows: Personal contributions received for and

The books are kept on a cash basis. We were informed by the Business Manager that there were no unpaid bills at the close of the year.

Fire and extended coverage insurance is carried in the amount of \$12,000.00 on the church building and \$3,000.00 on the contents. A fidelity bond is carried on the Business Manager.

GOSPEL TRUTHS In the Book of Mormon

We, who are blessed with our belief in the Book of Mormon, have probably often realized as we teach our children, what a treasure chest it is. It is filled with true adventure stories; and as it ties in with modern archaeological findings, it is as fascinating as any mystery tale.

Also, through the pages of this wonderful book, we find stories that very clearly illustrate principles of the church, and great truths that every child should know. You teachers, who are better students of the Book of Mormon than I am, will know many, many such examples. But here are just a few that seem to me good illustrations of the various ideas. The story, with the particular point to be brought out in mind, may be told to the children in your own words. All, or parts of it, may be read from the Book of Mormon to be followed by an explanation and question period. Always, it seems advisable to adapt the lesson to the child's daily life.

FAITH: Outstanding among the many beautiful stories of faith in the Book of Mormon, is the one of the brother of Jared asking the Lord to touch the stones to make light for their vessels. (Ether)

REPENTANCE: Tell the story of the sudden conversion of the sons of Mosiah, and Alma, son of Alma, when the angel appeared to them and asked why they were persecuting the church. (Mosiah).

BAPTISM: Give background of Alma leading the faithful to the place called Mormon followed by the story of baptisms there. (Mosiah).

LAYING ON OF HANDS: To me, one of the most glorious stories is that of Christ blessing the little children ringed by the angels from heaven. (III Nephi). Tell other times the ordinance of "Laying on of Hands" is used.

ETERNAL LIFE: Importance of preparing for Eternal Life as shown in the vision of Lehi about the Rod of Iron and the Tree of Life. (I Nephi)

PROPHECY: Many examples to be found ... a striking story is that of Samuel the Lamanite, preaching of the coming of Christ. (Helaman). Follow with the stories of fulfillment of Samuel's prophecies.

VISIONS: The entire story of Ammon becoming a servant to King Lamoni, the king's conversion, his visions and those of his household. (Alma).

REWARD OF RIGHTEOUS LIVING: Story of courage and faith of "Helaman's sons" in battle, with no lives lost. (Alma).

WHEREVER WE ARE, GOD HEARS OUR PRAYERS: Lessons to be learned from Tower of Zoramites. (Alma).

GOD PROTECTS HIS SERVANTS: Miracle of the circle of fire when Nephi and Lehi were in prison in Lamanite country. (Helaman).

REMEMBER GOD IN GOOD, AS WELL AS TROUB-LED TIMES: The dramatic story of Moroni and his flag of freedom, calling the people back to God. (Alma).

MISSIONARIES, THEN AND NOW: For 14 years, the sons of Mosiah preached in the Lamanite country. Keep our children up to date on work of our present day missionaries. (Mosiah).
