EDITORIAL

As this number of the Advocate goes to press the Summit Conference of the Big Four convenes in Paris. Each of the Big Four nations represented by its head of state is calling for peace. This call has been going on for a number of years while both the East and the West have prepared for a great conflict.

The continuing chain of international events flaring up throughout the world causing increasing tensions makes us aware of the gravity of the international situation. The fact that an American was caught spying on Russia's activities is only a small link in this chain of events. It has been admitted that spying on each other is a common practice between the East and the West, but to be caught is an excuse for much fuss.

The dark clouds of turmoil over Europe, Asia and Africa, which George Washington saw in vision while camped at Valley Forge are already boiling and are exactly according to the time table. The communistic "dark red light" is glowing plainly as he saw. The rest of his vision can well be expected to follow shortly. Is America ready for these clouds as they join in one to envelope her in a terrible conflict such as she has not experienced before?

Is the church prepared to meet this great trial when it comes? Is the faith of her people sufficient to stand firm when these things come? There is little time left to prepare. Having been forewarned we should be making ourselves ready rather than to be found asleep without oil in our vessels as were the five foolish virgins.

Let us humble ourselves individually and as a people before the Lord and seek to serve Him with full purpose of heart and cease to have our attention centered on things of a lesser nature.

At the recent conference I offered my resignation from the Referendum Committee which was accepted and another qualified to fill the position elected. The explanation accompanying said resignation has caused personal offence. I therefore wish to do all in my power to make amends for the wrong done; therefore in view of the fact the personal offence was made in public, I wish to make a public apology and publicly sue for forgiveness.

The General Church Recorder was never aware of the fact that I took issue with her until after the conference had acted upon my resignation and it had been recorded in the minutes.

Minutes of Conference, April 12, 1960 10:00 A. M. Session

Apostle Don W. Housknecht in charge, assisted by Apostle Wm. A. Sheldon.

Opening song: No. 217-Soldiers of Christ Arise.

Opening prayer by Apostle Wm. A. Sheldon.

Second song: No. 230—God Is My Strong Salvation.

Scripture reading: Selection from chapters 6 and 10 of II Cor.

The minutes of April 11, 10:00 A.M. Session were read and were ruled to stand approved as read.

The minutes of April 11, 2:00 P.M. Session were read and were ruled to stand approved as read.

The report of the Dining Hall Committee was given first reading. It follows:

Bro. Arthur M. Smith moved that we receive the report and give the Dining Hall Committee a standing vote of appreciation. Seconded by Marvin Ely. Carried by standing vote, none opposed.

Form No. 7a was given consideration.

Bro. Harvey Seibel, Sr., moved that we accept Form No. 7a. Seconded by Bro. Clarence Thompson.

Bro. Harvey Seibel, Sr. moved as a substitute for the whole matter that we follow the recommendations of the Quorum of Twelve in the following items (1) that Form No. 7a shall be incorporated in a book, (2) that the title shall be changed from "Items of Blessing" to "Membership Data", (3) that "name of spouse" be changed to "companion's name", (4) that items of children with birthdates will be deleted. Seconded by Bro. Arthur M. Smith.

Bro. Wm. F. Anderson moved, as a substitute for the substitute that we approve the recommendation from the Council of Twelve on Form No. 7a and Form No. 12. Seconded by Bro. B. C. Flint.

Bro. Harvey Seibel, Sr. proposed to offer another substitute for the whole matter. It was noted that this would be an amendment of the third order and normally out of order.

Bro. Harvey Seibel, Sr., moved that we waive the rule on amendments of the third order for this particular motion only. Seconded by Bro. John A. Sweem. Lost.

The Chair ruled out of order an amendment of the third order.

Bro. Marvin M. Case moved the previous question on the substitute and the substitute for the substitute, but not on the original motion to approve. Seconded by Bro. Clarence Thompson. Carried by show of hands.

Vote was called on the substitute by Bro. Wm. F. Anderson to approve the recommendations of the Council of Twelve. Carried 20 to 15.

The recommendation of the Twelve relative to Forms 7a and 12 follows:

"Forms 7a and 12 to be incorporated in a booklet to be carried by the ministry, and filled out when officiating in a baptismal service. The Certificate of Baptism (Form 12) would remain as shown except that all below, 'AND BECAME A MEMBER OF THE CHURCH OF CHRIST', would be deleted, and space provided there for the signature of the 'Officiating Minister.' The title of Form 7a would be changed to 'MEMBER-SHIP DATA'. 'Name of Spouse' would be changed to 'Companion's Name.' Listing of children's names and birthdates would be deleted. The Certificate of Baptism and two of the Membership Data forms would be printed on a single sheet of paper, with perforations between. The Certificate of baptism would go to the candidate, one Membership Data form to the General Church Recorder, and the other to remain in possession of the minister who officiated."

Bro. LeRoy Wheaton moved to further amend forms 7a and 12 by deleting the words "Membership Data" and call it "Baptism Data"; and after it says "Date of Birth" put "Father....." and "Mother....." and where it says "Local Pastor, Local Clerk, and date", that it be "Signature of Officiating Minister" and leave the date down there. In Form No. 12 where we deleted the impression seal, put a printed seal. On each form of these sheets there shall be a serial number, and

this serial number shall become the item number in the Recorder's record. Seconded by B. C. Flint.

Vote was called on the amendment by Bro. LeRoy Wheaton to change to Baptism Data, etc. Carried by show of hands.

Vote was called on the motion to approve Form No. 7a and Form No. 12 as amended. Carried by show of hands.

Bro. Marvin Ely moved that Form No. 12 be made available to the General Church Recorder in separate form for furnishing duplicate certificates. Seconded by Bro. LeRoy Wheaton.

Bro. LeRoy Wheaton moved, as a matter incidental to the instructions relative to Form No. 7a, to strike out the word "triplicate", also strike out "local clerk and pastor" and say "signed by the officiating minister." Further, to strike out paragraph (3) three and say, "first copy to be retained in book by officiating minister, second copy to General Church Recorder." Strike out reference to a third copy. In reference to the instructions to Form No. 12, strike out all after the word "issued" and add "by the officiating minister". On the instructions to Form 7a change the title to "Baptism Data." With reference to instructions to Form No. 12, add "Item 2. A duplicate copy may be issued by the General Church Recorder upon request." Seconded by Bro. Wm. A. Sheldon.

Vote was called on the incidental motion. Carried by show of hands.

Vote was called on the motion to authorize duplicates of Form 12. Carried by show of hands.

Bro. Thomas E. Barton, Jr., had requested permission to register a vote with reference to a matter to come up for consideration in later sessions of the Conference because he anticipated being gone at the time.

Bro. LeRoy Wheaton moved that it be the sense of this body with reference to requesting this body to register a vote on a pending matter, that we deem it unwise to set a precedent; that when these things go out to referendum he will have the opportunity then to vote. Seconded by Bro. Harvey Seibel, Sr.

Carried by show of hands.

The Chairman declared the session to stand adjourned.

Closing prayer by Bro. Wm. A. Sheldon.

Minutes of Conference, April 12, 1960 2:00 P. M. Session

Apostle Wm. A. Sheldon in charge, assisted by Apostle Wm. F. Anderson.

Opening song: No. 175—Guide Us, O Thou Great Jehovah.

Opening prayer by Apostle Wm. F. Anderson.

Scripture reading: Acts 15:1-11.

Sr. Edna Smith moved that the unapproved minutes of this conference be placed in the hands of the Council of Twelve for approval when they are ready to be read. Seconded by Bro. LeRoy Wheaton. Carried by show of hands.

Consideration of the forms was resumed, the next being Form No. 7 for transfer of members of other branches of the Restoration to the Church of Christ, Temple Lot.

The Chair ruled that before consideration of Form No. 7, a matter should first be handled having to do with whether or not any at all should be received by transfer. This had reference to the Resolution on the Manner of Uniting with the Church of Christ as sponsored by Bro. Harvey Seibel, Sr.

Bro. Harvey Seibel moved the acceptance of this document on the resolution on the manner of uniting with the Church of Christ. Seconded by Bro. Ed. Podhola.

The resolution follows:

Resolution on The Manner of Uniting With The Church of Christ

Whereas, No man can administer the ordinance of baptism, except he who has authority given him of God: Book of Commandments 24:52, and

Whereas, There can not be more than one Church of Christ with one faith, one doctrine and one baptism, or else God is divided, for the scripture tells us, "If ye are not one ye are not mine," and

Whereas, It is unthinkable that there could be more than one set of the priesthoods with more than one quorum of twelve apostles called of God to preach conflicting gospels, and

Whereas, No man taketh this honor unto himself except he that is called of God as was Aaron, and

Whereas, It is a dangerous thing to treat lightly the gift of this authority as is seen from the following catastrophic examples:

- 1. Nadab and Abihu, sons of Aaron and priests in the Temple, offered strange fire before the Lord which they had not been commanded and fire came down from the altar of God and burned them up and they died before the altar of God for their error. Lev. 10:1-2.
- 2. When the Ark was being returned from the Philistines on a cart drawn by oxen, Uzzah who had not been called to the priesthood, reached out his hand to steady the Ark of God and he died before the Lord for he had treated lightly the command that only the priest could touch the Holy Ark of God. II Sam. 6:6-7.
- 3. The two hundred and fifty princes of Israel, men of reknown, sought the honor of the Priesthood which had been given to Moses and fire came down from God and burned them up and the earth opened and swallowed their wives and children and all that they owned because they treated lightly the Holy Priesthood. Numbers 16:1-35, and

Whereas, The other churches of the Restoration have denied the authority of the Holy Priesthood to which we have been called in that they do not honor our baptisms and thus have deliberately chosen to cut themselves off from the true priesthood and yet have taken unto themselves this honor and thus expose themselves as false apostles and false teachers. Rev. 2:2 and II Cor. 11:13-16.

Therefore, Be it resolved that

1. The Church of Christ will no longer give that honor to those false priesthoods of the other Restoration churches which is due only to those of the Church of Christ, and

2. That, beginning with the passage of this resolution, baptisms performed by other churches of the Restoration will no longer be considered valid and binding, and

3. All those wishing to unite with the Church of Christ from any source whatsoever from this time forward will be required to be baptized by one having authority in the Church of Christ.

4. That the provisions of this resolution repeals all previous acts conflicting herewith.

Bro. John A. Sweem moved the previous question. Seconded by Bro. B. C. Flint. Carried by show of hands.

Vote was called on the motion to adpot the resolution on uniting with the Church, lost, 6 for, 23 against.

Consideration was resumed on Form No. 7-transter.

Bro. Wm. F. Anderson moved the adoption of Form No. 7 in harmony with the recommendation coming from the Quorum of Apostles. Seconded by Sr. Edna Smith.

Bro. Harvey Seibel, Sr., moved to amend Form No. 7 to add the word "endeavor" so that it would read "and endeavor to do all in my power . . ." Seconded by Bro. LeRoy Wheaton.

Bro. LeRoy Wheaton moved to amend the amendment by adding these words after where it says "support this gospel" add, "to abide by the articles of faith and practice." Seconded by Bro. Marvin M. Case.

The regular hour of adjournment arrived.

Bro. Marvin M. Case moved that we stay convened in conference until we take care of all business that needs to be taken care of. Seconded by Bro. LeRoy Wheaton.

Bro. Wm. F. Anderson moved as a substitute that we continue at least one hour and a half. Seconded by Bro. B. C. Flint. Carried by a show of hands.

Bro. Archie F. Bell moved the previous question on the amendment to the amendment and the amendment. Seconded. Carried by voice vote.

Vote was called on the amendment to the amendment, to abide by the Articles of Faith. Lost, 5 to approximately 25.

Vote was called on the amendment, to add the word "endeavor". Carried by show of hands.

Bro. Archie F. Bell moved to further amend Form No. 7 by striking out the word "elders" from "Recommended for acceptance by Elders," and strike out the numbers "1, 2 and 3;" and in the place thereof use three lines with the word "Elder" under two of them and the words "Missionary in charge" under the other line. Seconded by Bro. B. C. Flint.

Vote was called on the amendment regarding signatures. Carried by show of hands, unanimously.

Vote was called on the motion to adopt Form No. 7 as amended. Carried by show of hands with no opposition.

Bro. Don W. Housknecht moved to amend the instructions for Form No. 7, item No. 1 to read as follows: To be filled out and signed by applicant and two or more Elders, one of whom shall be the Missionary in Charge. Seconded by Bro. Harvey Seibel, Sr. Carried by show of hands.

Form No. 18 was considered.

Bro. LeRoy Wheaton moved the adoption of Form No. 18, the certificate of ordination, and that instead of an impression seal we have a printed seal. Seconded by Bro. Wm. F. Anderson.

Bro. B. C. Flint moved to amend the motion to adopt

April 7, 1960

by adding, "and that it read, 'Certificate issued by the officiating minister'." Seconded by Bro. Harvey Seibel, Sr.

Bro. LeRoy Wheaton moved, as a substitute for the whole matter, that we approve the certificate of ordination (Form No. 18) with the following changes: have a printed seal; that we strike out the words "issued by the General Church Recorder" and put in "The officiating minister"; and that this form be printed in a book with three forms on a page with perforations between so that the certificate of ordination with the seal would be given to the one ordained, and that the second copy without a seal be given to the General Church Recorder; and that the third copy without a seal be kept in the Book for a record; and that these three forms have a common serial number to be entered in the General Church Recorder's record. Seconded by Bro. B. C. Flint.

Vote was called on the substitute. Carried by a show of hands.

Form No. 23 was given consideration.

Bro. LeRoy Wheaton moved that we approve Form No. 23. Seconded by Bro. Archie F. Bell.

Bro. LeRoy Wheaton moved to amend the motion to adopt by adding, "and after the line 'date of birth' add 'Mother' and 'Father' with appropriate blank lines." Seconded by Bro. Archie F. Bell.

Bro. LeRoy Wheaton moved the previous question on the amendment and the motion to adopt. Seconded by Bro. B. C. Flint. Carried by show of hands.

Vote was called on the amendment to add "mother and father". Carried by a show of hands.

Vote was called on the motion to adopt Form No. 23 as amended. Carried by a show of hands.

Bro. LeRoy Wheaton moved to approve the instructions on Form No. 23 with the changes previously approved, calling in item No. 1 for "Baptismal Data" instead of "Items of Baptism." Seconded by Bro. Wm. F. Anderson. Carried by show of hands.

Instructions for Form No. 18 were given consideration.

Bro. LeRoy Wheaton moved that in the instructions to Form No. 18 we strike out all after the word "be" and change it so that will read "To be issued by the officiating minister"; and that we approve instructions on Form No. 18. Seconded by Bro. A. M. Smith. Carried by show of hands.

Form No. 24 was given consideration.

Bro. Wm. F. Anderson moved that we approve Form No. 24. Seconded by Bro. B. C. Flint. Carried by show of hands.

Bro. Wm. F. Anderson moved to adjourn to 10:00 A. M. tomorrow morning. Carried by show of hands.

Closing prayer by Bro. Wm. F. Anderson.

Minutes of the Conference, April 13, 1960 10:00 A. M. Session

Opening prayer by Apostle Leon A. Gould.

Scripture reading: Isaiah 53.

First reading was given a recommendation from the Council of Twelve relative to C. E. Irwin.

Instructions on Form No. 24 was given consideration.

Bro. Wm. A. Sheldon moved that we approve the instructions on Form No. 24 as published. Seconded by Bro. Ed. Podhola. Carried by show of hands.

Second reading was given the resignation of Bro. K. J. Smith from the Referendum Committee:

Council of Twelve Apostles

Church of Christ, Temple Lot

Greetings:

Whereas every man has an inherent right to his honesty and integrity and whereas the present rules governing the custody of the referendum votes of the church are interpreted by the present incumbent in the office of General Recorder as being her sole right to have and to hold and to direct the meeting of the referendum committee in the counting thereof: I hereby tender my resignation as a member of the Referendum Committee, to become effective immediately.

Bro. Clarence Thompson moved that we concur with Bro. K. J. Smith's request. Seconded by Bro. Marvin M. Case. Carried by show of hands.

The unexpired term of Bro. K. J. Smith remained to be filled.

Nomination: Bro. Forest Maley.

There being on further nominations the body voted by show of hands to accept Bro. Maley for the one year unexpired term.

Second reading was given the recommendation of the Council of Twelve relative to the organization of local churches.

Bro. Clarence Thompson moved that we not accept this matter to send it out to referendum. Seconded by Bro. Ed Podhola.

Bro. Harvey Seibel moved to amend the recommendation of the Twelve by deleting the words telling how much time necessary to give notice before a business meeting. Seconded by Bro. A. M. Smith.

Vote was called on this motion to amend. Lost.

Vote was called on the motion to not accept. Lost.

Bro. A. M. Smith moved that we approve the recommendation of the Quorum of Twelve on local church organization, and that it be sent out to referendum. Seconded by Bro. T. J. Jordan.

Bro. Forest Maley moved to amend the recommendation by adding to the last paragraph, "Should the pastor deem an emergency business meeting necessary, he may call such meeting with notice suitable to his own judgment." Seconded by Bro. A. M. Smith.

Vote was called on the amendment. Carried 23 to 1.

Bro. Marvin M. Case moved to further amend the recommendation by adding to paragraph No. 2, "In the event the Elder refuses to serve, a priest may be elected by the local church body." Seconded by Bro. Leon A. Gould. Carried by a show of hands.

Vote was called on the motion to approve the recommendation of the Twelve on local church organization, as amended, and to send to referendum. Carried 15 to 0, it being the vote of the ministry.

The recommendation of the Twelve on local church organization as adopted follows:

Page 86

To the General Conference Of the Church of Christ

April 8, 1960

Greetings:

The Council of Apostles recommends the adoption of the following to be sent out for referendum vote of the church:

Inasmuch as there is not a clear understanding concerning the organization of a local Church of Christ among our members,

Therefore, be it resolved

That a local Church of Christ shall consist of:

1. Six or more regularly baptized members, one of whom is an Elder.

2. A Pastor, who shall be the presiding official of the local. He shall be elected from among the Elders by the local church. In the event the Elder refuses to serve, a priest may be elected by the local church body.

3. A Secretary or Clerk, who shall take care of the secretarial work of the local church and keep its records.

4. A Treasurer, who shall be the financial agent for the local church.

Other officers and functional groups, such as a Sunday School, may be provided for as required.

There shall be a business meeting held at an agreed time, at least once a year. At this time, all officials of the local church shall be chosen by the vote of the members of the local. The Secretary, or Clerk, shall keep a full account of all business meetings in a record book.

A business meeting may be called at any time the local congregation may see fit, by giving at least two weeks notice of the meeting. Should the pastor deem an emergency business meeting necessary, he may call such meeting with notice suitable to his own judgment.

The following recommendations in reference to appointments were made and are presented to the conference for your consideration:

1. We recommend that Bishops Vance H. Harris and John A. Sweem be appointed to labor as representatives of the Bishopric as circumstances may permit.

2. We recommend that two Bishops go to Yucatan if circumstances permit.

3. We recommend that Apostle Leon A. Gould be given the equivalent of a regular allowance.

4. We recommend that \$10.00 per month Elder's

Expense be allowed Apostle Wm. F. Anderson as the Representative in the Office.

First reading was given the report of the United Workers.

Second reading and consideration was given a resolution relative to the manner of voting:

Bro. Harvey Seibel, Sr., moved that we accept this document on voting and send it out to referendum. Seconded by Bro. Harold Gill.

Bro. Nicholas F. Denham moved that we refer this resolution on voting to the next conference, to be the first order of business. Seconded by Bro. Clarence Thompson.

Bro. Harvey Seibel moved as a substitute that we put the resolution on voting into the hands of a committee of three to be studied until next conference, they to bring in a report and findings to be printed in Zion's Advocate two months prior to conference. Seconded by Bro. Rolland D. Sprague.

Vote on the substitute carried by a show of hands. The resolution on voting follows:

Resolution of an Amendment

To the By-Laws of the Church of Christ

Relative to the Manner of Voting Whereas, We are commanded, "Therefore this shall ye observe, and make it your law to do your business by the voice of the people," and note that it was not by the voice of the Elders. Mosiah 13:36, and

Whereas, The God of the farflung heavens declares, "All things shall be done by the common consent of the church, by much prayer and faith," Book of Commandments 27:3, and

Whereas, The founders of the Church of Christ understood the Elder's Conference to be composed of the whole church, see the history of the first nine conferences,

Therefore, be it resolved that,

First, All resolutions pertaining to the government of the General Church by the Conference (along with Conference-vote on the same) and all votes for officers and committees of the General Church with the exception of those resolutions, officers and committees specifically concerned with the functions of the General Conference of Ministers (for example, the Dining Hall and the Reception and Housing Committees) shall be submitted to a referendum vote of the whole church for ratification or rejection according to present procedures dileanted in the by-laws, with the following exception: Those attending the General Conference either favoring or opposing the resolutions submitted to referendum, may include, along with the ballot, reasons for their respective positions in order that the benefit of their study may be available for the consideration of the people in whose rule the affairs of the Church rests.

Yucatan School Committee Report

April 7, 1960 Independence, Missouri

The Council of Twelve Apostles The General Bishopric and the Church of Christ (Temple Lot) in Conference Assembled

Greetings:

The Independence, Missouri, Local Church wishes to report to the conference on a project which we have undertaken and to solicit help from all who are interested.

Several years ago the church by conference action approved the establishing of a school in Yucatan, but the lack of a definite plan of procedure seemed to cause this project to lag. Several months ago a letter from Bro. Fernando Ojeda was printed in the Advocate in which this project was mentioned. Soon after this at a business meeting this local selected a committee to formulate a program and to solicit funds to establish and maintain a school in Yucatan. A copy of the committee's recommendation is attached.

This report was approved by the local; we sent our recommendation to Bro. Fernando and the local at Ticul selected a committee to work with us. To date we have raised a little over \$100.00 toward this project.

We desire to work with the church and the General Bishopric on this project and hope that all who desire to help will send their funds to the General Bishopric to be made available to the committee in Yucatan for this school.

Local Church of Christ (Temple Lot) Independence, Missouri

Your committee, to solicit and raise funds to supply Fernando with his needs concerning the establishing of an elementary and trade school (in Yucatan) and to recommend a program of the needs, reports as follows:

We met January 1, 1960, and listened to a taped report and discussion by Fernando with the Bishops and also a tape Fernando made for Glenn Gill. We also talked to Glenn at length on the conditions he found during his month's stay in Yucatan this fall.

We find that they have good elementary and high schools, but no trade schools. They teach English in high school but not in elementary school. All schools require that they buy their own books. Many cannot afford books therefore are not able to get an education.

We recommend that:

1. No elementary school be instituted at present but that funds be raised to buy books to be made available to those who need help both in elementary and high school. First those in the church and then all that can be supplied. We recommend that these books be the property of a board and loaned to students so they may be used year after year.

2. That the English classes now being conducted be continued for both children and adults and that funds be raised to supply texts, helps and a building as needed to expand this project.

3. That a trade school be set up with classes in various trades which can be taught by members or others that may be available to give their time. That funds be raised to rent or build a modest building for such a school. We recommend that such a school could have at the start such trades as:

(1) Weaving (now being done)

- (2) Shoe making (Fernando's trade)
- (3) Carpentry, cabinet and furniture making (there is a young carpenter available in Yucatan, a Bro. Raul)
- (4) Tailor (have one as a member)
- (5) Baker (Cayetano)
- (6) Hats

(7) Mechanics

(8) Accounting (Fernando planning to take course)

- (9) Stone Masonry
- (10) Jewelry

We also recommend that the present committee be supplemented by a committee of three from Yucatan, Fernando being one of this committee. The committee from Yucatan and their successors would be a board to hold all property and equipment in their name as a trust, so it would not revert to the state, and to act as the school administrators. That these two committees work as far as possible with the General Bishopric who have already authorized Fernando's purchase of a piece of ground for a school site.

We recommend that the Bishopric be advised of our plan and that we immediately contact Fernando to ascertain the exact needs and that we proceed to raise funds by subscription, dinners, sales, etc., in this local and through the Bishopric, throughout the whole church.

We set forth that the purpose of this school is to raise the standard of living by becoming skilled in useful occupations which will be near at home so that they can become self-supporting and devote more time and means to spreading the gospel. That the teaching of English is missionary as it brings children and their families into contact with the church and the Gospel it teaches.

Ministerial Report of Apostle Leon A. Gould

April 1, 1960

Apostle Wm. Sheldon, Secretary Council of Twelve Dear Brother,

In giving an account of my work for the conference year just ended I submit first the statistical, although I am aware that some frown upon the custom, and would prefer a brilliant mirage of great things for the future—but I note a peculiar tendency for the mirage to lose its brilliancy before the end of the year. During the past year, I have preached 23 times, been in charge 16 times, and assisted 24 times, attended 114 other services, making a total of 178 meetings attended. Have confirmed 2, assisted to confirm 1, blessed 4 children, administered to the sick 39 times, and made 52 house to house calls.

After conference, Apostle Housknecht took me to Bemidji in his car, where we met with the local, and visited the saints remaining in the Blackduck area. After a short visit Bro. Housknecht returned to his home, and after loading up the things needful for me to bring I returned to Independence to take up the work assigned me here, and spent the time from the middle of May until the latter part of August in an intensive search of the records for the minutes and conference actions that have brought us to the present time from 1925. In the formative years of 1925, 26, and 27 it seemed needful to include much of the routine actions that will enter into the history of that period. After that all routine matters, and actions that were completed within each conference session, and pertaining solely to those sessions have not been included in this compilation; but only those that were carried forward to future conferences or that pertained to the future work of the Church have been included in this compilation.

Some resolutions I was not able to find, as for example: "Moved and seconded as follows (See Resolution Book p. so and so). Carried." Some of them were in the resolution book as indicated; and then the pages were blank, not even numbered—possibly the numbered ones had been removed for some purpose, and not put back.

Should the compilation be published, it should be needful to delete some from the manuscript, to modify some perhaps, and to add others, if they can be found.

Bro. Smith brought his Ditto Machine up, and it was decided to mimeograph the document, and after the Holidays I began making the master copies of the 139 pages, plus six pages of index, and running them through the Ditto machine, sufficient for 50 copies of the document, then stapling them together for reference, completing the job about the middle of March.

After completing the first draft of the minutes the latter part of August, I attended the Wisconsin Reunion at Lima Center, which was one of the best reunions I ever attended; from there went to Milwaukee with my daughter Helen, preaching one sermon in her home, then to Muskegon, Michigan, visiting old friends in that area, and after the middle of September joined Bro. Housknecht in missionary work, first in northern Michigan, then in southern areas, then turning westward we traveled through Colorado, New Mexico and Arizona, visiting the locals and assisting where we could; then westward to the coast to contact the isolated members so far as we could from San Diego to Portland, then eastward to Idaho and Montana, and finally to Viceroy, Canada, thence to Bemidji and back to Independence by December 14.

Looking at the situation in general, we would say that the enticements and encroachments of the world have combined to hinder the spiritual advancement that is a prime requisite, if we are to be successful in meeting the demands of the hour for the advancement of the cause of Christ and the redemption of Zion. To this end we are admonished by the beloved disciple:

"Love not the world, neither the things that are in the world. If any man love the world, the love of the Father is not in him. For all that is in the world, the lust of the flesh, and the lust of the eyes, and the pride of life, is not of the Father, but is of the world. And the world passeth away, and the lust thereof: but he that doeth the will of God abideth for ever."—I John 2:15-17. To this end let us labor and pray.

We cannot give you the miles traveled. We feel that is no consequence. We feel it is sufficient to say that we were treated kindly wherever we stayed and were well provided for in our travels over our field.

It was passed that, "Since the onetenth collection from the local Sunday Schools has been sufficient to warrant it, that we send materials published by the General Sunday School free to local Sunday Schools desiring it. We hope the donations will continue so this practice may grow." This resolution was offered in hope that with the easy availability of Sunday School material, there would be more interest shown and more requests for the materials on hand. They are at the printers now and should be completed shortly. These books are in a loose-leaf binder style and will have a filler for each year. The officers must cooperate with each individual and each individual in turn must cooperate with the officers for any good to be accomplished.
