# EDITORIAL

Several times when matters of grave importance, and seemingly unsolvable, were being considered in Council chambers, the waiting assembly met in prayer to implore the Spirit of God to be with those deliberating, and to pray for His will to triumph. We feel that these prayers and the myriad prayers offered by the people at home during the Conference, were answered, and that the Church has taken a great stride forward, for the united efforts of the Twelve and

the Joint Council brought forth recommendations which were accepted by an overwhelming majority vote of the people present.

We also wish to tell you of the brotherly feeling exhibited throughout the Conference that contributed to its success. # Minutes of April 6, 1962-10:00 A. M. Session

Meeting opened at 10:12 A. M. with Bro. Archie F. Bell in charge, assisted by Bro. Leon Yates. Opening song No. 190 "Redeemer of Israel." Opening prayer by Bro. Leon Yates. Second song No. 272, "Jesus My Shepherd."

General Conference was declared opened and a greeting was given by the Chair.

Bro. Isaac Brockman moved that we have the Council of Twelve Apostles preside at the Conference as always. Seconded by Bro. Kenneth Smith.

Bro. Nicholas Denham moved to amend the motion by inserting the word "entire" before "Council of Twelve Apostles." Seconded by Bro. Denver Chapman

Bro. Tom Barton, Sr., moved to amend the amendment by adding "Those who are eligible." Seconded by Bro. Isaac Brockman.

Bro. Richard A. Wheaton moved as a substitute for the whole matter that all members who have been ordained to the office of Apostle shall preside in their rightful order over conference and that all Quorum sessions throughout this conference shall be held in the Quorum room and any meeting or caucus which shall be held without full representation of each member qualified as above shall be declared null and void. Seconded by Bro. Rolland Sprague.

The chair ruled the substitution for the whole matter out-of-order and extended the privilege to Bro. Wheaton to re-phrase the motion to make it in order.

After some discussion Bro. Richard A. Wheaton moved as a substitute for the whole matter that all members who have been ordained to the office of Apostle shall preside in their rightful order over conference. Seconded by Bro. Rolland D. Sprague.

Bro. Tom Barton, Sr., moved to amend by adding "All qualified." Seconded by Bro. Isaac Brockman.

Chair ruled the amendment out-of-order.

Bro. William F. Anderson moved the previous question on the whole matter. Seconded by Bro. LeRoy Wheaton. Previous question on the whole matter carried—41 for, 6 against.

The substitue for the whole matter carried—29 for, 27 against.

#### INVESTIGATION COMMISSION REPORT:

Independence, Missouri November 19, 1960

Apostle William A. Sheldon Officer in charge of the case of The Church of Christ vs. Clarence L. Wheaton Dear Brother:

As the commission appointed to investigate matters pertaining to the Church of Christ vs. Clarence L. Wheaton, we wish to report that we have had meetings on November 18th and 19th, hearing statements from Bro. E. L. Yates for the church, being appointed agent by the Council of Apostles, and from Clarence L. Wheaton with Brethren Richard A. Wheaton and James M. Case as his counselors.

We wish to report our findings pertinent to paragraph  $10\ \mathrm{of}$  the Jurisprudence:

- (a) The charges are properly prepared in writing. Reference, copy of the charges dated November 16 over the signature of Brc. E. L. Yates.
- (b) Based on evidence presented to the commission, labor has been performed so far as possible. Second labor was attempted but was rejected by the defendant who asserted that it was illegal.
- (c) Our interview with the parties to the case causes us to feel that there is a possibility that further labor may be fruitful toward reconciliation since there seems to be a small common ground between the statements made to us. To wit: the defendant offers to accede to the terms of reconciliation upon being shown conclusive evidence that he was officially informed of the will of the conference before taking the action of which complaint was made.
- (d) Temporary silence was imposed by letter of July 18, 1960. We feel recommendation on this point by the commission would be superfluous.
- (e) Temporary silence covers any restriction of membership privileges applicable in the charges as filed.
- (f) Due to the conflicts related to the facts of this case as is aparent in the mass of material presented to us in affirmative statements, and in the event further labor as recommended in paragraph (c) above does not affect a reconciliation, it appears that the spiritual welfare of both parties and the church will be better served by having this heard and adjusted by an Elders' Court and we so recommend.

#### ELDERS' COURT DECISION:

Decision of the Elders' Court
In the Case
of

The Church of Christ vs. Clarence L. Wheaton December 11, 1960

We, the members of the Elders' Court of the Church of Christ (Temple Lot), after prayerful consideration, do render the following decision:

- 1. The Court finds Brother Clarence L. Wheaton guilty of un-Christianlike condct toward his brothers in the Quorum of Twelve: to wit; spreading malicious gossip throughout the church, and using language unbecoming a minister of the Gospel called and ordained by God; some examples of which are: "I shall ignore this foolish act." "Attempt to impose unlawful silence," "This ungodly action," "Having been dealt with so treacherously," and "A wicked and unlawful course of procedure." Therefore this Elders' Court counsels Apostle Clarence L. Wheaton to restrain his remarks from this time forward and curb the spirit of belligerency which brought forth these statements: for, out of the heart the mouth speaketh.
- 2. This Elders' Court orders Apostle Clarence L. Wheaton to discontinue any efforts to bring charges arising out of this case against any member of the Church of Christ (Temple Lot). Any breach of this order automatically opens the charge of insubordination against Apostle Clarence L. Wheaton.
- 3. This Elders' Court does not find Apostle Clarence L. Wheaton guilty of the charge of insubordination to the Conference of the Church of Christ, nor to the Quorum of Apostles as the charge was not sustained by rigorous and conclusive proof. Implications and suggestions are insufficient evidence to condemn a brother.
- 4. This Elders' Court counsels the complainant and the defendant to continue in brotherly love and the work of the Lord as if this difficulty had never arisen.
- 5. This Elders' Court counsels the conference and the agents thereof to be more explicit in the future instructions to the missionaries lest the work of the kingdom be hindered.

#### BISHOPS' COURT DECISION:

Bishops' Court of Appeal Decision

In the Case of

E. L. Yates, Agent for the Council of Apostles, Complainant

vs.

Clarence L. Wheaton, Sr., Defendant (and also stated as)
The Church of Christ vs. Clarence L. Wheaton, Sr.

We, the members of the Bishops' Court, appointed to review the evidence and the decision of the Elders' Court in the above captioned case, said decision of the Elders' Court being appealed from by the defendant, do hereby render a decision after prayerful and careful consideration and examination of the records of this case.

- l. The Elders' Court found Clarence L. Wheaton, Sr., not guilty of the charge of insubordination to the conference of the Church of Christ, or to the Quorum of Apostles, which charge was made by E. L. Yates, agent for the Council of Apostles. The Bishops' Court sustains this decision.
- 2. The Elders' Court found Clarence L. Wheaton, Sr., guilty of unchristianlike conduct toward his brothers in the Quorum of Twelve. The records of this case do not show or even indicate in the evidence presented that there was ever any charge of unchristianlike conduct, other than insubordination, filed against Clarence L. Wheaton, Sr. Therefore, the Bishops' Court finds it necessary to reverse the decision of the Elders' Court, on this point, and finds Clarence L. Wheaton, Sr., not guilty of unchristianlike conduct toward his brethern of the Quorum of Twelve.
- 3. The Elders' Court also make the following decision: "This Elders' Court orders Apostle Clarence L. Wheaton to discontinue any efforts to bring charges arising out of this case against any member of the Church of Christ (Temple Lot). Any breach of this order automatically opens the charge of insubordination against Apostle Clarence L. Wheaton,"

The Elders' Court erred in making this order and threat inasmuch as an Elder's Court has no authority to restrict any member from bringing charges against any other member of the church so long as such charges are legally brought before the proper authorities

according to the procedure as outlined in the Jurisprudence of the Church of Christ, and as shown by the Scriptures, therefore, the Bishops' Court finds it necessary to revoke this order and to declare it to be of none effect.

- 4. This Bishops' Court feels that, due to the many irregularities and improper procedures that were followed in this case, an opinion should be written concerning this case pointing out such irregularities and improper procedure followed in the prosecution of this case in order that, in future cases, justice might be served and that the rights of each and every member of the Church of Christ might be secured.
- 5. The Bishops' Court wishes to point out that either the complainant or the defendant may appeal from the decision of this court to a Court of Last Appeal as provided for in paragraphs 23 and 50 of the Jurisprudence of the Church of Christ.

#### APPEAL FROM BRO. E. L. YATES:

April 10, 1961

I am appealing to the Conference to appoint a committee of three Elders to investigate the validity of the Bishops' Court of Appeal in the case of, Church of Christ (Temple Lot), Complainant Versus Clarence L. Wheaton, Sr., Defendant, for the following reas-

1. The Title of the case as tried by the Elders' Court was, "Church of Christ (Temple Lot), vs. Clarence L. Wheaton, Sr." This title was approved by the Investigation Commission and accepted by the Elders' Court. See Investigation Commission Report under date of November 19, 1960. Also Title Page of the Elders' Court Record under date of December 10, 1960. The Bishops' Court changed this accepted title to "E. L. Yates, Agent for the Council of Apostles, Complainant Vs. Clarence L. Wheaton, Sr., Defendant (and also stated as) The Church of Christ vs. Clarence L. Wheaton, Sr."

I affirm that the changing of the accepted title in any way is over and beyond the authority of the Bishops' Court.

- 2. The Bishops' Court was appointed by the General Bishopric. Whereas, it should have been appointed by the Council of Twelve according to Article 8 of the Jurisprudence.
- 3. The minutes of the Elders' Court are not complete. This is verified by the Secretary of the Elders' Court as found on page 138 of the Court minutes. Much of the evidence presented to the Court by the Complainant was entered after this point in the Court proceedings.
- 4. The Complainant was not notified of the time or place of the holding of the Bishops' Court, as should have been done in accord with Section 37 of Jurisprudence.
- 5. The Bishops' Court was supposed to rehear the case as is provided in Article 43 and Form 19. This they did not do.
- 6. The Court of Elders did not send the Officer in Charge a certified copy of a full and complete record of the proceedings of the Court, as provided for in Form No. 12 in Jurisprudence.

I recommend to the Conference that this committee be instructed to contact the Defendant, the Complainant and the Chairman of the Bishops' Court separately.

#### REPORT FROM THE COUNCIL OF APOSTLES:

In order to acquaint the Church of our actions during the past conference year, in regard to a committee report, we, the Council of Apostles, do hereby submit the following:

At the close of the April, 1961 conference of the Church, there was a report from a committee, appointed by the Conference, in the hands of the chairman of the last session, and upon which no action was taken.

The appointment of the committee came as a result of an appeal submitted by Apostle E. L. Yates to the April 10, 1961, 10:00 A. M. session, as follows:

"I am appealing to the Conference to appoint a committee of three Elders to investigate the validity of the Boishops' Court of Appeal in the case of the Church of Christ (Temple Lot), Complainant, versus Clarence L. Wheaton, Sr., Defendant, for the following reasons:

"The Title of the case as tried by the Elders' Court was, 'The Church of Christ (Temple Lot), vs. Clarence L. Wheaton, Sr.'. This Title was approved by the Investigation Commission and accepted by the Elders' Court. See Investigation Commission report under date of November 19, 1960. Also Title page of the Elders' Court record under date of December 10, 1960. The Bishops' Court changed this accepted title to, 'E. L. Yates, Agent for the Council of Apostles, Complainant vs. Clarence L. Wheaton, Sr., Defendant (and also stated as) The Church of Christ vs. Clarence L. Wheaton, Sr.'

- $^{\prime\prime}$ 1. I affirm that the changing of the acceped title in any way is over and above the authority of the Bishops' Court.
- "2. The Bishops' Court was appointed by the General Bishopric. whereas it should have been appointed by the Council of Twelve according to Article 8, of the Jurisprudence.
- "3. The Minutes of the Elders' Court are not complete. This is verified by the Secretary of the Elders' Court as found on page 138, of the Court Minutes. Much of the evidence presented to the Court by the Complainant, was entered after this period in the Court procedings.
- "4. The Complainant was not notified of the time or place of the holding of the Bishops' Court, as should have been done, in accord with Section 37, of the Jurisprudence.
- $^{\prime\prime}5.$  The Bishops' Court was supposed to rehear the case, as is provided in Article 43, and Form 19, of the Jurisprudence. This they did not do.
- "6. The Court of Elders' did not send the Officer in Charge  $\alpha$  certified copy of  $\alpha$  full and complete record of the proceeding of the Court, as provided in Form 12, in Jurisprudence.

"I recommend to the Conference that this committee be instructed to contact the Defendant, the Complainant and the Chairman of the Bishops' Court, separately. Respectfully, your brother in Christ, E. L. Yates."

The above appeal was given its first reading at the 10:00 A. M. session, April 10. It was approved and the recommendations were concurred in at the 10:00 A. M. session, April 12. A committee consisting of Brethren Joe Kidd, Ray Hunholz and Barney Wentworth was appointed by the Conference.

This committee had completed their investigation and their report was in the hand of the Chairman of the 10:00 A.M. session of the Conference, April 13. The Conference adjourned about 11:00 A. M., for the year 1961. The report of this committee was never

read before the Conference before it adjourned, therefore it could not have been acted upon by it.

Following the close of the Conference, a quorum of the Apostles met to consider what should be done about the report made by the committee appointed to investigate the validity of the Bishops' Court, above mentioned.

Before any action was taken, this Quorum considered its authority to act on this matter. It decided that the Council not only had authority to act on it, but was duty bound to the church to do so. We will quote from the different references that were considered:

- 1. Article of Faith and Practice of the Church of Christ, Article 13. "We believe in the same church organization as existed in the time of Christ and His Apostles. The highest office in the church is that of an Apostle, of whom there are twelve, who constitute special witnesses for Jesus Christ. They have the missionary supervision and the general watchcare of all the churches."
- 2. The report of the Conference of 1927 as appears in the May issue of The Zion's Advocate of that year, An Opinion Adopted by the Quorum of Twelve, was approved by the Conference. In this opinion is written the following Article 5 and Article 6:

"That the general church is created and functions for the purpose of preaching the gospel of Jesus Christ to every nation, kindred, tongue and people, and establishing Christian Assemblies everywhere; and to promulgate a uniform system of teaching and practice of those virtues and ideals set forth in the word of God and confirmed by the Holy Spirit,

"That in order to accomplish this object on earth, God has placed in the Church immediately under the direction of Jesus Christ and the Holy Spirit, the Quorum of Twelve Apostles, who have the general oversight and watchcare of all the churches; and in case of sedition and apostasy from the faith, to regulate or set in order as they may be directed by the word of God and the Holy Ghost."

The Conference Minutes for April, 1932, 2:00 P. M. session, contains a resolution which was unanimously carried. This resolution was entitled, "Defining of Duties and Prerogatives of the Twelve." In articles 1, and 2 of this is written these instructions:

- "1. The Quorum of Twelve is a body of ministers called Apostles, ordained of God and set in the Church to preach the gospel, set in order and establish the Church of Christ in all the world—the supervising authority and general watchcare of all the churches being resident within this collective body of ministers.
- "2. A majority of seven constitutes a working quorum whose unanimous decision is binding in the interim between conferences."

After due consideration, the Quorum decided to approve the report of the conference appointed investigating committee and concur in their recommendation. The following letter was approved by quorum action and sent to Brethren Wheaton and Yates.

April 17, 1961:

"In the report of the investigating committee appointed to determine the validity of the Bishops' Court of Appeal in the case of "Church of Christ (Temple Lot), Complainant, versus Clarence L. Wheaton, Sr., Defendant," we find this language:

"'Whereas sufficient evidence has been examined by the committee herein referred, and said evidence has been found to be overwhelming to the extent that our conclusion is that the Bishops' Court of Appeal was entirely illegal and consequently invalid and therefore not binding.

"'This committee recommends that the only way in which justice can be rendered to all concerned, would be to call for a rehearing of the Elders' Court'."

"The Council of Apostles has approved of this committee's report and concurs in their recommendation. We therefore notify you that the Bishop's Court of Appeal which sat on the case of Church of Christ (Temple Lot), versus Clarence L. Wheaton, Sr., Defendant, is hereby declared illegal, and invalid and none of their decisions binding.

"Be advised that if an appeal is desired by either the Defendant or the Complainant, it will be necessary to file for a new trial within sixty (60) days of the date of this notice or else this

case shall remain in the status of the decision of the first Elders' Court."

We are including a copy of the Decision of the Elders' Court for information purposes,

"Decision of the Elders' Court in the Case of The Church of Christ vs. Clarence L. Wheaton, December 11, 1960.

We, the members of the Elders' Court of the Church of Christ (Temple Lot), after prayerful consideration, do render the following decision:

- "1. The Court finds Brother Clarence L. Wheaton guilty of un-Christianlike conduct toward his brothers in the Quorum of Twelve; to wit; spreading malicious gossip throughout the church, and using language unbecoming a minister of the gospel called and ordained of God: some samples of which are: "I shall ignore this foolish act," 'attempt to impose unlawful silence,' this ungodly action,' having been dealt with so treacherously." Therefore this Elders' Court counsels Apostle Clarence L. Wheaton to restrain his remarks from this time forward and curb the spirit of belligerency which brought forth these statements: for, out of the heart the mouth speaketh.
- "2. This Elders' Court orders Apostle Clarence L. Wheaton to discontine any efforts to bring charges arising out of this case against any member of the Church of Christ (Temple Lot). Any breach of this order automatically opens the charge of insubordination against Apostle Clarence L. Wheaton.
- "3. This Elders' Court does not find Apostle Clarence L. Wheaton guilty of the charge of insubordination to the conference of the Church of Christ, nor to the Quorum of Apostles; as this charge was not sustained by rigorous and conclusive proof. Implications and suggestions are insufficient evidence to condemn a brother.
- "4. This Elders' Court counsels the complainant and the defendant to continue in brotherly love and the work of the Lord as if this difficulty had never arisen.
- "5. This Elders' Court counsels the conference and the agents thereof to be more explicit in future instructions to the missionaries lest the work of the kingdom be hindered."

"Signed, Elder M. Harvey Seibel, Chairman, Elder Eugene Gould, Elder David S. Hinkle."

An answer to the letter sent to Brethren Wheaton and Yates was received from Brother Wheaton under date of May 2, 1961, in which the following expressions were made by him protesting the Council's action in this matter.

"It will also be noted that this Conference did not at any time vote to delegate to the Council of Twelve the right to take this report from the table, nor for them to take up any unfinished business. Therefore, your action of April 17, 1961, is null and void and has no bearing whatsoever in this case. The only valid action that now stands, and which will be recognized by myself as the Defendant in this case, is that of the Appellate Court of the Bishopric, which Court, according to our Jurisprudence, was properly constituted, whose decision must stand until overthrown by properly constituted Court of Last Appeals."

Two members of the Court appointed by the Bishopric, Vance H. Harris and Nicholas F. Denham, wrote a letter of protest to the Council concerning the action taken by that body. This letter was dated April 29, 1961, and was received June 7, 1961. We are quoting from their letter:

"We hereby register a protest to the action taken by the Council for the following reasons:  $\label{eq:control}$ 

- "1. The committee was an instrument of the Conference of the Ministry appointed by said Conference and instructed to report back to that body.
- "2. The Conference of the Ministry adjourned before the report of said committee had been received and acted upon by the body which created it. The recommendation of the Committee died with the adjournment of Conference according to Roberts Rules of Order, paragraph 17, Section C.
- $^{\prime\prime}$ 3. The Council would have no authority to act upon the committee report under the above conditions. $^{\prime\prime}$

Under date of June 22, 1961, a letter of protest was received

from ten members of the priesthood of the local church on the Temple Lot. We will quote part of their reasons for the protest.

"4. Robert's Rules of Order, 75th Edition, Copyright 1951, page 64. paragraph 17c shows that business unfinished at the adjournment of the Conference is ended until next year's Conference. We feel that this rule, in particular, has been violated by the action of the Council of Twelve.

"In view of these points, we respectfully request the Council of Apostles to reverse and void any action they may have taken with regard to this committee report."

Under date of October 31, 1961, a letter was sent by the Secretary of the Council to the Secretary of the Bishopric, stating the reason the Council of Apostles had taken the post-conference action on this matter. A similar letter dated November 1, 1961, was sent to Elder Rolland D. Sprague, Pastor of the Temple Lot, Independence local church, to be read before the ten members of the priesthood of that local who had signed their letter of protest.

We feel that we as a Council have acted in harmony with the duties and prerogatives of the Twelve as outlined and approved by Conference actions of previous years. We therefore respectfully submit this report.

Be it resolved that inasmuch as the Council of Twelve has come to the combined opinion that Apostle Clarence L. Wheaton, one of their members, has erred in his conduct as a minster of Christ, as evidenced by correspondence, documented incidents in its files, and the Elders' Court record convened under date of December 11, 1960, in the case involving him, that he be required, based on his stated desire to repent of any error committed, to present in published form to all members of this Church affected, either individually or as a body, a full retraction of all such material; And that a probationary period be established for a one-year period from this date to sufficiently establish the fact that repentance has truly been consummated, and that any further infraction of unchristianlike conduct referring to this case shall be sufficient grounds for initiating new charges based upon such new evidence; And be it further resolved that any letters or material containing derogatory material initiated by any other member of the Council of Twelve related to this case brought to trial, be retracted through appropriate means to be determined by the Council of Twelve, with copies of all retractions by any individual involved to be filed in the records of the Council of Twelve as evidence that such has been accomplished.

Bro. Thomas E. Barton, Sr., moved that we receive the reports and that we approve the committee report and the Council of Twelve's report on the Bro. Clarence L. Wheaton Court case. Seconded by Sr. Doris Sheldon.

Bro. Harold B. Schultz moved as a substitute as follows:

Whereas a great deal of time and money has been expended, and a great deal of hatred has been generated among our membership by reason of the charges brought against Apostle C. L. Wheaton.

And whereas; Brother Wheaton has been found not guilty of the charae which was brought against him,

And whereas; we have grown weary of the delays which have occurred on the handling of this matter, which in itself is not in accordance with Christian practice,

Be it resloved that it is the decision of this Conference of the Church of Christ (Temple Lot) now convened that all present charges against Apostle C. L. Wheaton be declared null and void, and that he be restored with full rights to his position in the Quarum of Twelve.

Seconded by Bro. Ray Bryant.

Bro. Thomas E. Barton, Sr., moved as an incidental motion that the vote on this matter be voted on not later than 11:50 A. M., April 10, 1962. Seconded by Bro. M. Harvey Seibel. Carried by show of hands.

Bro. Arthur G. Smith moved the previous question on motion submitted by Bro. Harold B. Schultz. Seconded by Bro. Isaac Brockman. Carried.

Vote on Bro. Harold B. Schutlz's motion which lost 22 for, against 45.

Bro. LeRoy Wheaton moved to amend the motion to receive the reports and approve the Committee Report and the Council of Twelve's report by striking out the words "and the Council of Twelve's report. Seconded by Bro. Nicholas F. Denham.

The amendment carried—for 38, against 28.

The motion as amended—"Move that we receive the reports and that we approve the Committee Report on the Bro. Clarence L. Wheaton court case."—carried by show of hands."

Bro. William F. Anderson moved that Bro. Clarence L. Wheaton be given the privilege of withdrawing his motion to refer the tentative program back to the Quorum of Twelve. Seconded by Bro. Richard A. Wheaton. Carried.

Bro. Richard A. Wheaton moved we adjourn until 10:00 A. M. tomorrow morning and that there be song service at 7:30 P. M., preaching at 8:00 P. M., and prayer service at 8:00 A. M. tomorrow. Seconded by Bro. William F. Anderson.

Bro. Archie Bell moved to amend by adding that the services be arranged for by the chair. Seconded by Bro. William F. Anderson. Carried.

Closing song No. 14, "Praise God From Whom All Blessings Flow."

Dismissed by Bro. William F. Anderson.

#### Minutes of April 10, 1962—10:00 A. M. Session

Meeting opened at 10:00 A. M. with Bro. William F. Anderson in charge, assisted by Bro. Leon Gould. Opening song No. 88, "Come Gracious Lord." Opening prayer by Bro. T. J. Jordan. Second song No. 300, "Thou Must Be True."

To the Apostles and Conference Assembled,

Insubmitting my report for the year just closed, I do not have as much to report as last year as to visitors calling.

During the year there were two hundred and thirty visitors, the greatest number being folks from the west, mostly they who were journeying to or returning from seeing the pagent that is put on at the Hill Cumorah each year, during the later part of August. Mostly they were in busloads, and would come in and find seats in the dining hall and asked me to tell them our version of the Restoration, and why the difference. I was enabled to take them back through the years, and start with the early revelations, and endeavored to point out to them that there was a failure to follow the instructions as given by the Lord as to the setting up of the church, auoting to them the instructions as given, and how instead of doing as Lord told them to choose apostles they chose other officials and placed them ahead of the apostles in direct opposition to the scripture that they were to rely on. I was surprised to find that many at least did not know these things.

I am of the opinion that retaining a representative here is a very good plan, and if the revelation given through Brother Wheaton in 1919 be true the Lord referred to the various groups of the Restoration as being branches of his church, and that we should not contend with them over points of doctrine, and that when he came he would instruct them in doctrine and theory. I have found the folks who came through from the west to be open minded and tolerant and friendly, willing to concede that there might have been mistakes made along the line, and hoping for the time when there would be a clearing away of the mists of misunderstanding that now exists.

With the groups that passed through were some college professors. They too expressed thanks for what we offered.

There were a few from the Reorganized Church but not many, and they were not as liberal minded, but definitely grounded in the idea that they and they alone held the key to Eternal Salvation. Oh, there were some exceptions who were willing to listen, and

There were some few called that were of other churches, but did not exhibit any interest in that which is referred to as the Restoration of the gospel, more curiosity seekers.

We were able to sell around ninety dollars worth of books during the year, and handed out a number of tracts, keeping no record of the number handed out.

As for actual pulpit sermons, I do not have a great many to report. In August I was called to care for the funeral of Brother Fred DeLong, and September I went to Denver, Colorado to care for the funeral of Sister Barton. Meeting the Ely folks there, they asked me to return home with them for a few days, which I did. There I met Brother and Sister Bell, and Brother Bell and I held a week's meetings, after which he went to Denver and I returned home.

During the latter part of October I was asked to go to Columbus, Ohio which I did and was there over two Sundays.

I preached nineteen sermons, had charge of twenty-four services. Assisted thirteen times, and attended one hundred and fortytwo meetings, up till March 22nd, 1962.
