EDITORIAL

The first recorded communication from God to man, was a question: "Where Art Thou?" (Gen. 3:9). It is significant that this question came following the disobedient acts of mankind and their futile effort to hide this disobedience. The question could have been: "What have you done?" for in the all-seeing eye of God, nothing is hid. or nothing secret, and every thought and deed is an open record before him.

This is still the main question being asked of man: "Where art thou?" 'and it denotes a separation of man from God by disobedience, a separation not of God's seeking nor to his liking, but of man's doing. It is a separation that through the ages God has been offering to close. God's voice speaking through the silvertongued prophet, Isaiah, echoes through the years: "Seek ye the Lord while he may be found, call ye upon him while he is near; Let the wicked forsake his way, and the unrighteous man his thoughts: and let him return unto the Lord, and he will have mercy upon him; and to our God, for he will abundantly pardon." (Isa. 55:6-7). Time and time again this offer has been repeated, entreating man's return to God.

Today in the complex life of (so-called) civilized man, the question, "where art thou?" takes on a deeper meaning. Where are you today? Where do you stand? To what do you give active support? To what do you give "silent" consent? Benjamin Franklin once said: "Just as we must give an accounting for every idle word, so must we for ever idle silence." To what degree of honesty do you hold? The highest? The leasi? Or some where in between? Man is being tried by the same standard of perfection as always-God's yardstick never varies. Merely because there are more decisions to be made, this does not excuse us from the test. When the retarding, degrading influences that surround us, touch our lives or the lives of those who look to us for guidance, where do we $^{\mathrm{sc}}$ rtand? How many traffic laws do we observe when know we won't be caught?

The world today is the work of man. The world tomorrow will be no different if man remains the same. What can you do to improve it? You can make your influence be felt for good wherever life may find you. You can measure your own reactions to falsehood, dishonesty, unkindness, tale-bearing, hate, envy, jealously, selfishness and strife by this golden yardstick of Christ: "And as ye would that men should do to you, do ye also to them likewise." Luke 6:31.

Only when we are separated from God will He ask: "Where art thou?" The sheep in the fold are safe. How much distance are we putting between ourselves and God by our willful disobedience? How far have we wandered? Can we still hear when God calls us by name and asks: "Where art thou?" For you can be sure that:

"To every man there openeth A way, and Ways, and a Way. And the High Soul climbs the High Way And the Low Soul gropes the Low; And in between on the misty flats,

The rest drift to and fro. But to every man there openeth A High Way and a Low, And every man decideth The way his Soul should go."

(Editor's Note: This is June, the month of marriages, so what could be more appropriate than to refresh our own minds and to tell others, what our church teaches concerning marriage? So we reprint from the Advocate for January 1950 the following.)

WHAT THE CHURCH OF CHRIST TEACHES CONCERNING MARRIAGE

Because of our belief in the Book of Mormon we are often confused with the Latter Day Saints in Utah, and reproached with the crime of polygamy and other related false doctrines, which the uninformed, ignorant and prejudiced religionist allege is taught in the Book of Mormon, in an effort to confuse, bias and discourage the earnest investigator of the latter-day Restoration message.

This Church of Christ, which was founded by divine direction of God to Joseph Smith, Jr., in Fayette, Seneca County, New York, in 1830, has never taught polygamy, neither believed in nor practiced it, nor been associated with any organization which has or does teach it. We believe the teaching and practice of such a doctrine is a crime against God and the state, and out of harmony with the plain teachings of the Bible and the Book of Mormon, as well as the inspired revelations of God to this Church of Christ in these last days. We therefore invite all men everywhere to correctly represent this matter regardless of what their religious persuasions might be. Therefore, in answer to the oftrepeated inquiry as to our beliefs on this subject, and as to what the Book of Mormon has to say, we present this brief resume for your consideration.

1. The following statement from the revelations given by the Lord through Joseph Smith, Jr., in March, 1831, says: "And again, I say unto you, that whoso forbiddeth to marry, is not ordained of God, FOR MARRIAGE IS ORDAINED OF GOD TO MAN:

"WHEREFORE IT IS LAWFUL THAT HE SHOULD HAVE ONE WIFE, AND THEY TWAIN, SHALL BE ONE FLESH, and all this that the earth might answer the end of its creation and that it might be filled with the measure of man, according to his creation, before the world was niade."—Book of Commandments 52:16-17.

2. From the Articles of Faith and Practice of the Church of Christ, Article 20, we quote the following:

"We believe that marriage is ordained of God, and that the LAW OF GOD PROVIDES FOR BUT ONE COMPANION IN WEDLOCK FOR EITHER MAN OR WOMAN. In case of a breach of this covenant by adultery, the innocent one may remarry."

3. (a) Concerning marriage and the crime of polygamy, the Book of Mormon teaches the following, which with the Bible, is the basis of the belief and the practice of the Church of Christ on this question as set forth above:

"Behold, David and Solomon truly had many wives and concubines, which thing was abominable before me, saith the Lord,

"Wherefore, thus saith the Lord, I have led this people forth out of the land of Jerusalem, by the power of mine arm, that I might raise up upon me a righteous branch from the fruit of the loins of Joseph.

"Wherefore, I, the Lord God, will not suffer that this people shall do like unto them of old."

"Wherefore, my brethren, hear me, and hearken to the word of the Lord: FOR THERE SHALL NOT ANY MAN AMONG YOU HAVE SAVE IT BE ONE WIFE; AND CONCUBINES HE SHALL HAVE NONE: for I, the the Lord God, delighteth in the chastity of women.

"And whoredoms are an abomination before me; thus saith the Lord of Hosts."—Book of Mormon, Jacob 2:33 to 37.

(b) In connection with that which we have above quoted from the Book of Mormon, we wish to include

the following from the Holy Bible showing that Christ taught monogamy:

"And said, For this cause shall a man leave father and mother and shall cleave to his wife (NOT WIVES): and they twain shall be one flesh. Wherefore, they are no more twain but one flesh. What therefore God hath joined together, let not man put asunder."—Matthew 19:5-6.

We wish to state for the enlightenment of all people that we hold marriage to be one of the most solemn and sacred covenants that God has enjoined upon Christian people by the teachings of the gospel of Jesus Christ, and that inasmuch as this Church of Christ accepts these teachings as above cited from its standard books of faith we declare that from the beginning of time, marriage has been recognized of God as a divine institution, in which one man shall have but one wife, and one woman but one husband; and the State also recognizes it as a wise provision necessary for the welfare and happiness of the race. In the beginning, before sin entered into the world and man was still in his innocency, God said, "It is not good that man should be alone; I will make him an help meet for him," (nothing was here or elsewhere said about a plurality of help meets). Infinite wisdom designed the marital relationship for the human race to be monogamistic in order to increase its happiness and to restrain improper and lustful affections. Monogamy is thus ordained by an all-wise Heavenly Father as the foundation of congenial home life, that integrity and righteousness might be cherished and impressed upon posterity, thus building a strong social order worthy to endure through all ages.

So sacred and holy is this state of wedlock considered, that the word of God declares it to be the true emblem of the inseparable bond that unites Christ and His Church. In this respect He said, "Husbands, love your wives even as Christ also loved the Church, and gave Himself for it."

In view of these facts, the earnest student of the Restored Gospel can readily see the harmony of teaching of the Church of Christ, as set forth in the standard books of the Church, and we affirm that no justification exists for the charge that the Book of Mormon advocates plurality of wives, or polygamy, but to the contrary. For it plainly teaches "There shall not any man among you have save it be one wife and concubines he shall have none."

MINUTES OF 1962 CONFERENCE CHURCH OF CHRIST (Temple Lot)

Minutes of April 11, 1962-2:00 P. M. Session

Meeting was called to order at 2:28 P. M. with Bro. Tom Barton, Sr., in charge. Opening song No. 298, C"O Jesus I Have Promised." Opening prayer by Bro. secutar. C. Flint. Second song No. 175, "Guide Us O Thou kat Jehovah."

Minutes of April 11, 1962, 10:00 A. M. session were read and approved.

A letter from Ticul, Yucatan, was read.

Bro. William Sheldon moved that this letter together with the other letter on the table be referred to the Council of Twelve for their consideration and recommendation. Seconded by Bro. M. Harvey Seibel.

Bro. LeRoy Wheaton moved as a substitute that we appoint a committee of five elders, not of the Twelve, to review these items as an invsetigating committee and report back to this body. Seconded by Bro. Vance Harris.

Bro. William F. Anderson called for the previous question. Seconded by Bro. B. C. Flint. Carried.

A vote was taken on the substitute motion which lost—23 for, 33 against.

A vote was taken on the motion to refer which carried—34 for, 18 against.

(Note: the conference voted to leave the letters with the Council of Twelve until adjustments can be made. See minutes of April 13—Conference Secretary).

The report of the business manager was received.

April 11, 1962

To the General Bishopric and To the General Conference Greetings:

I am attaching herewith the Auditor's Report of examination of the account books of the church for the fiscal year ending Feb. 28, 1962.

Our tithes were \$2,341.11 less than the previous year and total receipts were \$1,075.11 less for the same period.

Our expenditures in 1961 were \$15,362.99 and \$16,896.77 in 1962, an increase of \$1,533.78.

Our New Building Fund and the Temple Fund increased \$302.71 of which \$258.38 was interest on the accounts.

Our General Church expenses for maintenance and repair of the church building was \$2,127.77.

The members of the Independence Local on the Temple Lot donated a total of \$1,636.85 of this amount which was used to replace the old roof, new windows in the dining room and Bishops' office, and new carpet in the auditorium. The previous year the Independence Local on the Temple Lot bought a new furnace and aluminum storms and screens for the upper auditorium. They have given approximately \$2,500.00 to repair and maintenance the last two years.

The new venetian blinds in the dining room were paid for by a member of the Independence Local (Temple Lot) and this expenditure is not recorded in our records.

Even though our receipts are somewhat lower than for the previous year, the General Fund balance has increased and our present bank balance is \$2,653.92 more than last year.

I wish to make apology for the lateness of some receipts going out which was due mainly to existing conditions during the year.

I certainly appreciate the prayers offered in my behalf during my stay at the hospital and the months following, and may each one who took part be blessed in their daily life for so doing.

I shall be pleased to answer any questions put forth by the membership if it will help to explain our records in behalf of the church.

The Board of Publications was staffed by the same members α_3 last year. The 1961 Conference appointed the same members to cantinue in office in lieu of selecting new ones to replace those whose terms had expired.

No meetings were held by the Board during the year 1961-62. However, it became the Board's duty to select a person to fill the vacancy left on the Editorial Staff of Zion's Advocate by Bro. Nicholas Denham's resignation. Sister Metta Anderson was appointed to fill the vacancy in a ballot taken by mail.

This is the extent of the work completed by your Board of Publications during the past year.

Inasmuch as this was referendum matter a vote of the ministers was called for and taken. The motion carried—26 for, none against. A vote of the body was then taken and the body approved unanimously.

A BILL OUTLINING THE DUTIES OF THE CHURCH OF CHRIST BOARD OF PUBLICATIONS

The Board of Publications has in the past found itself hampered in performing its duties, functions and operations by existing rules. Some examples are as follows:

- 1. The board found itself limited by former action which restricted the Board's right to correct grammar and punctuation in manuscript material submitted to the Board for approval and publication.
- 2. We found ourselves limited to accessibility of funds and their disbursement for publications.
- 3. In organization we found ourselves hampered by the past practice of having the General Church Business Manager acting automatically as chairman of the board. This not only has added to the manifold duties of the Business Manager but it also has denied the Board of Publications the right to choose its own chairman.

THEREFORE, BE IT RESOLVED THAT THE FOLLOWING BILL OUTLINING THE FUNCTIONS AND OPERATIONS OF THE BOARD OF PUBLICATIONS BE ADOPTED:

- I. ORGANIZATION OF THE BOARD OF PUBLICATIONS
 - A. OFFICERS
 - 1. Five Elders
 - 2. Two of the chairs on the Board are to be filled by one Bishop and one Apostle.
 - B. TERM OF OFFICE
 - To be elected in two pairs of two and one singly.

- C. MEETINGS AND ELECTIONS OF OFFICERS
 - 1. Meetings to be held as appointed by the Chairman or by agreement of the members.
 - 2. Chairman of the Board to be elected each year after General Conference appointments are made. The Secretary of the Board shall also be appointed at this time.

II. FUNCTIONS OF THE BOARD

A. PUBLICATIONS

- 1. Editing Rights
 - a. To edit all material for church publications except Zion's Advocate.
 - b. To correct grammar, punctuation and manner of presentation
 - c. To check for doctrinal content.
 - d. To draft all church forms.

III. FUNDS FOR OPERATION

A. REVOLVING BOOK AND TRACT FUND

- 1. Books and tracts published are to be sold and the funds returned to the Book and Tract Fund for the publishing of new material
- 2. The Board of Publications to establish prices to cover:
 - a. Postage and handling
 - b. Missionary copies
 - c. Cost of publication, etc.
- 3. Moneys of the Board to be handled by the Bishopric in a special fund and disbursed at the discretion of the Board of Publications.
 - a. The member of the Board of Publications who is a mem ber of the Bishopric is to be able to give financial status reports to the Board at their appointed meetings.
- 4. The Board of Publications cannot obligate themselves financially beyond the limits of the Book and Tract Fund.
- B. STARTING APPROPRIATION OF THE BOOK AND TRACT
 - 1. \$2,000.00
 - a. To be raised from present church funds.
 - b. All printing of books and tracts by the Church of Chart to be charged to this fund.
 - c. This fund can also be used to purchase books and tracts for resale.

BE IT UNDERSTOOD THAT:

All former action pertaining to the Board of Publication is to stand rescinded with the adoption of the above resolution or as may be amended.

CHURCH OF CHRIST CONFERENCE MINUTES April 12, 1962, 10:00 A. M. Session

Independence, Missouri April 11, 1962

To the Church of Christ (Temple Lot) In General Conference Assembled Greetings:

In view of the action taken by the General Conference on April 9, 1962, relative to the report of the members present of the Council of Twelve, Investigation Commission, Elders' Court, the Bishopsic, the Bishops' Court and the Conference appointed Investigation Committee, the following statements are made. The report was as follows:

Be it resolved that inasmuch as the Council of Twelve has come to the combined opinion that Apostle Clarence L. Wheaton, one of their members, has erred in his conduct as a minister of Christ, as evidenced by correspondence, documented incidents in its files, and the Elders' Court's record convened under date of December 11, 1960 in the case involving him, that he be required, based on his stated desire to repent of any error committed, to present in published form to all members of this Church affected, either individually or as a body, a full retraction of all such material; And that a probationary period be established for a one year period from this date to sufficiently establish the fact that repentance has truly been consumated, and that any further infraction of unchristianlike conduct referred to in this case shall be sufficient grounds for initiating new charges based upon such new evidence; And be it further resolved that any letters or materials containing derogatory material initiated by any other member of the Council of Twelve related to this case brought to trial, be retracted through appropriate moans to be determined by the Council of Twelve, with copies of all retractions by any individual involved to be filed in the records of the Council of Twelve, as evidence that such has been accomplished.

And in view of the further fact that in consultation with the Secretary of the Council of Twelve, Apostle Archie F. Bell, I have been informed that the documents referred to as necessary to be retracted are, the letter addressed to Mr. Ralph Stone, attorney-at-law, under date of August 8, 1960, and the document addressed To the Membership of the Church of Christ (Temple Lot) Scattered Abroad, dated, August 22, 1960.

Therefore, I, Clarence L. Wheaton, do hereby state that I was in error in the following instances:

6. 1. Based upon such information as was at hand at the time, section. Tressed the communication to Mr. Ralph Stone, I made this $k_{\rm s}^{\rm cont}$

"It appears that the very act of sending me to Israel was an act of conspiracy to get us out of the way", etc. See page 2, of said Stone Letter; and again

"In regard to the funds of the General Church, they entered into a conspiracy at the late Conference to the effect that if we came to Wales (and that has been entirely at our own expense), that our allowance would be cut off until we should return to the United States," etc.

Since returning to the United States, I have been informed that such statements were unfounded, and should not have been made. I, therefore, feel that I was in error issuing such statements to my attorney or any one else, and wish by this means to offer my sincere apologies to all who were affected in my having done so.

I will further state that all documents which were put into the hands of Mr. Stone, were returned to me over a year ago, and that no such documents now appear in his files.

In view of the above stated circumstances, I pray that on this phase of the matter, I have sufficiently covered the grounds to merit the forgiveness of my brethren of the Twelve, and the General Bishopric, and all others who have been grieved by this communication.

Copies of this document, if I recall correctly, were sent only to members of the Council of Twelve and the General Bishopric. I do not recall sending it to any other person or persons.

2. Relative to the "Appeal", I sent from Gilloch Goch, Wales, under date of August 22, 1960, I wish to state that I erred in sending this document out to the membership of the Church. Such information and statements as contained therein should not have been written and sent out.

Some of these statement relative to my brethren of the Twelve, I made without due consideration of the harm they might do the Church if circulated among the membership. After more serious consideration, I now see this grave possibility and now can truly say, that making these statements was unwise on my part and I am sincerely sorry for any injury they have caused the Church or my brothers and sisters in the gospel bonds.

This document instead of being sent out to the membership of the Church, should have been presented before the Council of Twelve and been disposed of according to the proceedures set up in the Church laws and rules.

I therefore, ask forgiveness for this breach of ethics.

Other than these documents, there has nothing else been published or broadcast by me as far as I can recollect. Copies of these two doctuments attached, are hereby filed with this statement.

I therefore, hope and pray that this will end the controversy and that we each shall go about the Lord's work to which we have been called.

A STATEMENT RELATIVE TO THE STATUS OF THE CHURCH OF CHRIST AND TRANSFER OF MEMBERSHIP

To Whom It May Concern Greeting:

Whereas there has been wide publicity given in the daily press to the claims that the Church of Christ, with headquarters on the Temple Lot, Independence, Missouri, broke away from the Reorganized Church of Jesus Christ of Latter Day Saints, and whereas, there has arisen a question in the minds of some relative to receiving individuals from the R.L.D.S. Church on their original baptisms, and with their priesthood,

Therefore, be it known to all men, that this Church of Christ was never at any time a part of the R.L.D.S. Church, but has maintained its standing and integrity as a remnant of the Church of

Christ established on the sixth day of April 1830, which was organized by Joseph Smith and six Elders, at Fayette Township, Seneca County, New York, in the home of Peter Whitmer. It has never been disorganized nor reorganized, but maintained its early connections with said Church of Christ in New York, as a group of local churches calling themselves the Crow Creek Branch of the Church of Christ in Woodford County, Illinois, later to remove as a body to Independence, Missouri, in 1867 following which date, as opportunity offered, they purchased the property known as the Temple Lots, which they still own to this day, which has been dedicated for the building of the Temple, and

Be it further known that the R.L.D.S. Church was composed of fragments of the early 1830 Church of Christ, who were located in the vicinity of Beloit, Wisconsin, who amalgamated in 1860 under the name of the Reorganized Church of Jesus Christ of Latter Day Saints, and accepted Joseph Smith, III, as their President, and

Be it known that through the years from about 1890, these two divisions of the Restoration, though duly elected committees endeavored to reach points of agreement, on which they might unite as one organization, until through these efforts, there were by 1918 some twenty-four points of agreement raached, which when presented to their respective Conferences were ratified as a Working Agreement of Harmony.

Among other points of agreement reached was one in which they mutually accepted each other's priesthood and baptisms as authoritative, when traced through valid original sources back to the hands of Joseph Smtih and the angel who placed this authority upon him.

In view of these facts the Church of Christ has accepted by transfer, after an examination of their status, such persons from the R.L.D.S. Church who have complied with these provisions, on their original baptisms and ordinations, as being equal and on a par with those of the Church of Christ and acknowledged such as our brethren.

Thus from 1916 down to 1926 this was the accepted position and action of this Church of Christ and inasmuch as the R.L.D.S. Church, by conference action did abrogate this Agreement of Working Harmony in 1926, it therefor became necessary for this Church of Christ to limit the transfer of membership to those who had been thus ordained and baptised prior to April 6, 1926.

Therefore, we the Church of Christ, in General Conference assembled do hereby declare that all persons thus transferred on the above terms, are validly baptized members of this church, and where priesthood has thus been conferred, that the official acts of such ministry, when acting in accord with the laws and usages of said Church, are valid and binding upon the said Church of Christ, and its members through the World, and we hold that wherever there are those even to this present time or in the future who are able to comply with these terms and are desirous of association with this Church of Christ, that they are likewise eligible to membership with us.

Bro. LeRoy Wheaton moved to approve recommendation from the Council of Apostles in regard to Apostle Don W. Housknecht and his missionary appointment. Seconded by Bro. Archie F. Bell. Carried.

Bro. Richard A. Wheaton moved that the press committee be instructed to submit the matter on transfer to the Independence Examiner, Kansas City Star, and Pictorial News with the request that it be printed as a news item and further if this request is not granted that space be purchased in a prominent place in the Independence Examiner to publish this resolution. Seconded by Bro. Joe Kidd.

Bro. H. B. Schultz moved to amend that this document also be submitted to the United Press and Associated Press News Services. Seconded by Bro. LeRoy Wheaton.

Best Results Follow Service, Leadership

Greetings again from the Black River Falls, Sparta Local, Wisconsin. Our services during the past winter months have been limited, due to the snow and inconvenience of having had to meet in homes because of our lack of heat in our little church.

Brother Isaac Brockman and Glenn Gill have been our only speakers. Both have given us much food for thought. The following are resumes of their sermons.

As members of the Church of Christ we are different, just by not being hypocrites in our religion. We have the fullness of the gospel, and God deals with us in our works. As long as we are and remain a people sincere in heart, God remains with us and then are we able to show the world we are the Church of Christ.

This is the day of our probation and we must choose to either stand among valueless things or in the midst of good. Man has to be operated by God's laws, not God'by man's.

As one man to another we must serve each other, but only in love, not because of title, age, dress, or what we own, etc. Just as Christ did a servant's work in love to his apostles, who felt lowlier, so must we to one another. (See John 13 where Christ washes his apostles feet.)

Our nation is a nation that was founded by a people who believed in God. God is mentioned on our money, and in all our important documents. Therefore, if we allow men to become our leaders who don't believe in God, our principles are destroyed and our nation will fall. This is the trend of today. As individuals we consider all to lightly. If we as individuals follow the path as other around us—the material rise of a nation to power—then we,too, will be destroyed along with the nation. Our rise must be that of a spiritual nature, and then if we live according to scriptures, stand firm in our beliefs, and have faith we'll be blessed, we can be taken "home" to live with our Heavenly Father, when the time comes our material home is destroyed.

To learn completely about God we must make Him a part of us, by setting up conditions whereby we allow Him to enter our souls. Things in this life are unimportant in thinking of eternity. Life span of time is only a pin Hudd, chairs universe. With God, a timeless being, secretary; Sr. v rerse so large we can't comprehend,

and yet we will defy Him, by feeling big and wanting Him to do as we want. But to be Christians we have to come apart from the world, love God, and **follow** His commandments, not just read them and say we'll follow them. The time to serve God is NOW, and NOW is always.

One sermon was started by the passing of a grain of mustard seed, and reading Matthew 17: 20-21: "And Jesus said unto them, Because of your unbelief: for verily I say unto you, If ye have faith as a grain of mustard seed, ye shall say unto this mountain, Remove hence to yonder place; and it shall remove; and nothing shall be impossible unto you. Howbeit this kind goeth not out but by prayer and fasting."

Even if we slip from side to side because of disappointments, God is waiting with open arms to receive us, if we are willing to repent and say yes to His will, if we have that faith of the mustard seed in the promises of scripture. If we abide sincerely as we're supposed to, God will abide with His full promises.

We have also had some round table discussions. The following are the questions asked and answers given to these discussions.

What is Christmas? Time of Christ's birth, and the time we should be thankful we have God to guide us. It's a time of happiness, thankfulness, time for showing our love for each other, and a time for realizing what we really love—Christ, gospel, etc. After our discussion we read the Christmas story from Luke 2:1-23.

What is wealth? Real wealth is the things money can't buy—having the Spirit of God, friends, health, feeling of giving and opening ourselves for receiving. One's greatest wealth is to be able to love others and to be able to be loved by others. Wealth of money is ckay only if used properly, and not to destroy love in others. Repentance and baptism effect the extent of wealth and increases the knowledge of it.

Is it the duty of lay members to show an example to the world the same as the ministers? It is very much our duty as we don't know when a word or deed dropped here or there will help or destroy a soul. Our discussions should be approached with "pull our ideas out of the blue" rather than in an arrogant manner of "I know it all, so listen to me." Let the Bible and Book of Mormon be our law. Govern religious things by the religious law.

What is Zion? We drew our conclusions as thus: a gathering of the saints to a place and also a condition of the people. The going forth of the law will be from Zion.

In what ways has it been of value to me to be baptised and accept Christ? The individual ideas were thus: It has made life fuller, given a greater tolerance of other's religious beliefs, greater love for others, and a hope for eternal life. Baptism was no problem, as there was a previous wish of wanting someting strong to hold to. It gave a greater interest in others' feelings and ideas, greater knowledge of things in the word of which there had been an unawareness, and a greater

foundation prayer-wise; a fuller extended growth. Baptism is the putting on of a new man, when the Spirit of God is then allowed to work more with one.
