## EDITORIAL

"Let him that is taught in the word communicate unto him that teacheth in all good things."

Be not deceived; God is not mocked: for whatsoever a man soweth, that shall he also reap.

For he that soweth to his flesh shall of the flesh reap corruption; but he that soweth to the Spirit shall of the Spirit reap life everlasting.

"And let us not be weary in well doing: for in due season we shall reap if we faint not." Galatians 6:6-10.

This month is an exciting one in the lives of many of our young people as they graduate from high schools and colleges and prepare to embark upon a new career.

Simply stated, graduation is the preparation made for the next step in life and in that sense that are many graduations from the cradle to the grave, which each of us must pass with honor or dishonor depending upon the preparation we have made.

Everything of a human nature goes through changes—some of which indicate advancement and life—some of which indicate stagnation and death. The history of man is the story of these changes.

Graduation time is a time to think of and plan for the future and as one listens to the speeches made by the boys and girls who are making this important step, one hears from their youthful lips the discussion of such topics as these: "As Tomorrow Dawns" "Preparation Through Education"—"Opportunity for Youth"—"Toward a United World", and many other such idealistic subjects. Too idealistic you say? Ideals and dreams are humanity's way of calculating the future.

Today I listened while a man was being prepared to orbit the world 22 times—this preparation ended in cancellation of the flight—but the flight will be made, for in reality it has been made by others. Yet when I graduated from High School in 1923, orbital flight was scarcely conceived in the minds of men. Today their dreams vision a landing on the moon—Tomorrow? Who can speak for tomorrow?

David Swing said: "Idealism is not the ravings of a maniac, but it is the calm geometry of life—all great truths are persistent. Each form of right is a growing form. All high ideals will be realized."

This one must believe who believes in the omnipotency of God. For Him there is only victory. His words will not return unto Him void.

Therefore, plans or dreams of the future which omit the Divine Influence of God are not the best and will eventually prove to be empty of true and lasting riches or rewards. A life without a proper relationship to God is a life without a light. This is an important truth our boys and girls will not have learned at school. It is part of the home curriculum, and if it has not been taught there, then we as parents must shoulder the blame, and can only pray that the lesson when learned will not have been too costly.

The lessons or preparation for life does not end with the classroom. Unless we learn from both our victories and defeats our education is useless. Thomas Huxley said: "Perhaps the most valuable result of all education, is the ability to make yourself do the thing you have to do, when it ought to be done, whether you like it or not. It is the first lesson that ought to be learned; and however early a man's training begins, it is probably the last lesson he learns thoroughly."

Another lesson we should learn early and remember long, is that the highest ideals win the greatest victories and richest rewards, though they sometimes seem to suffer the most bitter defeat. Christ, crucified, became the Lord of Life and the greatest teacher ever known, and his continuing influence is felt throughout the entire world of man.

If we are not intelligent enough to learn early in life that the greatest happiness comes through living according to the precepts of this great teacher we are doomed to many hours of sorrow and heartbreak.

The person who leaves God out of this mortal life will be left out of God's immortal life.

Bro. Clarence L. Wheaton moved that we take a ten-minute recess. Seconded by Bro. M. Harvey Seibel. Lost by a voice vote.

Bro. Marvin M. Case moved that the referendum action of 1962 relative to transfer of membership is not retroactive in its passage in that it does not affect existing members. Seconded by Bro. Thomas E. Barton.

Bro. C. LeRoy Wheaton moved: Be it resolved that in as much as Referendum Bill No. 1 of 1962, with reference to transfers, did not carry a clause rescinding former action, therefore, be it resolved that this bill is declared not valid nor binding upon the Church of Christ; be it further resolved, that we reaffirm our former action on transfer as set forth in Referendum Bill No. 19 of the 1936 conference and that this reaffirmation be sent out to referendum. Seconded by Bro. Richard A. Wheaton.

Bro. Thomas E. Barton moved as a substitute for the entire matter that we elect a committee of three to study this problem of transfer and bring in a recommendation to the 1964 conference. Seconded by Bro. C. LeRoy Wheaton.

Bro. Isaac Brockman moved the previous question. Seconded by Sr. Doris Hutchison. Carried.

Vote on motion to establish a committee to study the problem of transfers: Lost.

Vote on motion to reaffirm former action of 1936: Carried; 31 for, 0 against.

Bro. Thomas E. Barton moved to consider the recommendation from the Council of Twelve relative to the filling of the vacancy in the Quorum of Apostles. Seconded by Sr. Doris Hutchison. Carried.

Bro. Isaac Brockman moved to endorse the recommendation and that the Council of Twelve provide for the ordination of Bro. Robert H. Jensen at the earliest convenience. Seconded by Bro. Thomas E. Barton.

Bro. M. Harvey Seibel moved as an incidental motion to defer action on this recommendation until 10:00 a. m. April 12. Seconded by Bro. Rolland D. Sprague.

Bro. M. Harvey Seibel withdrew his motion to defer action.

Vote on recommendation from Council of Twelve relative to filling the Apostolic quorum. Carried.

##### Minutes of April 12, 1963—10:00 a.m. Session

Meeting opened at 10:00 a. m. with Bro. Thomas J. Jordan in charge, assisted by Bro. Arthur M. Smith. Opening song No. 241, "I'm Pressing On the Upward Way." Opening prayer by Bro. Arthur M. Smith. Second song No. 324, "Pass Me Not, O Gentle Savior." Scripture reading was from the 24th chapter of Matthew.

Bro. Thomas J. Jordan turned the chair over to Bro. Arthur M. Smith for the business session.

Report from the Committee on Rules of Jurisprudence was given first reading.

Recommendation from the Joint Council relative to the appointment of Bishops in the missionary field was given first reading.

Recommended Statement of Estimated Expenditures for the Conference Year 1963-64 was given first reading.

Bro. Nichols F. Denham moved that we send a note of thanks to the Blue Valley Federal Savings and Loan Association for sending the Easter Lily. Seconded by Bro. Richard A. Wheaton. Carried.

Bro. M. Harvey Seibel moved that Bro. John Gill choose four members of the church to invite Bro. Fernando Ojeda to attend meetings with us to bridge the gap which may separate us and that this delegation assure our love for him. Seconded by Richard A. Wheaton.

Bro. William F. Anderson moved the previous question. Seconded by Bro. M. Harvey Seibel. Carried.

Vote on motion relative to Bro. Fernando Ojeda: Carried.

Bro. M. Harvey Seibel called for the Sunday School and Church Materials Bill.

Bro. M. Harvey Seibel moved to approve the Sunday School and Church Materials Bill. Seconded by Bro. Harvey E. Seibel.

Bro. Richard A. Wheaton moved that this Sunday School and Church Materials Bill be referred to the

General Sunday School Association officers and Quarterly Committee for their study and that those provisions which can be incorporated into the provisions of the present Quarterly Committee be referred back in the form of a recommendation to the Conference of 1964. Seconded by Bro. Oren A. Caviness.

Bro. Tony Grzincic moved the previous question. Seconded by Sr. Minnie Smith. Lost 26 for, 34 against.

Bro. Oren A. Caviness moved to postpone indefinitely the consideration of this document. Seconded by Bro. C. LeRoy Wheaton. Chair ruled the motion out-of-order.

Bro. M. Harvey Seibel moved the previous question. Seconded by Bro. Isaac Brockman. Carried.

Chair ruled that the previous question applied only to the motion to refer. Decision of the chair was appealed. Decision was sustained by the body.

Vote on motion to refer the Sunday School and Church Materials Bill to a committee for study. Lost: 16 for, 34 against.

Bro. Oren A. Caviness moved the previous question on the main motion to approve the Sunday School and Church Materials Bill. Seconded by Bro. Joseph Kidd. Carried.

Vote on main motion to approve the Sunday School and Church Materials Bill. Lost: 29 for, 30 against.

#### THE SUNDAY SCHOOL AND CHURCH MATERIALS BILL

Whereas, the former duties of the Sunday School Association relative to the editing and publishing of Sunday School material is now vested in the Board of Publications, see Referendum Bill No. 2, 1962, "Outlining the Duties of the Church of Christ Board of Publications."

Whereas, the Sunday School Association's responsibility is limited to the soliciting and collection of Sunday School Material, without publishing rights, and

Whereas, this dual system of Sunday School material preparation by one agency with the responsibilities for evaluating, editing and selling by another agency which has no authority for choice of said material is cumbersome, time-consuming, inefficient, and unrewarding to those who do the work of collection; therefore,

Be it resolved, that the present Sunday School Association be abolished, and

Be it further resolved that the Sunday School Association be replaced by "The Sunday School and Church Materials Advisory Committee" hereinafter referred to as "The Committee."

#### I. MEMBERSHIP:

- a. Three members serving three years each elected by the General Conference; one elected on successive years. Election in the first year will be for 1, 2, and 3 years respectively, the one receiving the highest vote serving the 3-year term, etc.
- b. Members will be spiritually dedicated persons capable of developing and advancing the functions of Sunday School materials, whether in the form of Quarierlies, or in the field of Visual Aids and Helps.

#### II. FUNCTIONS:

- a. The Committee serving as a subcommittee to the Board of Publications, working in close harmony with the Board in the choice of Sunday School Materials, in the gathering of such materials, the selection of subject matter, author, etc.
- b. The Committee serving as liaison between the Board

and Authors, in an advisory capacity to the author in subject matter, outline of presentation, type of material, and teaching effectiveness within the guidelines established by Board action.

- c. The Committee meets with the Board whenever the requirements of information flow, problem areas, general routine, and expeditious performance of pending functions demand.
- d. The Committee will engage in an active and continuing program of research along the lines of the possibility of maintaining a lending library, Visual Aids, Sunday School Aids, Slides, Films and Projection Equipment, intended to promote the growth and development of interest in church schools, classes, lectures in the message of the Church of Christ in all the world.
- e. The combined Board and Committee has full authority to implement part or all of the above program when it is deemed feasible and necessary by the Board of Publications.

#### III. AUTHORITY:

- a. Final authority will be vested in the Board of Publications for all functions of the Committee. The Board may delegate authority to the Committee whenever the expeditious performance of the work requires.
- b. The Committee will not vote at Board meetings.

#### Black River Falls-Sparta Local

Greetings once again from the Black River Falls Sparta Local. During the past few months, we have received much food for thought from the sermons we have heard. I would like to pass on to you small resumes of these sermons.

"In the beginning was the Word, and the Word was with God . . . In him was life; and the life was the light of men. . . . And the Word was made flesh, and dwelt among us. . . ." (Portions of John 1: verses 1, 4, 14.)

"Whosoever drinketh of the water that I shall give him shall never thirst; but the water I shall give him shall be in him a well of water springing up into everlasting life." (John 4:14.)

The water of life comes from God, and any one can have it, who really desires it. If we desire this living water, and follow God through righteous living, we have an inheritance promised to us that: "He that overcometh shall inherit all things; and I will be his God, and he shall be my Son." (Rev. 21:7).

All the testimony and law of God hangs under the two great commandments: Love the Lord thy God, and love thy neighbor as thyself. And Christ is the light that came and set an example unto us. He is the light that we should hold up, and we can hold it up by following the example he set.

Beautiful days should be appreciated and we should thank God for these things. The creation was the first miracle and all things were created perfect. God is an unchangeable God, so when His kingdom is in operation, all will be perfect.

The relationship between the individual man and God is a personal thing. It is therefore our own choosing as to how good this relationship is kept, and what happens to us upon stepping over the threshold of eternity.

Portions of the article, "Why I Quit the Ministry", taken from Post Magazine, November 17, 1962, was read. It dealt with a Protestant minister and his problems in trying to present religion to a community, where only social prestige was wanted. In his work, he ran into stop signs along the way, and finally got a warning from the board of trustees. He then quit as he felt his job in this community wasn't the job of ministerial work which he had been chosen to do.

Nephi prophesied of this very thing of ministers being turned away because they tried to teach the truth instead of what the people wanted to hear. Also of people only wanting fine sanctuaries and the prestige; not religion. But we don't have to be corrupted. We aren't enslaved in these things, or need to be controlled by a clique. A firm belief of the gospel of Christ and prayer can make us strong enough to resist the temptations of the devil. We are only committed to answer to God, because our sins can only be blamed on ourselves. The choice is ours, whether it be life or death.

The first sin was a lie. And a lie is the basis for all sin. It can start us on the pathway of wickedness in only a snap of time. And salvation for the wicked ones comes only through the moments in this temporal life. God gives us according as we desire: life or death, joy or remorse of conscience. Our faith in God is built by sincere prayer to God, for a stronger foundation to enable us to withhold the sins of this temporal life.

We have held two round table discussions. One was on the "Sermon on the Mount", Matthew 5, 6, and 7. The other was a follow up of the Gentile Nation, from its first settling to the prophecy of the future of the rise and fall of the Great and Abominable Church, as recorded in Nephi's vision in the Book of Mormon and Rev. 17, 18, and 19:1-6.

We have held one special called prayer meeting and then have had our regular sacrament service.

We have been visiting in Madison and Milwaukee for church services.

Visiting ministry has been Bro. John Gill, South St Paul, Minnesota. Other visitors have been the Earl Petries of Portage, Wisconsin, Sr. Doris Hutchison, Milwaukee; Sr. Leona Tucker, Black River Falls; and Mr. and Mrs. Victor Arnold, Wisconsin Rapids, Wis.

Our young people's organization, formally named Youth Christian Practice, has been active in several gatherings.

We've had regular study classes during each month. Our other meetings have included a home-made ice cream social, and a film entitled, "An American Girl", followed by a round table discussion.

The film was the story of a girl, not Jewish, who was given a Jewish bracelet, which she wears in spite of opposition and loss of friends. **"... A MORE EXCELLENT WAY."**

I Cor. 12:31

James teaches us that all the worthwhile attributes of men come as gifts from God. He said, "Every good gift and every perfect gift is from above, and cometh down from the Father of light, with whom is no variableness, neither shadow of turning." James 1:17.

In Christ's parable of the talents, the Master called his servants to him and gave them talents to care for according to their ability to manage them. Two men developed their talents and became profitable servants. . The third man buried his talent, neglecting to develop it and because of this he was of no use to the Master. The Master said, "Take therefore the talent from him, and give unto him which hath ten talents. For unto everyone that hath shall be given, and he shall have abundance: but from him that hath not shall be taken away even that which he hath." Matt. 25:28-29.

We know, of course, that a talent in the ancient world was a unit of money or a measure of weight. In our modern language we think of a talent as a gift, a natural endowment, powers and gifts bestowed upon us as a divine trust.

God in His infinite wisdom has given talents in various numbers and degrees to every person and it is our duty to search them out and develop them in ourselves and in our children to the fullest extent. We are just as responsible to God to make profitable use of our talents as we are for any other part of the Gospel of Christ. They are an important part of His plan, and of His purpose, that we might become "—heirs of God and joint heirs with Christ: if so be that we suffer with Him, that we may be also glorified together." Romans 8:17.

Paul said, "Neglect not the gift that is in thee . . . meditate upon these things; give thyself wholly to them; that thy profiting may appear to all." Timothy 4:14-15.

In other words it is our responsibility to develop our talents that they may be profitable to others.

Often the very thought of developing a dormant talent frightens people. The idea that only an artist, a musician, or those with ability to speak before large crowds are talented, is a mistaken idea. They may have a greater degree of natural talent, but they have also spent many hard years in developing it.

There is a quotation which states, "whom God calls, He qualifies." If a person has a desire to develop his talent and makes an effort to do so, God will help him.

It is my opinion, that many talents we are prone to think of as great, are not the greatest talents that God has given. God is anxious for all His children, even those of us with the least natural talent, to develop in spiritual grace, that we might appear profitable to all. That through His gifts we might enjoy a more abundant life on a higher spiritual plane.

The most important talents to the spiritual life are

those listed in the Scripture as the "Fruits of the Spirit." In the 5th chapter of Galatians we find, "But the fruits of the spirit is love, joy, peace, long suffering, gentleness, goodness, faith, meekness, temperance, against such there is no law." Gal. 5:22-24. And in the 4th chapter of Phillipians, "Finally, Brethren, whatsoever things are true, whatsoever things are honest, whatsoever things are just, whatsoever things are pure, whatsoever things are lovely, whatsoever things are of good report: If there be any virtue, and if there be any praise think on these things . . . and the peace of God shall be with you." Phil. 4:8-9.

We cannot deny the fact that a person who is gifted with meekness, gentleness, a loving heart or a peaceful mind is a talented person. We have heard much of love and faith and I'm sure we all realize the value of those two important talents, but I would like to point out some of the things we seldom think of as talents and their importance to us.

Zion has been an important part of the Gospel since the beginning of the Restoration. So we may say that Zionistic living is a talent to develop. When a large group of people are concerned it is unlikely that there will be a complete unity of thought upon all matters. But there should be a complete unity of purpose. This not only applies to Zionistic living at some future date, but to Gospel living in the Church today.

Selfishness, hypocrisy, neglect, unrighteousness, and ignorance must be overcome by developing and putting to use, the natural gifts and talents which God intended us to use. Love, of course, being the foremost. Neither can we deny the spiritual value of the dormant talents which lie within us. A peaceful mind, a long-suffering and gentle character, wholesome goodness, meekness, joy, and an understanding heart are things which are acceptable to the Lord. Christ said, "Blessed" are they who make use of their talents. Unity of purpose will come about only when men love God more than self.

The cause of Zion, church unity, peaceful home, or any other cause must first be established in the hearts of men and women and that condition takes a lot of preparation. If you are to be successful in your church group, in your work, in your community or in your homelife that preparation must be started today. For you cannot become tomorrow what you are not becoming today.

There was a story in the newspaper some time ago of a little six year old girl who was denied the love of a mother and the security of a kind and gentle home-life. The only love and gentleness she had ever known came from a dog. So she became like a dog, she crawled on all fours, barked like a dog and snarled at people. She forgot how to talk and laugh.

To those who live by the "fruits of the spirit" those things seem unreal and could not happen in our country, or in our own home town—but it did. That little girl did not have a chance to develop her natural talents. Since juvenile authorities found her and placed her in a chil-

dren's clinic she is slowly responding to the kindness, gentleness and love of the nurses and teachers. By making use of well developed God-given talents they are rehabilitating the life of the little girl. We hope she may regain the ability to develop that talent of love within herself and that it will bless her and those around her.

Can we say kindness, gentleness, peace and love are not talents? The mother of this girl had completely neglected to develop her natural talents, ruining her own life and perhaps that of her child.

Recently at two separate locations I have heard two young boys, not yet in their teens, being moved to tears, stand and offer their testimony, thanking God for the blessing He has bestowed upon them through the Gospel of Christ. They are not being denied the opportunity to develop talents which are pleasing in the sight of God, but rather are being encouraged in things which will appear profitable to all.

Paul said, "Ye are our epistle written in our hearts, known and read of all men: for as much as ye are manifestly declared to be the epistle of Christ ministered by us, written not with ink, but with the Spirit of the living God; not in tables of stone, but in the fleshly tables of the heart." II Cor. 3:2-3.

If every person would develop those talents of virtue, patience, charity and love, and have them written in their hearts there would be no little girl living like a dog. There would be no loneliness, the sick and the aged would be comforted, homes would be happy and the peace of God would be upon the whole world.

There is a story of a business man who was reading his Sunday paper, but his five year old boy was continually asking him questions. So finally the man found a map of the world in the magazine section. He cut it up in small pieces to make a puzzle for the boy. Then he said, "Here son take this puzzle and see if you can put it together." He settled himself down for a while to enjoy his paper, but in the space of minutes the boy came back and said, "Daddy, I have the puzzle put together." And sure enough he had. The father looked at his son in amazement and said, "Son you are much smarter than I was at your age. However did you get the puzzle put together so quickly?" The son said, "It was easy, daddy. On the other side of the map of the world is the picture of a man. I put together the picture of the man and the world came out all right." And so it is with world conditions, church conditions and family conditions. If all the people would develop the latent God-given talents within themselves and build upon them for the mutual good of one another the world would come out all right.

Think on these things, meditate on them. Give thyself wholly to them, that thy profit may appear to all. And the peace of God shall be with you.

We are told that God so loved the world, that he gave his only begotten Son that whosoever believed on him should not perish, but have everlasting life. Then comes the question, do you believe Jesus Christ? The one outstanding teaching of Christ was to love. "Thou shalt love the Lord thy God, with all thy heart," etc. Do you dear reader keep that commandment by giving God first place in your life? When we learn to put this fully into operation in our life there will be no hardship in keeping all the other commandments. When we reach that point, there will be no temptation that will be successful, and the Satanic power will have no power over us.

We might note the other commandment that is coupled with the first, and like unto it, "Thou shalt love

thy neighbor as thyself." Until we are keeping the first commandment we will not heed the second, and so on down the line, for on these two commandments hinge all the others. The keeping of all the other commandments, depends on the keeping of the first and great commandment—God comes first, or should, and when we put God first in our life the other commandments will be easy to keep.

The other force would entice us to go the other direction, and put self and self interest in first place—to love self, and then if there is any time or other commodity left, let God have that. Seek to tear down your brother or neighbor, if he does not see as you do, make accusations against him, and do all you can to discredit him, whether he is dead or alive—so Satan advises.

Jesus said we were to love our enemies, do good to those who persecute us. Which way are we going? Whose advice are we taking? We note in the last prayer of the Master as found in John 17, where He prayed for those of our day, that we might be kept from the evils, that there might be a united force for good, that we might be one with them, that the world might know that Jesus was sent.

"I pray for them which thou hast given me; for they are thine. . . . I pray not that thou shouldest take them out of the world, but that thou shouldest keep them from the evil. . . . Neither pray I for these alone, but for them also which shall believe on me through their word: That they all may be one as thou, Father, art in me, and I in thee, that they also may be one in us; that the world may believe that thou hast sent me."

Unity is a neglected or forgotten virtue, division is very evident, and on the increase. We tell or try to tell the world that we have the gospel restored in these last days in its primitive beauty—a gospel of unity, and love—these two go together for if we love God with all our heart, then there will be a unifying of our forces, and there will be a light that will shine forth that will attract good people. But as long as there are those who spend their time, talent, and energy to discredit their brother, whether living or dead, they are not being directed by the great force of love.

"If you love me, you will keep my commandments," and the great commandments will be the first we must keep. There is no love where efforts are being made to injure each other.

The eyes of the world are on us, and they are forming their opinions from the manner of our lives, and when we do that which hurts or discredits each other, there we find the working of the other force, commonly referred to as hate, ill will, dislike, and all kindred tools of Satan.

Eternal life is the most important commodity we have. To be acceptable to God is the greatest of all favors. Satan will and does do all he can to get us to go his way, when we are not constantly on guard he gets us to follow his lead, and little by little he binds us. True, there has been a restoration of the gospel in our

day, but the world will not believe it as long as efforts are being made to tear down the columns that it is built on.

I am reminded of a local revelation, wherein, The Lord said: "Tear not down another's structure, hoping thus to build thine own." It is true we cannot build a successful character by first destroying another's good name or character.

The one outstanding advice given by the Master was that we love one another. It is not possible to love and hate at the same time. "Return unto me, and I will return unto you" is acceptable to we who claim to be the possessors or custodians of the pure gospel of Christ. We must return to the Great Commandment of Love, giving God first place in our lives. Sit down and figure how much you can give or do for the Lord, rather than how little we can get by with.

Hate is as destructive to spiritual life as strychnine is to physical life. The mission of Christ was love. In love He was willing to come and take on human life that he might rescue mankind from the snares of Satan. So in order to make his teachings effective, He said we were to love even our enemies. I wonder how many of us do as He said? We are told that God is love, and it follows that we can say the same for Christ.

We claim to love each other, yet we find there is a disposition to love self more.

"A great and marvelous work is about to come forth among the children of men; behold I am God, and give heed to my word, which is quick and powerful, sharper than a two-edged sword, to the dividing asunder of both joints and marrow: therefore, give heed unto my word. Behold I speak unto you, and also to all those who have desires to bring forth and establish this work, and no one can assist in this work, except he shall be humble and full of love," Book of Commandments, chapter 11.

If we ever hope to have Zion we will have to stop hating and begin to love.
