

I Know Thy Works

"I know thy works, that thou art neither cold nor hot: I would thou wert cold or hot. So then because thou art lukewarm, and neither cold nor hot, I will spue thee out of my mouth" Rev. 3:15-16.

e would like to think that we are hot. But are we? We need to examine ourselves to see just what kind of individuals we are. What do we do with our time? Do we spend it in service to God? Or do we spend it doing our own thing? Do we spend our time sharing the gospel with others? Or do we keep it to ourselves?

Are we too comfortable in our nice homes, not wanting to get out of our soft easy chairs? The Bible says in Matthew 7:16, "Ye shall know them by their fruits." Oh yes, it's speaking of the false prophets, but we are all known by what we say and do. People judge us by the things they see us do. Are we setting a good example, or a bad one? In James 1:27 it says that "Pure religion and undefiled before God and the Father is this, To visit the fatherless and widows in their affliction, and to keep himself unspotted from the world." Are these the things that we are doing with our time? Dear Brothers and Sisters in Christ,

have been desirous to pen a few words to all of you. First, to thank all of you for responding in such a generous way to ease the pain and suffering here in Honduras. We are not located in the areas that were hardest hit by "Hurricane Mitch," but nonetheless many families were affected and lost all they owned to the raging rivers. With your help we have been able to bring food to more than 120 families who lost all that they owned—their homes as well as the fields of corn and beans.

We are now in the process of trying to locate affordable land where they can begin to rebuild and start over.

I would like to go back to the first few days of "Hurricane Mitch" and share with you portions of my diary as events unfolded here in Ville de Jamastran, Zamarano, Honduras.

11-4-98

"Hurricane Mitch" has passed by and left its devastation in its wake. We all wait to see what will be the final outcome.

President Carlos Flores has announced that 70% of all bridges have been destroyed. We have been a week with no electricity, no potable water, and have begun rationing the amount of staples people can buy from the pulperia (which means a small store). We spent most of the day yesterday trying to find beans to buy. We have enough beans for the community for 3 weeks and sugar for 1 week if we ration them.

Today in Danli I visited the families being housed. Some of these families' homes have been destroyed; others have been evacuated from their homes for fear

the mountain will explode with water and destroy their homes.

While visiting the mayor's office in Danli to see how we could be of a service, I was given a list of small villages where families had lost their homes to raging rivers and land slides.

11-5-98


thought I would not write tonight as I was so weary after my day of adventure; but, here it is midnight and I find myself unable to fall back to sleep. So I shall write some by the soft glow of my kerosene lamp.

Today I visited families at Las Almemdres who have lost their homes. First I stopped at Jorge Luis' mom's house to give her a medical shot. She has been in bed for 6 days with a fever, sick to the stomach, and pain throughout her body. I explained to her first that our Heavenly Father is the best doctor and He has all power to heal. So, we prayed together asking for a blessing for her.

I stopped at Maura Diaz' home to leave them some food as her husband had come last night asking for help. There is a shortage of work now as many crops have been destroyed. Maura is sick with the flu. Her gorgeous flowers growing in the front yard are such a contrast to her poor dwelling.

At Las Almendras I found that there are 14 families living in the school. II families whose homes had totally been destroyed and 3 others whose homes were in dangerous circumstances. When asked what their greatest needs are they responded: 1-food, 2-medicines, 3-land on which they can rebuild their homes and have a new start.

The walk home was very hot and long. It was our plan to go and visit families at Jutiapa after my English class (which I teach every week). We have rescheduled

my English classes for an earlier time in the day as there is no light after 5:30 p.m. So at about 3:30 p.m Ronnie, Glenda, Santos and I left on bikes for Jutiapa.

The first bridge we encountered was out with only a plank connecting the twisted metal to the other side, which we pushed our bikes across. Locals with four wheel drives were driving down through the river. As we made our way across the plank, one at a time, I wondered how easy it would be to recross in the dark on our way back.

We located the affected families in the community center and in the school building. Here at Jutiapa 58 homes had been destroyed. Many of these families work in agriculture. They are not land owners themselves, but work for large land owners in the area. Many of these crops have been destroyed. Therefore these people have no work, income, or food.

While talking with the families and seeing the destruction this one little river has caused, I can't help but think how terrible it must be along the coastal regions. My heart goes out to all of them. It is my prayer our Heavenly Father will show us how we can best help and open whatever doors are available, but most of all that He will put in each and every heart His love during this

critical time, and give us wisdom on how we can best help.

We headed back to Zamarano in the pitch dark of night that descends about 6:00 p.m. In the dark we had a number of very close encounters with other bikers, and as I had imagined earlier, the walk across the plank with our bikes was not easily accomplished. It then started to rain. It was a blessing to see Johnny coming with the van as we were all tired, wet, and dirty.

11-6-98

awoke with my eyes swollen shut. On the ride back from Jutiapa, I got a bug in my eye. So today my eyes are infected with conjunctivitis. The gnats here carry the infection.

Went to Danli to call Thomas and to buy provisions for the 14 families at Las Almendres. It was wonderful to hear Thomas's voice and to talk with Tom Maley. I cannot express in words how grateful I am for all of the help Tom has given to this work. It would have failed a long time ago had it not been for his love and generosity.

We were so grateful to hear from Thomas that a donation of \$2,000.00 had come with which we could buy food for these families.

11-7-98

am still writing by the soft glow of my lamp as the electricity has not been restored, but have difficulty in seeing as my eyes are still badly infected. We distributed to the 14 families the food and medicines and returned home about 11:00 a.m.

I was so weary, tired and sick that I begged off going to town to receive a call from Darin. So Johnny went in alone and I crawled into bed and slept until 3:00 p.m.

I got up feeling better and prepared the grapes for sacrament service. Tonia gave a testimony on how she needed a home to live in for her and her family and how the Lord heard her prayer and answered it by giving her a place on the project to live.

Tonia also give a testimony and asked for prayers for his family in Tegucigalpa (which is the capitol of Honduras) whose homes had been destroyed.

11-8-98 (Sunday)

When I arose I found a young boy and an elderly gentleman waiting for me. The elderly gentleman needed to get to an appointment in Danli. He stood


before me shoeless and in tattered clothing. He has tuberculosis (TB) and needed a check-up.

The young man (boy) was asking for help as his father was sick and in bed and had been unable to work, and therefore had no income with which to buy food for his family. I told him I would walk to his home and visit with his father.

I first had to take provisions to Isabelle. I feel guilty that I have not taken provisions to her sooner. It is sometimes hard to know what to do or how to help. I don't want to support her in being a prostitute; but then again, I would not want to force her back into her trade for want of food for her family and her children. I am praying that our Heavenly Father will give me an opportunity to talk with her and to give me words that could work upon her heart.

At the small home of the boy I found his father in bed; he has reoccurring hepatitis. He is taking medication, but is really in pain and sick. We first prayed together for him, his health, and his family. I left the provisions and told him I would stop back later in the week to see how he was doing.

Our group for church was smaller than normal as the river is too high to transport the people from the

three nearby villages in the van. Johnny's sermon dealt with not waiting until it is everlastingly too late before one responds to the Lord's call. He gave the example of a man in a flood and the water has entered the house and he is praying that the Lord will help him. So along comes a pick-up and the driver says. "Come with us. the river is rising." The man responds, "Don't worry. God will help me." Next the river is to the first floor ceiling and a boat comes along. The man in the boat calls out "Come with us, the rain is not going to quit." He responds, "Don't worry about me: God will take care of me." As the water rises the man has to move to the roof of his home and a helicopter flies by and offers him a lift. Again he cries out, "Don't worry about me; God is taking care of me." Later, as the water continues to rise, he cries out to God, "Lord, why aren't you answering my prayers?" God responds to him and says. "I sent my servants three times to help you; why aren't you listening to me?"

After church we walked to Chirinas to take food to the invalid's family. Norma's family, and to check on other families who come to church. The river water was up to the middle of our thighs. After visiting with the families we headed home in the dark, once again wading through the river.

11-9-98

We drove the elderly man with TB to Danli for his appointment. We also needed to pick up cement and metal rods to finish the small home on the roadside.

We went to the mayor's house to ask for an order for diesel for our van as we are delivering food to families. He gave us an order for 10 gallons of diesel. I then cashed a check for \$1,000.00 to buy provisions for the families of Capules, Villa Rice, Que Brada Larga and Jutiapa. We are planning to do these distributions on Wednesday.

11-10-98

y plans for today have changed as Norma's brother-in-law came to inform us that Norma needed us to come to Chirinas as her husband Lazaro had died of a heart attack while gathering fire wood. This was hard for me to accept as now how could Norma and her children survive. She has a baby and Jorjito (a 10 year old invalid), and 4 other small children. Now who would they have to provide for them?

Dear loved ones, I am so weary in heart and soul. How can we even make a dent on years and years of

social problems? It all seems so overwhelming. Perhaps just today people are beginning to feel the reality of where we are at. Ronnie could not buy sugar today. We are rationing sugar to ½ lb. a day per family. Ronnie found some beans for sale from a local farmer for 1.050 Lempiras (which would be \$76.00 for a 200 lb. sack). In Danli and Tegucigalpa they are selling for 1.500 Lempiras.

On reaching Norma's home we found she was not there, as she had left to claim Lazaros body and bring it home. His corpse had to remain in the location it was found until police from Danli could come and investigate the cause of death.

So I began to bathe Jorjito who looked as if he had not been bathed for weeks.


I am inside of a plastic and stick shack with a dirt floor and no water available. A neighbor women brought me a pan with water. I had brought with me disinfectant soap. I also had brought along a small cassette tape of Spanish children songs. Knowing Norma would not have clothing for Lazaro I also brought a white shirt, black slacks, and a pair of socks of Johnny's.

I had Ronnie pick up a casket in Danli, and that evening Johnny performed the funeral service. The casket was brought across the river in a small boat. For the service Johnny read Psalms 23, Alma 10:23-27 and Alma 16:229-232. Johnny explained how Lazaro's soul was with God and in God's control: but, our souls are still here and God has granted unto each of us time to repent, be baptized, and to endure until the end. We then all walked home in the dark.

My heartfelt prayer was for the Lord to guide us to know how to serve and love this people, that they would begin to desire Him above all else, and to show us how to help the children. So many without love. Mothers so weary and tired with burdens too big to carry alone and not knowing which way or to whom to turn for help. Please Lord, direct and guide our service and footsteps to best serve your children here. Mavis and Leyda prepared commodities for 22 families.

11-11-98

Took provisions to Capules and Quebrada Larga. Walked along the river to see where families had lost their homes. We next loaded provisions for 62 families at Jutiapa. But as we did not have a complete census to go by and it was late we planned with them to return on Friday.

11-12-98

Ronnie, Tonio, and I left for Tegucigalpa after giving instructions to Johnny about the distributions at Jutiapa; we then caught a bus to Ojo de Agua where the bridge was out.

The destruction was tremendous. We rode across the river in a small home-made craft that had to be baled out as we were pulled across by a rope from the opposite side. We then walked 2 to 3 kilometers to catch a bus to Tequcigalpa. We arrived about 2:30 p.m. We took a taxi to the embassy and then walked down to the center. When I viewed the tremendous destruction of one raging river I was totally "awe-struck." This one small river took everything with it. leaving only disaster in its wake.

wake.

STREET SHOWS WHERE THE When we arrived at the location of Tonio's sister and family and viewed the destruction one could not help but to feel pain for the 1000's of families left destitute without homes, and some

not knowing where their loved ones were.

Tonio has helped his sister construct a zinc teepee from trash in the riverbottom. They will live in it until they can find a better resolution. There are 7 members in her family. We slept with them for the night and shared their humble fare.

11-13-98

We spent most of this day walking through colonial (subdivision) after colonial along the river that

had either been totally wiped out or filled to over the peeks of roofs with sand and debris from the river. In some colonials all that could be seen were the foundations of 200 or more homes.

We walked to Victoria's (she had received the gun wounds when we were robbed 4 years ago) to see if she and her family were okay. They are doing fine. Her father lost his home and is staying in a school at this time.

We caught the last bus to Danli which would make it too late to catch a bus from Danli to Zamarano, so we intended to wait. On the outskirts of Danli Uriel (Jahaira's brother) came by and offered us a ride. We were very grateful for the lift.

11-14-98

Distributed to families at Las Almendres and took pictures of where their homes had existed. Many want to be picked up for church in the morning. Johnny promised he would come to pick them up. 11-15-98

Johnny's sermon dealt on the dead and the living, and that each of us are either walking in death or walking in life eternal. Are you walking in the love of Christ or the greed of man? 11-16-98

We went to Danli and picked up provisions for families. We also renewed Joani's and Ronnie's passports. Sammy did not want to sell us a full bag of sugar. He told us to wait until the store closed and he would sell us a full bag as we are helping families who are victims of "Hurricane Mitch." It was late when we returned to Zamorano and unloaded the provisions. Wearily I crawled in bed thanking our Heavenly Father for His many blessings.

11-17-98

Again we went to Danli for provisions for the pulperia. Johnny located 2 used tires for 900 limpiras. At 5:00 I had my English class. We went to bed early as we still have no electricity.

11-18-98

eyda and Leonel worked all morning on provisions for Capules and Quebrada Larga. We loaded up late but all went well. The families requested that we come and hold a prayer service with them on our next trip. We then all prayed together asking the Lord's blessing and help. Our study service went well. I felt at the end renewed in spirit and body. I am so grateful to our Heavenly Father for his goodness and kindness.

ear loved ones, I know this is not adequate for you to understand all that has taken place here in Honduras, but perhaps I have given you a feeling of what our lives are like here and a taste of the work. So much has happened to change the lives of so many. Many have come to me and asked, "Do you think that God is punishing us?" Some verses in Hebrews came to my mind. Hebrews chapter 12, starting with verse 3 and reading through verse 29 (please read this to understand).

What powerful words, "our God is a consuming fire." I do believe our God is shaking us, all of his children, trying to wake us and mold us in His image.

The government statistics for Honduras are: 1,000,000 displaced and homeless in a nation with


a population of 4.5 million. 70% of all crops destroyed. Over 6,000 people dead and over 9,000 missing.

All of this grief caused by a hurricane and 4 days of rain. When one hears the statistics it is overwhelming. Where does one begin to help this wounded nation? We ask ourselves, "What can we do?" OBITUARY

Kenneth L. Haines

March 29, 1920~March 15, 1999



Renneth L. Haines, age 78, passed away March 15 at the Tendercare Nursing Home in Clare. He was born March 29, 1920, to John C. and Maude S. Haines, who preceded him in death. He was the youngest of nine children, all of whom also preceded him in death.

Kenneth was graduated from Clare High School in 1938, and worked for Kroger and Dow Chemical prior to enlisting in the U.S. Army Air Corps in 1942. While in the Air Corps, he served during World War II as navigator aboard a B-17 in the European Theater of Operations. While on a bombing mission over Germany, their plane was shot down and they crash landed in Holland. After being picked up and interrogated by the Germans, he and his crew, while being transported by train, planned and executed a daring escape from their captors. After a short period of freedom, he was again picked up by the Germans and spent 18

months at Stalag Luff I, a German prison camp near Barth on the Baltic Sea. As a result of the heroism displayed in this escape, he and his crew were awarded the Silver Star for bravery in action almost 50 years later. He was proud to have served his country.

Following his return from active duty, he worked for the Department of Natural Resources for over 33 years, retiring from that department in March of 1980.

He was united in marriage to June Bergey on May 8, 1943, a union lasting 55 years. To this union was born one son, Bruce. He was baptized into the Church of Christ (Temple Lot) on October 2, 1994. He was a member of VFW Post 4159 and of the State Employee Retirees Association, as well as several military service organizations.

He leaves to mourn his loss his wife June, son Bruce, three

granddaughters -Lisa,Jill, and Hilary, four great grandchildren, many nieces and nephews, and a host of friends. He loved his family.

Services were held from the Stephenson-Wyman Funeral Home in Clare, with Elders Max Spencer and Aaron Heath, of the Church of Christ (Temple Lot) officiating. Interment was in the Cherry Grove Cemetery in Clare.
